19th Annual Ride for Roswell



The annual fundraising event is the largest in North America & raises millions of dollars for cancer research.

The 19th annual Ride For Roswell, North America's largest single-day cycling event, will take place June 27th & 28th, 2014.

The Ride For Roswell weekend begins with the Opening Ceremony on Friday, June 27th, with the Ride taking place on Saturday, June 28th at the

University at Buffalo's Amherst campus. More than 10,000 riders, volunteers and supporters are expected at the event. The Ride has raised nearly \$25 million for Roswell Park Cancer Institute over the past 18 years. Last year alone, more than 8,000 riders and 2,000 volunteers helped

raise \$4 million for cancer research and patient care programs at RPCI.

The Ride For Roswell Opening Ceremony is an inspirational rally against cancer that kicks off Ride Weekend. The program will feature a procession of RPCI researchers, doc-

The program won the "Bronze Commitment to Education" award from the Buffalo Alliance for Education in 2007 and continues to be a valuable program for participating students.

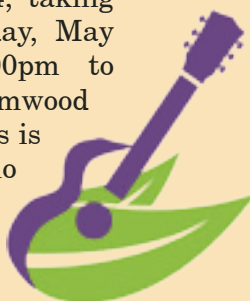

The Adventures of...

Rocket Man

“Body Awareness”

Jewish Repertory Theater will produce the Neil Simon classic “Odd Couple” next season, but somebody stumbling in on the current show could be excused for thinking it’s already here.

It has two women sharing a bedspread, a young man with a serious compulsive disorder and a traveling figure photographer, a documenter of the undraped, the most sensible and down to earth of the lot. Next to this mixed foursome, Oscar and Felix seem downright tame.

It’s poignant, sad and funny, too, some of the humor perhaps unintended by Pulitzer-winning Annie Baker. Rocket Man, a card-carrying Luddite, sensed a tremendous sendup of academia and its sensitivities. Professor Phyllis reminds schoolteacher Joyce that since Joyce works in a secondary school, she’s not really a part of academia. Really, now.

So, as “Awareness” dawns each day, Phyllis further unravels, having started out so sensitively inhibited

that she couldn’t even bring herself to call “Body Awareness Week” what it actually is. The play is so involved in 20-20 navel-gazing it’s gone cross-eyed.

The men in “Body Awareness” are Jared, Joyce’s son who is afflicted with a form of autism, and cool Frank, the exposure man, whose works are scattered around the campus bringing awareness to bodies of all ages. This reality bites at the otherwise laissez-faire Phyllis, – this, and the affection roommate Joyce seems to be developing for the guy, so to speak. To take Grandpa’s line from “You Can’t Take It with You,” she may strip next.

Adam Yellen is terrifyingly terrific as Jared, who declares, “I’m not angry, I’m surrounded by imbeciles,” then not only defines the word, but traces its history. He gathers words as loot, smartest person in a roomful of high IQ’s, with absolutely no bent for sociability.

Coolly, clinically, photog Frank outlines for him

the steps to seduction. The lad – he’s about 20 – digs the words but not the music and bad things happen, driving him into the arms of his mom. Tim Newell plays Frank with breathtaking clarity. This is the same actor who has realized revered comedian Jack Benny with such authenticity here and elsewhere. This portrayal redefines his range. Even Mr. Benny would exhale, “Well!!”

Eileen Dugan carries Professor Phyllis from confidence through consternation to near collapse, “Body Awareness” most emotional mobility. Kristen Tripp Kelly effectively connects, disconnects, then reconnects with each other character, and the closing family portrait had ‘em guessing in the preview audience. Rocket Man thinks he had it all figured out. It is an odd play of uncommon themes and may perplex perpetual patrons.

Also surprising, in a nourishing way, are the offerings at Myers Tel Aviv Café, (this night including a spectacular butterbean salad and bang-on salmon), just across the lobby from the Seller Theater at the Jewish Community Center, 2640 North Forest Rd., Getzville. SEVEN ROCKETS (out of 10.)

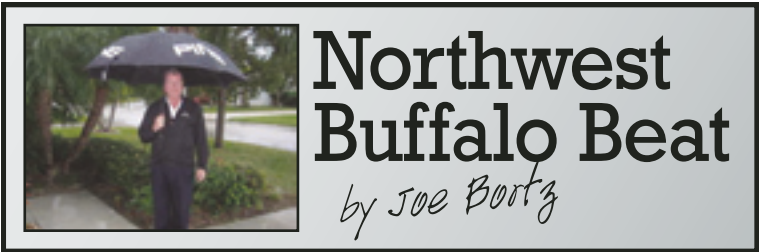

Shoe Shine Anyone?

Came upon a really old item that really brought me back into time. So long ago and so many things have changed in the world since then I guess it would be called an extinct trade.

You see these children today as young as five years old with smart phones, Ipads, and all sorts of electronic games and devices. Guess that is good and wonderful that we are able to communicate so easily. In line with that we also see this generation growing to be smarter, becoming researchers and people who contribute to the well being of society. There have been so many changes in my life-



time it is mind boggling. Imagine growing up without any of these things we have come so accustomed to. Living in a world without cell phones, television, computers or even the ability to own a vehicle for transportation. You wanted to go somewhere

you walked or took the bus. I lived through that and it was not that bad.

The item I uncovered was this old shoe shining box pictured. The price is painted on the side. It was handed down to me from my older brothers who all at one time or another, used it to supplement our meager income. In those days

there were no allowances. You wanted money you went out and earned it. And it was not easy as there was very little to be had.

I had four brothers and three sisters which today is a big family but back then it was somewhat common. My dad was able to keep his job at Birge Wallpaper during the depression. So we did not stand in any bread lines or go on welfare. My dad was proud that he was able to accomplish that. In spite of that we really did not have any extra finances to spread to the eight siblings. My brothers all had paper routes and did shoe shines for extra cash. I followed as soon as I was old enough.

The world was not as dangerous as it is now so going off on my own at 10 to make some extra cash was not only allowed but welcomed. The shoe shine box was now mine to own and my first financial endeavor. On weekends I would walk from my house on Fargo and Massachusetts to Grant and Breckenridge. The spot to be was waiting for people going in and out of the A&P.

That is a super market and not a public facility.

I could go out on a good day and make as much as fifty cents. Back then it would buy you a hamburger, fries and a drink and you would get change for that amount of cash. But usually I brought most home to the household and maybe kept a dime. Business was not always good as the war was going on and there were not a lot of men around. Those that were did not have extra cash for the luxury of a shoe shine as we were coming out of the depression. But there were still some and I made enough to make it worth while. On slow days for shoe shining I would bring my wagon and help people bring their groceries home. Remember most did not have cars and would have to lug these heavy bags for blocks. I was a welcomed sight to some and I charged a nickel. Once in a while I would get as much as a dime. Same as a shoe shine. I would also double up and put my shoe shine box in my wagon and offer both services.

When I was old enough I got a regular Courier Express route. Buffalo News routes were hard to come by as they delivered in the evening which was preferred. We Courier paperboys had to deliver at five in the morning. This is how I learned how tight money was. Collecting was a nightmare as people sometimes could not pay. Some weeks I actually lost money as the paperboy was the last on the list. This was also my first experience with nasty people, much to my dismay.

Yes this old shoe shine box brought back all those good memories. People seemed to be a lot more friendly and caring. I know a lot of them did not have any money but still tried to help out a young handsome boy in hand me down clothes. Such nice people and it was always a pleasure to be out among them. I enjoyed that part of my life and I did it without a calculator or Ipad.
