## The Little Engine That Couldn't

Five years ago Rocket Man and Co-Pilot Bill Seifert got the thrill of their orbital lives along a shady railroad track just north of Harrisburg, PA. Through the tunnel of trees an approaching light appeared and in an instant born of mentally-stored transportation grids, Rocket Man identified the incoming as the Strates Shows carnival train.

The Co-Pilot fired up his video device and breathlessly recorded its passage, 60 flatcars flush with disassembled rides, false fronts and ticket booths, pounding southward toward the York Fair at 50 mph. "Now I see," said the Co-Pilot when he could finally exhale, "Why you train guys get all excited." Co-Pilot Bill had too little time to savor this, soon called to a Higher Orbit. And now Strates has said that this would be the final trek to Hamburg. Their equipment no longer passes inspection.

Oil trains spew havoc all along the North Coast, and idling trains soak suburban Depew with the stench of garbage, but somebody finds a way to put the brakes on the circus train.

How many people were ever wounded by flying funhouses? As they shout at the circus when things go wrong, Hey Rube!

And another railroad era ends this week. The Western New York Railway Historical Society's display of a caboose and a box car has been ordered off the Fairgrounds.

While the obscurely-parked WNYRHS caboose didn't make a list of 175 favorite things to do at the Fair (mostly eating, usually to excess), people loved it. One of Rocket Man's favorite summer gigs involved guiding youngsters through the old-style bobber, which dated from 1947.

In four hours he'd usually get like 250 folks (counted enthusiastically,

if not accurately) and help parents help youngsters into the elevated seats and imagine they were trailing a string of 100 freight cars rattling along at 50 per, checking their status along with the condition of trains moving in the opposite direction. Most would step down with eyes aglow, having conjured up a moment much like that which so transfixed Co-Pilot Bill.

Crew-carrying cabooses iconned a time before the railroads, with the collusion of their unions, decided that 100 carriages each putting a dime's worth of friction on a steel rail did not need caretakers. How's that workin' out for us?

The WNYRHS did not become the force it is by publically railing (no pun intended) at larger entities, and will go quietly, but it has to be steaming (sorry) at a snub fairly typical for this Fair, which tends to look down its nose at smaller, modest, local exhibitors.

The caboose is open 11-7 and Rocket Man's on duty Aug. 15. All aboard!

THE BEAT GOES ON: Tomorrow, Aug. 8, Rocket Man and his First Mate will have been wed 55 years, much of it spent in railroad cars.

## Buffalo Bills to Toronto

There is a lot of discussion about the sale of the Buffalo Bills football franchise and where the team will end up. As of this writing the answer has not been determined, so I am allowed to add my two cents and the little I know about the whole deal. I will preface my remarks by reminding those who read this column that I was a Bills season ticket holder for fifty years. From the very first game in 1960 until I had enough in 2010. Met Ralph Wilson in person, watched every game, and was what one would call, a true blue Bills fan. No, I would not like to see the franchise move to Toronto even though I am disenchanted with the less than mediocre performance on the field of late.

So last Sunday a fellow from the Toronto area was in my shop to pick up an item he had bought on EBay. After a lot of chit chat and this and that we got onto his views on the subject.

His first question to me was had I ever attended a sports event in Toronto? Thinking about it, the only thing I attended was a Blue Jay, Yankee baseball game. He asked "Did you notice that the fans in Canada sit on their hands?" Now what is that supposed to mean?

He is from the Toronto area and is neither a Maple Leaf fan, nor a baseball Blue Jay fan. His teams of choice, believe it or not, are the Boston Bruins and the Red Sox. Does he have a connection in Boston, like his wife is from there, or what? No, he just likes the reaction of the fans to the games. He feels, and this is his not mine, that Toronto fans are too passive. Yes they do attend and they do cheer, but the enthusiasm is just not there like it is with American fans. He said, and again this is his views, that they cannot even sell tickets to the game when the Bills play up

I thought it was a bad move but what do I know. Anyway, in the parking lot before the game, there was tailgating and you had no problem identifying the noisy, hollering Bills fans. To say the San Diego fans are passive is an understatement. Their tailgating was totally different, with table and table cloths, silverware and even napkins. Bills fans use their sleeves. Now having been to away games in New York, Boston and Pittsburg, it was natural to expect a more enthusiastic rowdy crowd. You hide the fact you are pulling for the visiting team. That is the way it is in most NFL cities and what one would expect. I did not find that in San Diego as the fans were really laid back, and even to the point of who cares about the game. Who sees me here? We even had the fans sitting next to us, season ticket holders, pulling

for the Bills.

So I can relate to his saying the Toronto fans "sit on their hands". Like San Diego it is a wealthy, cultured town. How many of us have traveled the Queen E to see a show in Toronto, or see the attractions of which there are many? Love the city and what it has to offer as far as entertainment. But as this fellow put it, sports are a part of it but come in last. Like in San Diego, they attend a sports event, if there is nothing better to do. In both cities, there are so many more ways to spend your time.

So before Mr. Bon Jovi and his partners invest a billion dollars, they better look at the whole picture. Buffalo Bills unfreeze fans, and Toronto whatever fans. The only time Bills fans "sit on their hands" is to thaw them out and keep them warm. Been there and done that.

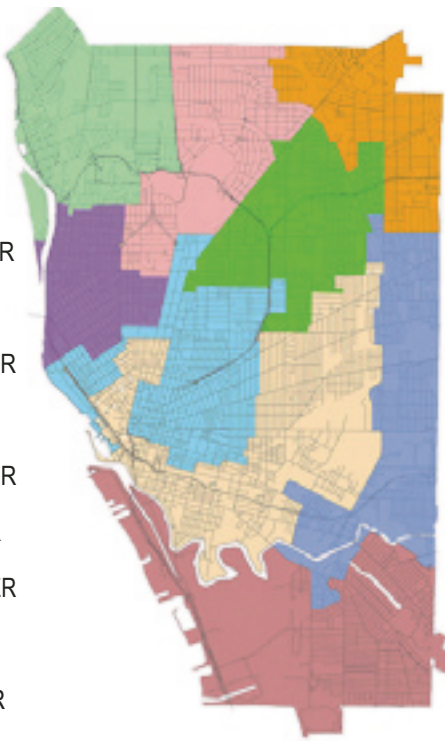
