"You Are Beautiful"

Over the Labor Day holiday weekend, billboards began to appear across Erie County bearing a simple message to residents: "You Are Beautiful." The work is part of

the Public Art Initiative, a collaboration between the Albright-Knox, Erie County, and the City of Buffalo that seeks to enrich the lives of area residents by placing significant works

of art in public locations throughout the region.

The art is the work of Chicago-based artist and designer Matthew Hoffman. The Erie County presentation of the work is the most immersive presentation that the artist has created to date. Hoffman began the project as a graffiti-style self-affirmation scrawled on the rusting trusses of an underpass in the Rogers Park neighborhood of Chicago. Following significant praise for this tiny gesture, Hoffman began

The Adventures of...

Rocket Man

“Over the Tavern”

Even with the flame of Catholic education flickering, “Over the Tavern” burns bright. Against the considerable competition of a significant Bills game, the Kavinoky Theater was packed Sunday afternoon for the 20th anniversary revival of Tom Dudzick’s parochial-school reminiscence.

And at the end they rose as a 12th man (actually, most were women) to hail this winning team of actors and designers, including the playwright, who directed. The following morning, amid acres of football coverage, a Buffalo News story lamented the closing of 10 Catholic elementary schools. Lot of people out there of many faiths who’d willingly accept a ruler rap to keep ‘em open.

The story concerns Rudy Pazinski, 12 or so, and his challenge to religious rote. Convinced that we were

placed on earth “to have fun,” he can’t remember his catechism but he has Ed Sullivan down cold. In a late, late scene, his tormentor Sister Clarissa reluctantly concedes how much he reminds her of similarly-aged rebel from 20 centuries ago.

Rocket Man saw “Over the Tavern” the day it was born, and a dozen times since, and has never seen a holier Sister Clarissa than that portrayed here by Ellen Horst. When she whacks Rudy—today, some busybody would have her arrested – it truly hurts her as much as him.

This splendid ensemble cast tunes to her fork. As Rudy, home-schooled Samuel Fesmire looks so cherubic as to almost demand a halo, and delivers his lines with an easy, innocent pace, especially his down-to-earth, let’s-make-a-deal address to one of the Holy Trinity.

He’s a fine facial match to special-needs brother Georgie, played eagerly and attentively by the well-pedigreed Jackson Mysliwy. Connor Graham

is a package of wise-guy fury as mid-teen Eddie, especially in his “moving-out” smackdown to his Dad. Caroline Schletter presents a muddle of ungainly, anguished adolescence as sister Annie, a remarkably generous bit of stagecraft. You could have heard a beer foam over in the silence that attended her touching, coming-of-age speech with Brigitt Markusfeld as her sympathetic, slip-showing Mom.

St. Joe’s teacher Steve Jakiel crafts a justifiably angry barman Chet who sees everyone’s faults but his own.

There’s some enormously funny stuff here, especially when Georgie mimes some new words into his vocabulary, but a couple of Dudzick’s finest exchanges fell victim to hasty or lateral delivery. Sets and props are extraordinary, especially what passed for pulp fiction in those days.

While blasphemy charges abound in the script, the devout will “get it” far more than the doubters. Those were tough times, but to coin a phrase oft said Sunday, where would you rather have been, right then. “Tavern” serves through October 5th. NINE ROCKETS (out of 10).

NFL Violence

The big topic this week, besides the Bills winning two games, is the suspension of players for domestic violence off the field. A couple of star running backs have been told they were not allowed to play in the NFL for events that happened some time ago. The first fellow punched his then fiancée out cold in an elevator. The other was suspended for child abuse, as he allegedly whipped his kid with a tree branch.

First the punch that set this whole thing off. I have seen as many of us have, domestic violence and wife beating. Years ago my sister-in-law used to come to our house after taking a beating from her husband. There is nothing more infuriating to me than seeing a woman after a brutal beating by her spouse. Your first reaction is to retaliate and give him a taste of his own medicine. A calmer mind tells you to not interfere and just offer a place for her to stay. Which she did, but just for the one night. Only to return to that same violent scene the next day. No further argument, her choice was to return and work it out. In this case it ended well and the violence stopped. He quit drinking and she actually beat him in an altercation. They had two children and lived happily ever after, until he passed away.

In no way do I condone any man hitting a woman for any reason. My wife, whose sister is the one I mentioned, thought that the player being thrown out of the league was not enough. What he did was disgusting, he should go to jail. I asked if she really thinks that other NFL players do not do the same thing. Or other men in different professions? Prob-

bly, but that does not make it right and this case just proves that it does happen. She feels that no one should hit another, man or woman. Yet, watching a movie or TV show she sits and cheers when the bad guy is getting his just due. If every wife beater lost their job, I think there would be a lot of un-employment. To finish on this case, the woman did end up marrying the fellow who knocked her out and stands by him. Figure that one out.

The other case is child abuse which until I heard there was a scar, it kind of made me wonder. I had eight children, three girls and five boys. I probably would have gone to jail or had them taken away as I admit I did spank them. Not the girls ever, but the boys sometimes got out of hand. I was elected disciplinarian, not by choice but by being the only one that would do it. My wife was too laid back and passive so the chore was on my shoulders. Her threat would be if they gave her trouble was, "wait 'til your father comes home". That made them really happy to see me. Right! So I had to hand out punishment depending on the offense. Most time a slap on the rear was sufficient. But there were times that it was more serious, like stealing, causing injury to another or disrespect to their mother. There would be a bit more than one slap on the rear. No sticks, no clubs, (sometimes my wife would use a short fat plastic baseball bat but they would laugh at that. Sometimes her slipper.) No fist, just an open hand. No scars or injury except a short lived certain red area.

None of them ever threw a tantrum like I often see now, not one would


ever consider hitting their mother or any adult, like I see now. I would take all eight to any restaurant and knew they would behave and never cause scenes, like I see now. I was proud of all of them and as children they would treat all adults with respect, you see less and less of that now. Eight is a lot of children in a family. They have all turned out real well. There has to be a certain amount of discipline in a large family to avoid complete chaos. Rules, duties, and the love for each other, there was and still is plenty of that. Step out of line and you knew dad's big hand was going to come in contact with where you sit. Hope they do not come and handcuff me. Cannot fire me as I am self-employed and semi-retired. Guess I got away with being a bad guy. Remember, respect is a key word, in family, relationships and life.

to develop stickers bearing the phrase that have now been circulated across the globe, as well as massive installations in all manner of media. (Stickers will be distributed in Erie County, too, connecting our community to this global phenomenon.)

“I found that I couldn’t make this statement

true with any other word than “beautiful,” he said. Though the artist pursues other projects that align with his enthusiasm for creating moments that support positive place-making while advocating for public compassion, You Are Beautiful has become a lifelong commitment.

The next project in the Public Art Initiative

will take place in October, when as many as 200 County residents will participate in the creation of an arena painting with nationally known, Buffalo-born artist Charles Clough. ey management skills that many young adults develop on their own.
“In collaboration with the Buffalo Metropolitan Federal Credit Union, our students will have an opportunity to experience a plethora of financial literacy components,” said Carlos R. Alvarez Jr., Principal at The International Preparatory School at Grover.
Alvarez continues, “This school year, we have the great fortune of operating a satellite branch in which our students will also have an opportunity to perform duties of a teller. Our entire school community will have the opportunity to become members of the Buffalo Metropolitan Federal Credit Union and conduct their transactions right in the school itself.”
The students selected to intern as tellers at the student-run credit union branch had to complete a résumé, interview process, and receive training during their summer at the main branch of Buffalo Metropolitan Federal Credit Union.
