## Allentown Literary Ghost Walks

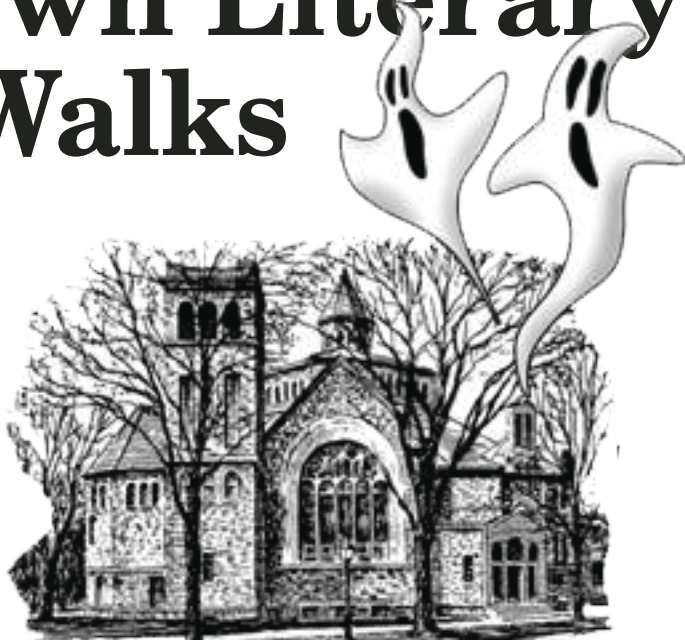

## Rocket Man

## "The Philanderer"

Ten performances remain for "The Philanderer" at the Shaw Festival. That is, if the actors don't first collapse from post-coital exhaustion. Countering the image of playwright George Bernard Shaw as stuffily philosophical, director Lisa Peterson stages a slapstick-and-tickle production best described as Benny Hill with compound sentences.

"Philanderer" doesn't just fool around. Director Peterson unearths the original third act which Shaw, under the urging of an associate, discarded as too controversial for Victorian times. It takes a strong stand for granting women equal rights in divorce, both in the law and in public opinion.

Gord Rand, definitive cad from "Juno & Paycock" just down the street, plays the title role here, an "ad-

vanced" thinker who holds that "when one is young, one marries out of curiosity." The curtain rises to the gasps and moans of he and the willing widow played by Marla McLean. In bursts Moya O'Connell as his supposed betrothed, sparking a full fury of gymnastic punches, rolls and clinches that must have had fight co-ordinator John Stead on overtime.

According to a mischievous essay in the playbill, real life inspired this row. Rand's philanderer doesn't so much love-'em and leave-'em as convince 'em that infidelity enhances their reputation, redefining the pursuit of happiness. With a doctor distraught that his patient might survive, a breathtakingly-set "Ibsen Club" with functional firepit, plus a page on rollerskates, it's 2 ½ hours of

wit-matching with libidos on hyperdrive.

Usual Shawspects Michael Ball and Ric Reid bring heft as the fathers of the ladies in question, and for a different twist there's Shaw sophomore Harveen Sandhu as O'Connell's too-cool sister, a vision in jockeyish silks.

Rocket Man knows all the Ibsen he ever wants to know, but it was enough to appreciate the inside-baseball absurdities of its polished and embroidered green and silver set and a membership code banning manly men and womanly women.

O'Connell and Rand's battles royal invoke the rowdiest of "Private Lives," and while Rand and McLean claim lofty ideals, they don't seem much interested in each other's minds as their garments go airborne, fluttering to the stage in a dead heat with the final curtain, just in the nick of time.

If only they can hang on 'til Oct. 12th's closing matinee. EIGHT ROCKETS (out of 10).

**Kevin O'Connell** is the chief weather anchor for WGRZ-TV. O'Connell also sub-hosted on *The David Letterman Show* on NBC, hosted the game show *Go* on NBC from October 1983 to January 1984, and presented the syndicated disco series *Disco Step-by-Step* from 1977 to 1980. He was often a substitute weathercaster for *Weekend Today* during the 1980s. O'Connell was previously a news and weather anchor for Buffalo's WIVB, as well as Los Angeles' KNBC and KCBS-TV during the 1980s before returning to Buffalo in 1990. He was also a disc jockey early in his career, before moving into work in weather.

# Japanese Drum Group to Perform in Buffalo

The Japan Culture Center of Western New York, Inc., in partnership with the Buffalo State Music Department, will host a once in a lifetime event this October at the SUNY Buffalo State Performing Arts Center. World-renowned Taiko (Japanese Drum) drummer, Eitetsu Hayashi, will perform one night only, on Saturday, October 25th at 7:30 pm.

Hayashi, an acclaimed Japanese musician specializing in Taiko, has many works that are well known throughout Japan. He is described by most as a Taiko legend, and was one of the first to bring this music style to the West in 1984 at Carnegie Hall. Hayashi has traveled through most of

America playing with various musicians, but this is his first visit to Buffalo.

To the Japanese, Taiko is the sound of the spirit of nature. It's different from other drums of the world, and most likely is different from anything you have ever heard.

Performing on stage with Hayashi is Joseph Small, a Western New York connection. Small, a current graduate student at UCLA majoring in ethnomusicology and dance, has traveled all over the world as an apprentice to Hayashi and as part of his ensemble.

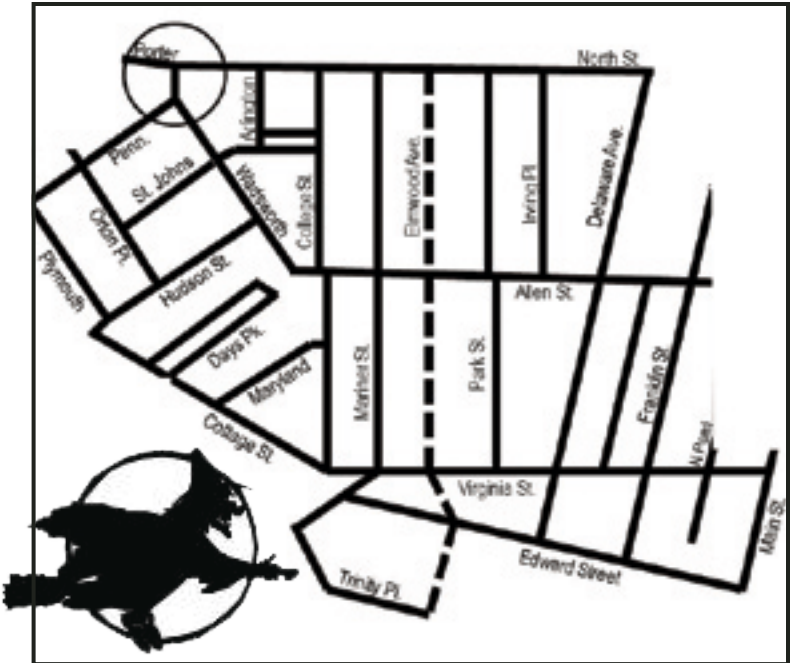




