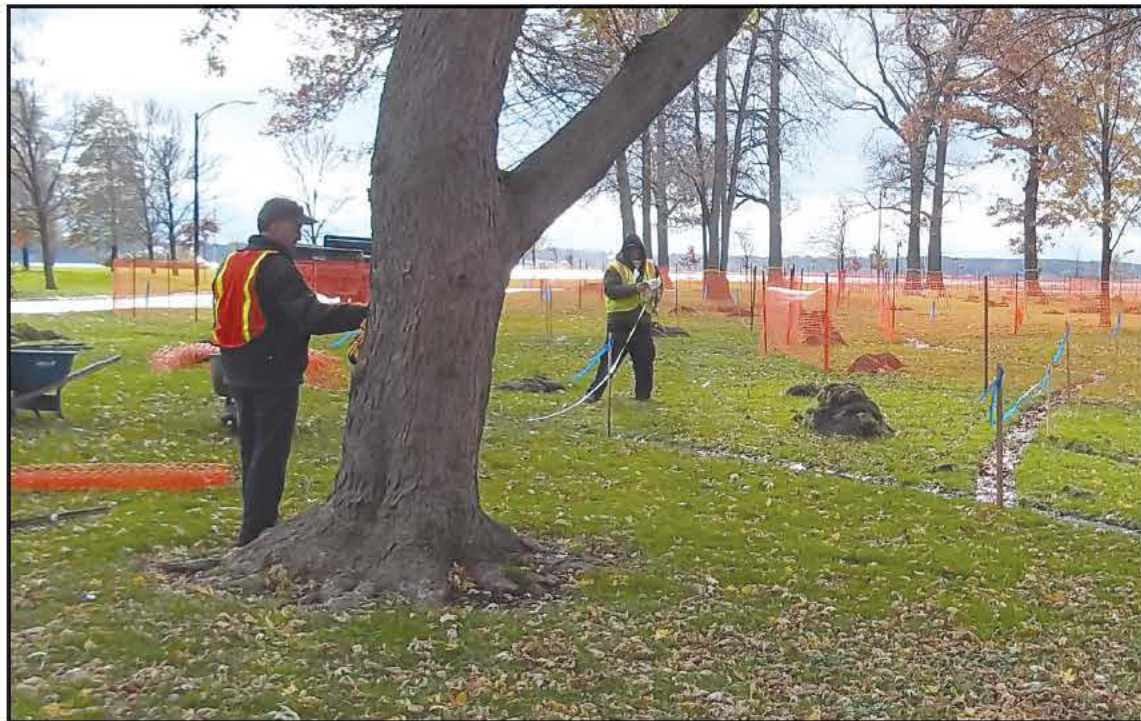




## Olmsted Returns to Riverside Park

Riverside Park was designed in 1898 by the famed Olmsted firm of landscape architects, the last major park they designed and built in Buffalo. The plan called for a formal concourse that connected the park to the waterfront via a pedestrian bridge that went over the Erie Canal. The entire northern end of the park along Vulcan Street was laid out with a water feature, paths and gar-

dens called the "Minnow Pools."

The Buffalo Olmsted Parks Conservancy will be restoring this long-lost garden now called RiverRock Gardens this fall and next spring. Once complete, RiverRock Gardens will boast 13,000sf of new pathways, over 1,100 shrubs, 1,000 perennials, a new stone bridge over the garden and 12 benches at key locations around the garden.

The project will reinterpret the historic "minnow pools" designed by the Olmsted brothers. The plant material to be installed will follow the historic plant plan from 1898. The new installation will meander through the existing mature trees on site and the project promises to be a key example of bringing back a lost Olmsted feature to the current park system utilizing his-

## City Begins Bagged Leaves Pick-Up

The City of Buffalo will begin collecting bagged leaves starting the week of November 11th and ending November 22nd. Residents should put their bagged leaves at the curb on the same day that their garbage is scheduled for pickup.

To participate in this collection, city residents are asked to place their leaves in clear plastic bags or brown kraft recyclable bags. These bags are available at local hardware stores, home centers, and other retailers. There is no limit to the number of paper leaf bags residents may place at the curb for pickup. Sticks and branches should be tied in bun-

dles with 'twine' or 'rope' and be no longer than 4 feet in length. Do not rake leaves

into the street; leaves should not be placed in garbage totes.

Also, residents should be advised that raking leaves into city streets is illegal and punishable by fine.

Residents are being asked to place their yard waste on the curb before their scheduled garbage/recycling pickup. Yard waste

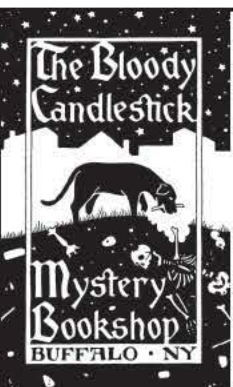

## Rocket Man

## 'To Kill a Mockingbird'

Feel the irony. As the Studio Arena opens again, the last play it staged opens elsewhere. It was five springs ago that the Studio finally succumbed to years of inefficient management, immediately following a superb production of "To Kill a Mockingbird."

This weekend it struggles to fly again as Road Less Traveled Theater, the wind beneath the wings of that "Mockingbird," re-opens the Studio doors with a lower-profile staging of the tense racial drama "Clybourne Park."

But you can't keep a good "Mockingbird" down. It takes flight Friday night in Kenmore's Advent Church, 54 Delaware Road, just north of Kenmore Village Hall.

Rocket Man has had a uniquely close-up view of rehearsals, from the vantage point of Judge Taylor, with little to say but a lot to consider as "Mockingbird's" pivotal trial plays out.

From a nostalgic 1960 novel with which Harper Lee won a Pulitzer Prize,

the staged "Mockingbird" does its level best (three levels, actually, on co-directors Randy Rumley and Christine Coniglio's inventive and functional set right in the church sanctuary) to present the characters of her girlhood in 1935 Alabama.

The charm is in seeing them developed by actors and actresses of all ages. Key is the girl Scout, a tomboy (remember that word?) around 10, wise, befuddled, frustrated, all at once, a child of fairness suddenly brought to realize that often the world's isn't. McKayla Brown plays her, brilliantly.

Bob Lonski plays the lawyer Atticus Finch, a role that brought Gregory Peck an Academy Award. Lonski, an attorney himself although seldom at trial, fervently tries an impossible case in the 1935 Deep South, a he-said, she-said in which he is black and she is white. "Nevuh seen a Negro win a case like this," one observer prophesies.

Mike Leszczynski breathes fire into the fa-

ther of the accused, one Robert E. Lee Ewell, bigot and proud of it. ("They devaluin' my property," he snarls at the judge.) Then there's Terri Jo Ritz as the neighborhood busybody, joyously demonstrating why a recent survey found "Alabama" to be the most pleasant accent in America.

Ron Mangum, this "Birds" lone professional actor, plays the frightened accused, Tom Robinson. Rocket Man is thrilled to share a stage with this consummate performer for the second time, following "Of Mice & Men" a year back.

And another colleague, Tom Malzan, brings the blessing of sincerity to the simple, fervent sheriff. "I ain't much," he tells attorney Finch. Wrong. The good man Malzan creates might well have won last week's election.

Lines slip by from time to time and sounds echo in the sanctuary, but Rocket Man is sure that feisty old Harper Lee, still alive and suing a museum in her home town, would love the fervor of this troupe which does her work such honor. Performances begin at 7:30 p.m. the next two Fridays and Saturdays and 2 p.m. the next two Sunday, at \$10 a ticket or less.

All objections overruled.

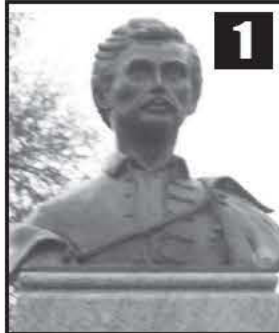

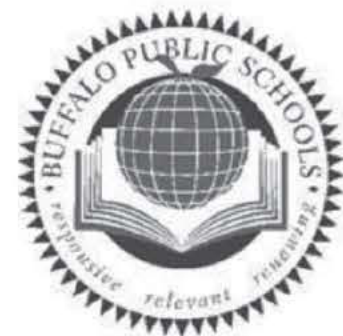

**Continued from page 1** toric layout and planting plans. These plans are carefully stored at the Conservancy's Olmsted Archive along with over 250,000 other items related to the history of the parks.

Once completed, this garden is expected to provide residents with a peaceful place to stroll, enjoy nature, flowers, and views of the Niagara River. It should also prove a draw for cultural tourists interested in seeing an authentically restored Olmsted landscape, part of the Olmsted legacy we enjoy throughout Buffalo.

This project was funded through various grants from the State of New York and the Niagara River Greenway Standing Committee of Buffalo and Erie County. Officials will be gathering on November

19th at 10:30 am to celebrate the groundbreaking on this significant investment for Riverside Park and the surrounding community. The public is invited to attend.

The Buffalo Olmsted Parks Conservancy has been charged with the ongoing maintenance and restoration of the park since 2004 in partnership with the City of Buffalo and the Community, raising 64% of the funds needed to care for the parks and parkways each year from donations and contributions from members of the community. The Conservancy expects to raise an endowment for the new RiverRock Gardens and asks anyone interested in making a significant contribution toward this fund to consider contacting the Conservancy at 716-838-1249 x 14 to discuss.

**Continued from page 1** may be picked up on a different day than the garbage day. Although they are scheduled for pickup on the same day, leaves will be picked up separately from garbage, so city residents should not be concerned if they are left behind after garbage removal.

As an alternative to the curbside bagged leaves collection, which again runs from November 11th thru November 22nd, the city opened three drop-off locations where residents can bring their unwanted leaves and lawn debris.

The three sites are:

- Cazenovia Park - Golf course parking lot, off Wildwood Place
- Shoshone Park - parking lot, at foot of Beard Avenue
- 1120 Seneca Street - DPW Engineering Garage parking lot, between Babcock and Smith

Drop off hours at Cazenovia and Shoshone Park are from 8:00 a.m. - 4:00 p.m., Monday through Saturday until December First. Drop off hours at 1120 Seneca Street are from 8:00 a.m. - 3:00 p.m. Monday - Friday, year round.
