Rocket Man

‘Miracle on South Division’

Playwright Tom Dudzick’s “Tavern” trilogy concludes with the line, “I think I’ve found my voice!” While it doesn’t compare to “I have always trusted in the kindness of strangers,” it rang like a Mass bell in Rocket Man’s ear as “Miracle on South Division Street” wrapped at the Kavinoky Theater Thursday.

“South Division” suggests that in eight previous plays, some breath-takingly successful, the Samuel Pepys of the Old East Side was merely clearing his throat. When laughter succumbed to exhaustion and ribs returned to their original upright position, there remained as fine a life’s lesson as Tom ever learned during his distinctively parochial education.

It’s one act, about 90 minutes. The last 40 seem to fly by. The miracle of “South Division” is that while plowing old ground, it unearths the gem of commonality.

Like much Dudzickology, it takes inspiration

from real life, a privately-maintained shrine in the playwright’s old neighborhood. He’s moved it a few blocks - the pen is mightier than the forklift, too - and surrounded it with four Nowaks, kindred spirits to the Gorskis and Pazinskis of yore.

Jimmy has worked overtime on a garbage truck to earn the price of an engagement ring and has developed a taste for gefilte fish.

Ruth has theatrical ambitions but failed her audition for the Bodypart Monologues. This is one of a laundry list of unconventional upsetting Mom Clara, whose theology can be summed up in “It’s not supposed to make sense, it’s religion!”

And daughter Beverly dares to bowl with her boyfriend on Christmas Eve.

They have gathered for a meeting on the state of the statue, a holy shrine which their late father commissioned and placed more than 40 years ago. To this point, “South Divi-

sion’s” script has sounded all too familiar and Rocket Man’s First Mate, who had endured an exhausting day after a sleepless night, actually nodded off.

Then, Dudzick weaves a new yarn (of whole cloth, he says). Cue the hysterics. But the comedy (not jokes, comedy) evolves from the shared realization of the folly of all our differences, notably, but not exclusively, of faith.

Ellen Horst is staunchly lovable as the Everymom, her accent tinged, Rocket Man swore, with a hint of another ethnicity. Such a prophecy. Ben Puglisi is the good son, fixer of lost appliances, steadfast in all devotions. Bonnie Jean Taylor is a true charmer as the frustrated thespian. Charmagne Chi bounds in as the untimely kegler. Dudzick himself directed with crafty hints as to plot development. David King designed the eye-catching, comfortable set.

“Reckkio’s Bowling” got a laugh, but “South Division” far outruns the boulevard of local recognition. It holds that we are defined not by what we believe, but that we believe in each other. A voice, indeed. NINE ROCKETS (out of 10), through Dec. 8.

The Morning Shower

The other morning I got up and as usual went into the bathroom and turned on the shower. Same as I have done as long as I can remember. Nice walk-in shower that you open the door and turn the valve on and adjust it to just the right temperature. Soon as it feels right you just walk in and move the head up or down for the right spray. Really do this without thinking about how convenient this is and how simple. No waiting, no stepping over or crawling into, just open the door and go in.

Then it hit me as I was letting the spray hit my face after washing my hair. It was not always like this. My thoughts slipped back to my childhood and the body hygiene we endured in those days. Let me begin by stating that there were no showers where I came from. We took baths in a bathtub once a week. Saturday night was bath night as we needed to be clean for church the following morning. Since there were eight children it was not uncommon for us to use the same bath water as that used by the previous occupant of the tub. The preface to taking a bath was getting hot water. Picture this if you would a galvanized tank usually in the kitchen. These were located in the kitchen as you would need a little hot water to wash dishes every night. This meant lighting the gas heater located under this steel tank. Usually with a match and hope it did not singe your eyebrows. After it was lit you had to physically feel the outside of the tank to see how much hot water was in there. The hot water

was on top so you measured the amount of heated water by running your hand down the side of the tank. If you just need to do dishes it was maybe a foot from the top. To take a bath, usually half way down the tank. And since we would all bathe on Saturday night we would leave it on till all were done.

Imagine if you would how dangerous this was. A gas heater that was not vented located in the kitchen. If you forgot to turn it off there is the danger of it exploding. You would read about that happening. No safety valves or relief valves. Just this steel tank sitting exposed for all to see. The gas burner on the bottom was necessary but you had to make sure the little ones did

not stick a finger into the open flames. None of that would be possible or allowed today and that is a good thing. Back then who knew any better, it was just the way it was.

Then to have to step into a bathtub filled with someone's dirty, murky, bath water. No problem, we just did it and thought nothing of it. Just skim off the soap scum off the top and hope the water is still at least warm as it usually is not hot. Yes that was a little bit of what it was like back then. Still it made no difference we did what we had to do as we did not know any better.

Just that now with the way things are it is so

much easier and better. People are living longer now and staying healthier till later in life. We have to think that some of that can be attributed to the cleaner, better way of life we live. Turn the valve and instant hot water in a walk-in shower. Continuous hot water till you are done cleansing every part

of your body. I was happy with that little recollection that went through my mind that day of what it used to be like. As I dried myself with my large bath towel, I added one more thing to my list of thanks. Kudos to all the plumbers who have made this possible.. I am much cleaner thanks to you.
