

Wingfest Heats Up Labor Day Weekend



It's more than just wings! Pageants, music, entertainment, and competitive wing eating contests are just some of the activities that draw thousands from all over the world to Coca-Cola Field every year for the National Buffalo Wing Festival.

The National Buffalo Wing Festival, one of the country's most beloved food festivals, returns to Coca-Cola Field in Buffalo on September 5th and 6th. Now in its 14th year, the festival, which attracted 70,000+ attendees from all 50 states and 34 different countries last year, will feature more than 30 local, regional, national and in-

ternational eateries serving more than 120 styles of chicken wings. In addition to the food frenzy, festival goers can enjoy a weekend packed with activities ranging from competitive wing eating contests, amateur cook-offs, pageants, music, children's entertainment and even the ever-popular "Bobbing for Wings" competition.

Admission is \$5. Children eight years and younger are free. The festival benefits Alzheimer's Association Western New York Chapter, Food Bank of WNY and Meals on Wheels for Western New York Inc. The festival has raised more than \$295,000 since its inception in 2002.

Rocket Man and First Mate can still barely watch it. The night it aired, anchorwoman Carol Jasen ran rivulets through a whole acre of mascara, she was laughing so hard. This wasn't happy talk, this was hys-

teria, and it was all Steve Beauchamp's fault.

A medical device helped keep Steve going. He wielded it so well that the manufacturer hired him to sell them, which he did better than anyone in the history of the industry, taking over territory after territory, the Donald Trump of insulin pumps.

Then, after Steve had moved southwest, he developed a condition beyond its pay grade. The greatest medical minds in the land told him he had 90 days to live and he should start taking it easy.

Not bloody likely, as GB Shaw would intone. He packed up and somehow got himself back to his beloved Buffalo to be with family, whom he took almost everywhere, including Las Vegas. "If you mourn me," he told them, "I'm gonna be really (well, irritated, so to speak)." Friends gathered from far and wide to throw him what is referred to in the play "Tuesdays with Morrie" as a "living funeral."

That was in February, near the 90th day. Soon there was Steve on TV, leading some fund-raising parade or riding his motorcycle or generally speaking out in behalf of making life better. With Steve, wise oddsmen always played the "over" and the better part of a year had passed before he moved on last week. Both through his lens and in his insistence on living, he showed us all a better way.

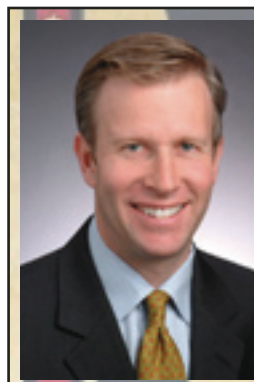
