

## 'You Never Can Tell'

Ah, now this was more like it. No ringtoned "Pygmalion," no four-hour diatribe on socialism and same-sex relationships. In fact, Rocket Man realized, he first reviewed "You Never Can Tell" as a Shaw Festival neophyte in 1973. The Queen was there. Took off her hat, too, which is more than he could say for the Maple Leafs fan who sat in front of him at the Royal George Theater last week.

While Buffalonians brace for Curtain-Ups , the Fest still has plenty of juice, besides the plentiful peaches (\$2.99 CDN for seven in Hendrik's Value Mart). Nearly two dozen performances, many at reduced rate, loom remain or "Tell," until Oct. 25 in the cozy Royal George Theater. Festival icon Jim Mezon directs, he who ground up his acting chops in the Festival's exhaustive "Intelligent... Guide." The two works could hardly be more varied. While playwright George Bernard Shaw classified "Tell" as "pleasant," Mezon goes positively giddy with absurd dental devices, extreme deliveries and beach balls bounding up from beneath.

Its implausible scenario has a dentist, earnestly played by Gray Powell, so impoverished (Aspen came much later) that if his landlord hadn't lost a battle with a Brazil nut, he'd be out on the street. What fortune, he is invited to lunch by aristocrats, but must demur due to their lamentable lack of a father, living or dead, a protocol of a 19th Century



English seaside resorts.

Eventually, Powell will hook up, emotionally at least, with the sparklingly rigid feminist Julia Course, under guidance of her mother, the toothsome, shall we say, Tara Rosling. This is Shaw at his most grittingly gregarious, but Mezon moves it at an incredible pace, the ensemble including the impeccably burred attorney Peter Krantz, the confidently taciturn gentlemen's gentleman Peter Millard and the deliriously delightful ditz Dolly, done to a turn by Jennifer Dzialowszynski.

"Jenny D," in her third Festival year, personifies perpetual motion as an oddly-matched twin bedeviling the dentist. "I'm not married, ANYone can see that!" Her eyes positively project, something in the style of the late comedian Marty Feldman. With a half-dozen lines she about stole "Pygmalion" and now, with a featured role. stardom awaits in the wings. Sympathies to platoons of future reviewers who will have to cope with her name, worth 39 points in Scrabble. As a comedienne, priceless.

Millard, meantime, manages order as the classic unflappable butler, putting all the silliness in the perspective of brevity. Between Jenny D and Peter, giving the title the lie, you can tell you're going to have a great time. NINE ROCKETS (out of 10).




