## Sabres Fall Apart During And After Homestand

Hopes were high for the recent seven game home stand. Five of the games seemed winnable and 10 or 11 points were needed to start to close the gap towards a playoff spot. Instead The returns were underwhelming with a 3-3-1 record for seven points. And teams behind them in the standings have passed them.

During the home stand leading scorer Jack Eichel had eight points on two goals and six assists. But he was a whopping minus seven continuing to show a less than necessary effort toward the defensive side of the game. Leading goal scorer Jeff Skinner scored five times and added three assist for eight points but was also a minus seven. For the month the Sabres are 3-7. Eichel is minus 11 with 10 points. Skinner in minus 12 and has scored nine points. Rasmus Ristolainen in minus 9 with 5 assists. Rasmus Dahlin is minus 8 with four points on 1-3-4 scoring.

Since the home stand the Sabres have been a disaster, losing 4-1 at New Jersey and again losing 4-1 at Florida. The Pan-

thers dominated in the third period with Alexander Barkov and Jonathan Huberdeau literally skating circles in the attacking zone around the Sabres listless defenders and scoring at will. The Sabres nursed a 1-0 lead into the final period and fell apart after the Panthers tied the score. Their psyche is so fragile that the team loses confidence when things go against them.

The 10 game win streak is a distant memory. Since then the Sabres have won

11 times in 34 games. That is pace of 65 points over the full season. In 2018-19 the Sabres had 62 points in a performance that was probably the worst season in franchise history. The 34 game record shows that in reality this team is no better than last year despite the addition of Jeff Skinner and number one overall pick Rasmus Dahlin.

The trade of Ryan O'Reilly created a major hole in the roster. Without that trade the team would have been much better. While Skinner has been an upgrade over the departed Evander Kane, the loss of O'Reilly opened up a huge hole on the second line where rookie Casey Mittlestadt has put forth a commendable effort but has been over matched against second line centers around the league. O'Reilly had 62 points and is a whopping plus 25 for a St. Louis team that has won 11 consecutive games.

From page one. ing demand for the 20- and 30-mile River Routes, Ride officials have added additional start times to expand capacity for these options. In past years, registrants choosing either of these routes had two start time options, but they can now opt to begin their ride at up to five different start times. Adjustments have also been made to the 2019 event so that more participants riding different distances can depart from the start line at the same time, making scheduling easier for families and team members looking to start together.

The Ride offers 10 different routes ranging from 3 to 100 miles, including two international Canada routes. The 2019 routes and start times include:

- River Routes (start at the University at Buffalo's North Campus)
- 3-mile Family Route: 10:30 & 11:30 a.m.
- 10-mile: 9:30 & 11 a.m.
- 20-mile: 7, 8, 9, 10 & 11 a.m.
- 30-mile: 7, 8, 9 & 10 a.m.
- Country Routes (start

- at UB's North Campus)
- 34-mile: 7:30 and 8:30 a.m.
- 45-mile: 7:30 and 8:30 a.m.
- 65-mile (Metric Century): 6:30 and 7:30 a.m.
- 100-mile (Century): 6:15 a.m.
- Canada Routes (start at Roswell Park)
- 26-mile with shuttle from Niagara Falls to finish line: 6:30 to 7:30 a.m.



- 44-mile: 6:30 to 7:30 a.m.
- To participate, riders aged 18 and over are required to reach the fundraising minimum of \$200 (\$500 for Canada routes) by Ride Day; riders aged 17 and under have a fundraising minimum of \$50 for all routes.

In addition to riders, more than 2,000 volunteers are needed to support the event. Volunteer

signup is now available for the most critical volunteer positions. The Ride also offers a virtual rider option for those who are volunteering or cannot be present on June 22 but want to raise funds for Roswell Park.

Ride Weekend kicks off on Friday, June 21, with the Peloton, a 12-mile route that is reserved for a qualified group of top fundraisers who raise \$1,000 or more. The Peloton riders will ride in two-by-two formation from Roswell Park to UB's North Campus and join the Celebration of Hope event, a moving and inspirational community rally in support of the fight against cancer. On Saturday, June 22, after months of fundraising efforts, thousands of riders will embark on their routes from start lines at UB's North Campus and Roswell Park.

Since the first Ride For Roswell was held in 1996, the event has raised more than \$48 million for cancer research and patient-care programs at Roswell Park.

cal Auto Bureau," stated Kearns. "However, if we find that the extra hour is also not economically prudent, I will be mindful not to waste tax payer dollars if there is no financial benefit." The employees who will be working the extra hour will be paid overtime.


The expanded hours until 5:15pm will be held the last Thursday each month on February 28th,

March 28th and extended to April 25th. At that time, based on business volume, a decision will be made to either continue with the additional hours or return the regular hours.



### North Buffalo

**February 16, 2019**



Completed applications can be mailed or brought to the Department of Community Services, located at Buffalo City Hall, 65 Niagara Square -Room 1701, Buffalo, New York, 14202. The office is open Monday through Friday, 8:30am to 4:30pm.

To be eligible for this Mayor Brown's Summer Youth Internship Program, youth must be a City of Buffalo resident, between the ages of 14 and 21, and must turn age 14 by March 29, 2019. Each participant will be screened, assessed and receive job readiness, life skills and financial literacy training. The City of Buffalo's Division for Youth will provide youth counselors who will serve as monitors and provide program support for everyone participating in the program. College Students are encouraged to apply.

In order to determine your eligibility for the Mayor's Summer Youth Internship Program, copies of the below items must be returned with your completed application:

1. Working Papers (obtained from your school's counselor) for all youth under age 18 • Ages 14-15 (Blue Card) • Ages 16-17 (Green Card)
2. Birth Certificate
3. Proof of Buffalo Residency (Utility Bills, Lease Agreement)

4. Family Income
5. Social Security Card
6. Attending School (Most recent School Report Card or Transcript)

Private sector businesses are encouraged to participate in Mayor Brown's Summer Youth Internship Program by hiring youth who have submitted applications with the Mayor's Program. Those businesses that hire city youth may also be eligible for tax credits. Not-for-profit and Community based organizations can also participate by providing a structured and supervised work environment for the summer and, through sponsorship and donations, the City of Buffalo will subsidize the wages of youth employed in these areas. 

## Ask Rusty - Spousal Benefits and Enrolling in Medicare

**Dear Rusty:** I will be 65 In March. Husband will be 61 In August. If I started collecting Social Security now would I only be able to collect on myself? My husband plans on collecting at 62. Will I be able to collect some of his when he starts collecting at age 62? Also, who can advise me about Medicare? Do I have to apply now? Signed: Needing Advice

**Dear Needing:** Yes, if you start your Social Security benefits now, you can only collect your own benefits – you cannot collect a spousal benefit until your husband starts collecting his benefits. Whether you will get a spousal benefit from your husband's record depends upon whether your own benefit at your full retirement age of 66 is less than ½ of your husband's benefit at his full retirement age (or "FRA"). If your husband will be 61 in 2019 his full retirement age for Social Security purposes is 66 and 8 months and if he starts his benefit at age 62 it will be 28.3% less than it would be at his full retirement age. If you start your benefit at age 65, it will be reduced by 6.7% from what you would get at your FRA of 66. Your spousal benefit will be based upon both of your FRA benefit amounts and, if your husband claims his benefit in August 2020 when he is 62, you will have already

reached your FRA. So, if 50% of your husband's FRA benefit amount is more than your FRA benefit amount you'll get a spousal boost. But since you are taking your own benefit one year earlier than your FRA, the spousal boost will be added to your own reduced benefit amount, which means your total spousal benefit will be slightly less than half of your husband's FRA benefit amount. To summarize: you can't get a spousal benefit until your husband starts collecting his; you will only get a spousal benefit if 50% of your husband's benefit at his FRA is more than your FRA benefit amount; and your spousal benefit amount will be slightly less if you claim your own benefit one year earlier than your FRA.

Regarding Medicare, whether you need to apply now depends on your current health insurance. If you have "creditable health insurance" coverage through an employer (either your own employer or your husband's) which will continue after you are 65, you do not need to enroll in Part B or Part D at this time. You should check with the employer's Human Resource department to make sure their coverage will remain first payer now that you are Medicare eligible. If you do not now have creditable coverage you need to

enroll in Medicare now. You are still in your initial enrollment period, which begins three months before the month you turn 65 and ends three months after the month you are 65. If you do not apply within this time frame and you don't have other creditable coverage you will be subject to a 10% Part B penalty (that never goes away) for each year you delay. If you apply now for your Social Security benefits to start in March, you'll be automatically enrolled in Medicare Part A (hospitalization) and Part B, but you can choose to opt out of Part B (doctors and outpatient services) as part of the application process. However, if you change your mind and decide to wait to claim your Social Security benefits and you do not have other creditable coverage, you should still enroll in Medicare during your initial enrollment period by contacting your local Social Security office or by enrolling online at [www.ssa.gov](http://www.ssa.gov). The current monthly premium for Medicare Part B is \$135.50 for a married couple filing a joint income tax return with a combined income (from all sources) of \$170,000 or less.


