## Storm Cleanup

A powerful storm system brought brutal winds and widespread power outages to Buffalo and parts of Western NY last Sunday.

Gusts of up to 75 mph were predicted to hit Western NY while nearly 40,000 were without power Sunday afternoon.

Erie County Central Police Services reported answering 1,500 emer-

gency service calls over a five-hour period on Sunday afternoon. But the center was prepared with additional staff to handle the volume, due to weather forecasts that were on the mark, said commissioner James Jancewicz. On a typical Sunday in February, the center receives about 75 to 80 calls in a given hour.

More than 5,000 util-

ity workers were readied to help with the damage.

Gov. Andrew M. Cuomo activated 250 members of the National Guard to help with debris cleanup, while empty tractor-trailer and tandem trucks were banned from portions of the New York State Thruway, as well as Interstates 190, 290 and 990, U.S. 219, State Route 400 and State Route 5.



## Sabres Dodge Disaster as Skinner Escapes Serious Injury

Silence enveloped the Keybank Center as Jeff Skinner crawled on his hands and knees towards the bench. He had just been tripped, corkscrewed actually by Washington Capitals defenseman Carl Hagelin. Skinner appeared to be in agony and had to be helped off the ice. With his 36 goals Skinner is tied for fourth in the league. He is the first elite goal scorer the Sabres have had since Thomas Vanek. The home crowd quickly understood that the disappointing season would plunge into a deeper darker hole without the NHL's second leading goal scorer.

But Skinner was back on the ice for the Sabres when they started the third period, helping Buffalo to a solid 5-2 win over the defending Stanley Cup champion Capitals. The sight of Skinner back on the ice was a huge relief for the fans and the team, which is trying to make a late season push for a wild card playoff spot in the Eastern Conference. Of course that is proving to be a difficult task for a team that has not won back to back games since December 13th.

Skinner is an Unrestricted Free Agent (UFA) and his contract expires after this season. General

Manager Jason Botterill's most important job should be to lockup Skinner to a long term deal. Whatever the cost. But that gets complicated as the market keeps rising for UFA's. Mark Stone was traded by Ottawa to Las Vegas at the trade deadline. Vegas promptly signed him to an eight year deal at \$9.5 million per season. Stone may be slightly more valuable than Skinner as he is a more consistent scorer and better two way player. But he also doesn't have Skinner's breakout year on his resume.

Supposedly the Sabres have no interest in paying Skinner that kind of money. No doubt they are concerned about his poor season with 31 points in 2017-18. The may want to pay him like the consistent 30 goals scorer which he has been. Not the potential 50 goal scorer he has been since playing with Jack Eichel. Of course Skinner's side will argue that he has never

played with an elite playmaker like Eichel before and that partnership will continue to be fruitful in the future. Eichel's emergence as a top scorer this season can be attributed to Skinner's finishing ability. Jack knows how to set him up and Skinner knows how to score. Skinner and his agent Don Meehan hold the negotiating leverage here. If they don't get the deal they want he can just skate away and sign somewhere else. Reportedly Skinner wants to stay here. But he also wants to get paid. It's

ludicrous to think that the Sabres have a "walk away" number beyond which they will not pay. Jack Eichel is the teams best player and as such is the highest paid player at \$10.5 million. So paying Skinner in the \$9 million range will not upset that salary hierarchy. Letting Skinner walk away for nothing over a million dollars would be a huge mistake for an organization that has been looking for an elite winger for their top center since trading away Evander Kane. Botterill needs to get this done.

Buffalo Gamelan Club - Sari Raras Irama will be joined by Director Matt Dunning, Darsono Hadiraharjo - Dhalang, and shadow puppet master Heri Purwanto, as well as Maho Ishiguro, gamelan director at Yale, as well as Chris Miller, Director of the gamelan at Cornell University, making for a full group of musicians able to perform an array of music.

SRI will start the show with gendhing Widasari, a classic piece in the klenengan style. SRI will be exploring all of the pieces exciting possibilities including it's elusive 4th level of density: irama rangkep. the rangkep section of the piece is it's most dense possibility, with the elaborating instruments playing at their highest skill level and fastest speeds. This is the first time that SRI will perform a piece in irama rangkep at a concert in Buffalo.

After Widasari BGC-SRI will change course and perform a 1 hourish wayang kulit shadow puppet performance. titled "Gatotkaca and the battle for the kingdom of heaven". This is the first wayang ever performed in Buffalo and will showcase all the different elements of the show. Later in the year on June 6th. 



## Felonies

After about a year, the person who originally arranged for us to get the first rescue dog,



## Ask Rusty - Why Should a Veteran Pay for Medicare?

*Dear Rusty: I am a Veteran and all my Medical needs are covered by the VA. Why should I be paying for Medicare out of my monthly SS check? Signed: Inquiring Veteran.*

Dear Inquiring Veteran: Well, it depends upon how comfortable you are that the VA will be able to provide ALL the medical services you may ever need, emergency or otherwise, for the rest of your life. I, too, am a veteran and receive some of my care – such as wellness exams, blood tests, some prescription drugs,

and immunizations – from the VA, but I also have Medicare to cover other services which are not typically available on an immediate basis from the VA. The point is, there will almost surely be times when you won't be able to rely on the VA for needed immediate care or certain specialized services from specific medical experts, and if you don't have Medicare you may find yourself facing some very large medical expenses which you will be personally responsible for. That's where Medicare will

help because nearly every medical facility and healthcare service in the country accepts patients with Medicare. And being immediately accepted as a Medicare patient anywhere in the country, anytime of day or night must certainly have some value for you. After all, none of us know what our health future will be.

Since you're now collecting Social Security I assume you're already enrolled in Medicare Parts A & B, and you're questioning why you should continue to pay the Part B premium. Medicare Part B is coverage for doctors and other outpatient services, while Medicare Part A provides hospitalization coverage. There's a premium for Part B (\$135.50/month in 2019), but Part A is free if you also qualify for Social Security. And, by the way, you must have Medicare Part A to collect Social Security after you're 65. For information, VA coverage for drugs is consid-

ered "creditable" as an alternative to Medicare Part D prescription drug coverage. But other VA healthcare coverage is not a "creditable" alternative to Part B by Medicare's standards, so it won't count for avoiding a late enrollment penalty if you drop Part B now and decide afterwards to re-enroll. Unless you have other "creditable" healthcare coverage from your or your spouse's employer after dropping Part B, re-enrolling later will result in you being assessed a late enrollment penalty of 10% on top of the Part B premium amount, recurring every year, for each full year you go without Part B coverage. That penalty doesn't go away, and it will go up as the Medicare Part B premium increases (which it does from time to time). Additionally, you will be restricted on when you can later re-enroll and when your coverage will start again. For clarity, if you have other "creditable" (not VA) coverage you can drop Part B, save the premium, and re-enroll in Part B again later without penalty (when your other "creditable" coverage ends). But if you

don't, you may find your healthcare options limited and you'll incur penalties for re-enrolling in Part B later.

Obviously the choice is yours to make, but I suggest you consider the above points carefully when making your decision about whether to drop Medicare Part B and rely only on the VA only for your healthcare coverage. That's not to take anything away from the excellent healthcare services offered by the VA, but only to make sure you're aware of the risks associated with dropping Medicare Part B.

# Canisius Wins First Place in CFA Challenge

For the ninth consecutive year, the Canisius College Golden Griffin Fund (GGF) team took home first place in the Western New York Chartered Financial Analyst (CFA) Institute Research Challenge. The four-person GGF team secured its latest win at Niagara University on February 18, 2019.

The team now advances to the Americas Regional, where it will compete against college and university teams from North and South America. The winner then moves on to vie for the worldwide CFA cham-

pionship. The Americas Regional will be held on April 23-24 and the global championship, on April 25, both held in New York City.

SUNY Oswego placed second in the competition followed by SUNY Geneseo and University of Rochester as runners-up in their respective semi-finals brackets. Other schools participating in the challenge included Cornell University, Niagara University, SUNY Buffalo and Syracuse University.

"The CFA Institute Research Challenge is a rigorous global competi-

tion that tests our students' knowledge and application of investment research, ethics and professional standards," says Richard A. Wall '78, PhD, CFA, professor of economics/finance. Wall is also the faculty advisor to the Canisius team. "To be among up to 60 teams who are moving on to the Americas Regional Challenge is an incredible honor for our students and a testament to their hard work and commitment to the competition, and their futures in the investment management profession."

"This competition provides our students with an opportunity to integrate their academic training in a team environment and become polished professionals at the very start of their careers," adds Steven Gattuso '87, MBA '89, CFA, CFP, CMA, director of the GGF and CFA mentor to Canisius students.

The Golden Griffin Fund team that took home first place in the Western New York CFA Institute Challenge was comprised of Alexandra Pfeifer '19 (captain), Allison Jennings '19, Jenni-

fer Keefer '19, and Mike Maiorana '19.

The CFA Institute Research Challenge is an annual global competition that provides university-sponsored teams with hands-on mentoring and intensive training in financial analysis. The competition tests the analytic, valuation, report writing and presentation skills of students studying business, finance and economics. Teams are challenged to research a publicly traded company and write a written report with a buy, sell or hold recommendation. Teams must then present and defend their analysis to a panel of industry professionals who serve as judges in the competition.

The subject company for this year's Canisius GGF team is Astronics Corporation, an aerospace and avionics provider headquartered in East Aurora, NY.


Established in 2003, the GGF is one of the region's first real-money, equity investment funds managed by undergraduate and graduate finance majors. GGF students select potential companies in which to invest, man-

age and analyze portfolio holdings, and evaluate and recommend companies to add to the portfolio.

In 2015, Canisius College won the global championship title, placing first over more than 4,000 undergraduate and graduate students from 865 universities in 70 countries.

The Chartered Financial Analyst Institute is a global association for investment professionals.
