Sabres Reach New Low

In their 4-0 loss to the Ottawa Senators the Buffalo Sabres managed to find a new standard of poor play in a season that has become the worst in franchise history. Ottawa has been the leagues worst team, then they moved out their best players at the trade deadline. This is a team heavy with AHL players. And they ran (skated) wild all night as the Sabres defensive game was nowhere to be seen.

This was the teams fourth straight loss and 17th loss in their last 20 games. The team has only one regulation win in those 20 games. It was their 13th consecutive road loss. Since the 10 game win streak four months ago, from November 27- March 27 the Sabres have 35 points in 51 games, the lowest total in the league. In their last 20 games. With 78 shots in their last two games the Sabres have scored only one goal, a fluke center ice bounce shot by Sam Rhinehart against New Jersey Monday night.

The Sabres actually outshot the Senators 35-31 but rarely threatened with a dangerous scoring chance. Team captain Jack Eichel expressed his disappointment after the game, "We've got to be better. Everyone. Myself, everybody. Everybody has to be better." "We can't go out there and play like that and expect to win. We've

got six games left... it's been embarrassing for us. We can't go out there and play like that and expect to win. We've got six games left. It's been embarrassing for us. If you can't play for self pride, find something. Find some motivation to play for. Everything has to get better."

On Ottawa's fourth goal Magnus Paaajarvi scored as the fourth player on the rush against two defenders as the Sabres forwards were caught deep in the offensive zone and out of position defensively. "It's just a lack of respect for our own net," Okposo said. "I didn't

think we were ready to play tonight. That's pretty inexcusable. We had a decent start. I think our first five minutes were pretty good, and then all of a sudden that just went into the tank. I'm running out of things to say." "I just don't think we have that sense of urgency every time we step onto the ice. We've got to get it. We've got six games left. We've got to show some emotion. We've got to play. That, tonight, was not good enough."

Late in the second period Tage Thompson was alone with the puck in front of the Ottawa net and stickhandled himself into shooting wide, the latest in a series of similar plays where he never even gets a shot on goal.

On a bright note Will Borgen made his NHL debut for Buffalo and looked poised on defense. The team had an 11-4 edge in scoring chances when Borgen was on the ice.

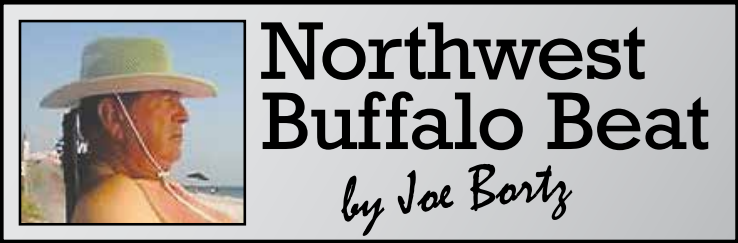

Her ability soon brought her into bigger things in the Capitol. She was a speech writer for a Vice President. Became involved with some top Federal agencies like the CIA, NATO, and NSA. Was instrumental in the writing of some historical documents. She is retired so I think it is ok to brag a bit. Her start was with the Rocket. That is another story.

Then there was my second daughter. Want to say here that all three

daughters went to all girls' Catholic schools as I was an over protective father. Dawn was a sweet attractive 16-year-old but still delivered the Rocket door to door on Delaware Avenue and loved doing it. As it goes there were some sleaze bags on the route that made inappropriate comments to her. Being young and naive she was not too offended by them. I was. Fortunately, the baseball bat did not come out. Remember please I grew up on the West Side. Sometimes you needed to correct things simply.

When a legitimate model scout approached her on the street, I did not buy it. She was all excited to think she could become a model. His business card had crossed out phone numbers. I just did not buy it. That week it happened that the paper had a story about this model scout and some of the local models he discovered. He was legitimate. He took some pictures of her at the Historical building and the rest is history. She went to New York City 40 years ago

to become a model and only returns to visit. She is still modeling and has had a very successful career. She did start at the Rocket, right? That is another story.

Then there is the incident with my son Daryl. He was delivering the West Side Times on Elmwood and Allen. Two fellows approached him and threw his papers around. These were not kids. Daryl had taken Judo at the Delaware YMCA and knew a little about self defense and was able to throw the one fellow. This only angered the two and they proceeded to give him a beating. He came home like that. Baseball bat time! Got my only other son willing to go and went looking for these gentlemen. Found the one at the Deco on the corner of Elmwood and Allen. That is another story.

Daryl perhaps due to

this incident went on to become a black belt in Judo at Kin Tora. His art in self defense has helped him. In another incident where he was confronted by three fellows at a German fest, in order to defend the honor of the girl he was with he had to take them on. His brother stood there and watched as he felt it was a fair fight. Three against Daryl. That is another story.

Lots of stories in the 50 years of the Rocket. Maybe I should write a book like Rimas says, "The adventures of Joe Bortz."

Ask Rusty - Increasing your Social Security Benefit Amount

Dear Rusty: I turned 67 in September 2018. My benefit estimate is \$1478 a month if I claim benefits now. I work and will continue working as long as I can. My 35-year earnings period includes about ten years of zeros when I was married (twice for about 5 years each). If I claim benefits now will my monthly amount go up if I continue to work? I read that the SSA recalculates each year and uses your high years. I make about \$57k a year now and hopefully will continue to do so. Does the SSA replace one of the zero years with the years I work after claiming benefits and raise my monthly benefit accordingly and how much? I truly appreciate your help with this as I would like to decide this month. I have read on SSA that if I don't claim it will go up 8% but I also have read I could be drawing benefits and working too, and this would be a better financial situation. Signed: Working Senior

Dear Working Senior: Yes, if you have 10 years of zeros in your 35-year earnings history, your more recent earnings each year will replace one of those zero years, if the earnings are what Social Security considers "substantial" (which your \$57,000 income would be). Social Security gets

your earnings information from the IRS as soon as your W-2 is available each year and makes any benefit adjustment necessary at that time (if you're self-employed the adjustment is made after you file your income taxes). When Social Security receives your income information each year, they will recompute your "average indexed monthly earnings" (AIME) with your revised 35-year earnings history (including one less zero year), adjust your "primary insurance amount" (or "PIA"), and increase your benefit accordingly. I can't tell you how much of an increase it would be because I don't have access to your lifetime earnings records, but you shouldn't expect it to be a major increase each year. After all, your new earnings will only represent 1/35th of your AIME, so the increase to your benefit won't be big. But if you continue to work with significant earnings your benefit will continue to increase over time and each increase you get will last for the rest of your life.

You are correct that for each year you delay claiming benefits beyond your full retirement age of 66, you'll earn delayed retirement credits (DRCs) of 8%, up until you are 70 when your benefit would

be 32% higher than at your full retirement age. You're earning those DRCs now at a rate of 2/3rds of 1% each month after your FRA and will continue to earn them until you claim (but not after age 70). However, if you are trying to compare the increase you will get by claiming benefits and continuing to work, versus the 8% per year increase you will get by delaying claim of your SS, please be aware that the 8% annual increase will be much more than any increase you'll get from working and replacing a zero year. And the fact is, if you continue to delay and also continue to work, you'll still be improving your eventual benefit from your earnings and you'll still earn those delayed retirement credits until you are 70. In other words, you can do both.
