Sabres Promote Sobotka to Second Line

In a curious move the Buffalo Sabres have promoted Vladimir Sobotka to the second line to begin the season. This ranks as a surprise because by any measure Sobotka was likely the worst player in the NHL last season. He scored five goals and eight assists with a -20 rating. On last seasons team Sobotka's plus minus was the third worst behind only the minus machine Rasmus Ristolanien's league worst -41 and Tage Thompson at

In fairness to Soboka, he is a skilled player perhaps miscast last season as a fourth liner playing with players like Zemgus Girgensons and Johan Larsson. While Girgensons and Larsson are honest hard working players their offensive output is minimal with five goals and six goals respectively. Sobotka or any other player cannot be expected to produce much offense with such line mates.

The Sabres new bench boss Ralph Krueger has coached extensively in Europe. Perhaps he sees the skill in Sobotka, a Czech player, and believes that he can coach him into a scorers role on the all European second line with Finnish newcomer Marcus Johansson at center and Swede Victor Olafsson on the wing. Remember that Sobotka is the only remaining

player that the Sabres have to show from the three players St. Louis sent to Buffalo in the disastrous Ryan O'Reilly trade. The eventual Conn Smythe trophy winner and Stanley Cup champion was shipped to St. Louis after he lost his love for hockey in Buffalo. In return the Sabres received Sobotka, Tage Thompson, Patrik Berglund, a 2019 1st round pick and a 2021 2nd round pick. Additionally the Sabres used that 2019 pick along with Brendan Guhle to acquire Brandon defenseman Montour.

If Sobotka can provide 10-15 goals from the second line and Brandon Montour makes a solid contribution on the blueline, then the return from

the O'Reilly trade looks better. Is this the thinking that drove the decision to put Sobotka on a scoring line?

The key is whether Johansson can drive the line from his center ice spot. He was outstanding on the wing for the Stanley Cup finalist Boston Bruins in the playoffs last season and has primarily played left wing in his career. Olafson is a talented goal scorer but needs a setup guy. If Johansson can fulfill that role then that will go a long way to making this second line work. Sobotka will be counted on to be a strong defensive presence and chip in with a few goals.

This is a surprising turn of events for Sobotka who looked like he was sleepwalking through last season would not have been missed if the Sabers had deservedly bought him out. A successful second line would allow the Sabres to keep their top line intact consisting of Jack Eichel (82 points), Jeff Skinner (40 goals) and Sam Reinhart (65) points which would be one of the top scoring lines in the league. Otherwise the top line would be broken up to provide some balance.

Gangs Two, Riot

As promised in last week's column I will proceed to go into chapter two of my encounters with the gangs that existed on the West Side of Buffalo back in the late sixties. Just in case you missed last week's endeavor I will rehash the highlights. It had to do with an inappropriate remark made by one of the gang members to one of my daughters. After talking to the siblings it turns out it was not my daughter but my wife. In any case, I quickly confronted the gang leader and he was kind enough to insist on an apology from the perpetrator. The incident was settled peacefully and at that point the Beta gang and my family continued on to co-exist at the Massachusetts swimming pool and playground. Which happened to be the Beta gang's stomping grounds.

One fine day in the middle of that summer, this same Beta gang decided to hold an outdoor concert right there at the Massachusetts playground. Actually in front of it. They somehow solicited a band and set up quite an elaborate stage and sound system. It was in the parking lot adjoining the Butler-Mitchell youth club. So if someone chose to dance they could do so. Seemed like a great idea and something for the kids to do outdoors and mingle with other neighbors. Now remember, this was in the afternoon and with plenty of daylight, so no lighting system needed to be procured. Everything went fine and I was there enjoying the afternoon event with my children. I thought much more of the "gang" for doing something like this. Like I said, everything

was going really well until someone complained and called the police. The complaint was that they were making too much noise. Granted, the music was not quite the golden oldies and was meant to be played "loud". Still it could have been tolerated as it was still during the day. So a patrol car appeared and politely told the leader of the gang to turn the music down. Remember that this was a neighborhood gang and even though this event was permited, they have had previous confrontations with the police. They did turn it down at first, but the effect of the music was not as stimulating, I guess. So they turned the sound back up. This did not sit well with the officers who had answered the call and chose to hang around. To simplify this I will just say the officer went on to pull the plug on the sound system. The gang leader put it back in. Thus a serious confrontation as the crowd in attendance were not in favor of the officer's actions. It became ugly and uglier until the officers called for back-up. Back in the sixties, some may recall, riots were happening all

over the country. So "back up" showed up in force. Riot gear, paddy wagons, night sticks, black jacks, (which are now illegal) and a small army. No questions asked, if you were the least bit defiant, you were arrested on the spot. Fortunately I was able to get my family out of there before the bottles and rocks started flying. When we got home I realized my eldest son was missing. My daughter said they grabbed him just for being there and she thought he was in one of the paddy wagons. So I returned to the battlefront, which now existed of the police at one end of Shields Street and the angry crowd at the other. A one block long street. The space between them was littered with rocks and bottles. The police were trying to disperse the crowd which had become extremely unruly. I just wanted to find my son. So at the risk of being arrested myself, I began to look into each and every one of the paddy wagons at the scene. Each contained some pretty beat up kids and plenty of blood. My friend Dick Ganci, who's grocery store was on that corner, told me my son did noth-

ing but was in the wrong place at the wrong time. They feared for me and thought I would end up the same way if I did not get inside. This was one really ugly scene for such a normally quiet residential neighborhood. I finally went to the local police station and my son was there. The officers were kind enough to let him go with me without any charges. The only damage was a welt from a black jack and a gloop of his Afro hairdo was missing. It came out in a big chunk when he was grabbed by the hair. We were happy with that as it could have been much worse. Strange how this all transpired as what started to be a good thing turned into a complete disaster. Looking back in retrospect, both sides over reacted. The responding officers could have been a little more tolerant and understanding. It was a bad time for law enforcement agencies. Back then in the days of the riots they were called "pigs." Seems that moniker has passed and that is good. Now they have to be aware that they are being videotaped. They were then and still are now some of Buffalo's finest.

Ask Rusty - What Will My Widow's Benefit Be?

Dear Rusty: My husband just started receiving Social Secureceiving Social Security Disability in June. He is diagnosed with a terminal disease that likely he will rapidly succumb to. He will be 65 in Oct 2019. I turned 62 July 2019. I was his caregiver when he was at death's door and was pulled back to 75% full life on immunotherapy. We see him starting to go downhill again; it creeps, then starts moving rapidly with the symptoms. I will be the caregiver again for round 2 that has no brakes to stop it this time - no do over. After he passes, when does the disability SS amount stop and what amount starts coming to me in my name as his widow, at my age? Signed: Survivor under age 65

Dear **Survivor:** Please know that you have my sympathy for what you and your husband are going through. Let me at least try to ease your anxiety by answering your Social Security questions.

Your husband's disability benefit will cease in the month he passes. Although, depending upon the date, he may receive a disability payment for the month he passes (it would be received the following month), that payment,

if received, will need to be returned to Social Security (SS). Social Security will only pay up to the last full month your husband is alive. The funeral home is supposed to notify Social Security of your husband's passing, but you should verify that they will be doing that. Your benefit as your husband's survivor will be based upon the SS disability amount your husband was receiving at his death.


Although your survivor benefit will be based upon the amount your husband was receiving, if you take it before you reach your full retirement age (FRA) the survivor benefit will be reduced. Your full retirement age for the widow's benefit is 66 plus 2 months (versus your normal FRA of 66 1/2). You have a choice to take the reduced survivor benefit early (before your FRA), or wait until your FRA to claim the full amount your husband was collecting at his death. If you claim your widow's benefit early, the reduction will be about 4.75% for each year earlier than your FRA that you claim it. Your survivor benefit reaches maximum at your widow's FRA. You must apply for your widow's benefit in person with Social Security and

you should contact your local office by phone first to make an appointment. You can easily find your local SS office contact information at this link: www.ssa.gov/locator.

Taken at age 62, the survivor benefit will be reduced by about 20%. When to claim your survivor benefit might be influenced by whether you are eligible for Social Security benefits from your own lifetime work record. If you are eligible for your own benefit, you should look at what your own benefit will be at age 70. If it will be more than your survivor benefit, you should make sure to file a "restricted application" for survivor benefits to allow your own benefit to continue to grow. It will grow until you are 70, at which time you would switch from the lower survivor benefit to your own (you get whichever benefit is higher). Your decision on when to claim the survivor benefit might also be influenced by your plans for working. Since you have not yet reached your normal full retirement

age (66 + 6 months), any Social Security benefit you claim before that (including your survivor benefit) will be subject to Social Security's earnings test. The "earnings limit" for 2019 is \$17,640 (changes annually) and if you exceed that, Social Security will take back benefits equal to \$1 for every \$2 you are over the limit. The earnings limit will be in effect until you reach your normal full retirement age, at which point it goes away. Once again, you have my sympathy for the difficulties you are experiencing, but fortunately your Social Security widow's benefit will be available to you when your husband passes.

fire itself to claim sleeping victims unaware of the fire.

Common Causes of Fires

Most house fires occur in the kitchen while cooking and are the leading cause of injuries from fire. Common causes of fires at night are carelessly discarded cigarettes, sparks from fireplaces and heating appliances left too close to furniture or other combustibles.

Playing

Children playing with matches or lighters is a leading cause of house fires and one in which the children and others present are often hurt. Children have a natural curiosity about fire and are tempted to play with matches or lighters. Even though children are curious about fire, they may become frightened and confused in a fire and hide rather than escape to safety. Children are often found hiding in closets or under beds where they feel safe. It is crucial to discuss with your children the dangers of fire.

Clothing

Clothing fires are a significant cause of fire injuries to children (and to adults too). They set their clothes on fire by getting to close to heat sources such as open fires or stoves, or when playing with matches or lighters. Here too, the best defense is a respect for fire and training in what to do if their clothes do catch fire. Their natural reaction is to run - which will make the situation worse. Stop, drop, and roll is taught as the correct action and has saved many lives in clothing fires. The moment clothes start to burn, stop where you are, drop to the ground, cover your face with vour hands and roll repeatedly to smother the flames.

Older Adults

The risk of death from fire for Americans age 65 and over is two times greater than the risk for adults under 65, and hospital stays of more than 40 days are common for older burn victims. Thus, older people need to be especially careful with fire. People can become victims of fire by falling asleep smoking, either in bed or in a favorite chair, especially after consuming alcohol or taking medication. Ashtrays emptied before smoldering materials are completely out also start a number of fires in homes of smokers. Cooking is a major cause of fire injuries among older persons when loose fitting clothing is ignited as the wearer reaches over a hot burner, or slips and falls onto the stove.

One of the most important fire safety devices for the home is the smoke detector. After becoming generally available in the early 1970s, home smoke de-

Smoke Detectors

tector sales grew rapidly and the price fell, so that by 1991, almost 90% of the homes in the United States had at least one smoke detector, and they could be purchased

for under \$10.

Several studies have concluded that when working smoke detectors are present, the chance of dying from the fire was reduced by half. The smoke alarms currently in place have saved thousands of lives, but several problems exist. Twelve percent of the homes without detectors have more than half of the fires. It is also estimated that a third of the smoke detectors in homes are not working, often due to the fact that a worn out battery is not replaced. Another problem is that many homes do not have as many smoke detectors as are needed to protect the occupants properly.

To be fully protected and be in compliance with state laws, it is required that a smoke detector is placed inside and outside each bedroom and a smoke detector placed on all levels of the home including the

basement.


