

## Sabres Lose Opener of Homestand

The Sabres lost 5-2 on Tuesday to an Ottawa Senators team beneath them in the standings. This was Buffalos first home game in a stretch of nine of their next ten games on home ice where the Sabres had a strong 14-7-3 record. The Sabres were 10 points and three teams out of a wild card spot in the Eastern Conference entering Tuesdays' game. It was hoped that the team could win a majority of those home games and get back into the playoff race. But hope is a commodity best rationed in small doses this season.

This was the Sabres first game in 10 days and it showed. The Senators played Monday and the activity clearly gave them an advantage against the rusty Sabres. Buffalo surrendered the first seven shots of the game and trailed 1-0 at 3:59 early in the first period. The team was weak on the mental side of the game as too many players did not show the competitive desire needed to win.

Jack Eichel and Sam Rhinehart scored for Buffalo as the Sabres squandered an opportunity for two points in a very winnable game. The Senators had a 1-5-5 record in their last 11 games, surrendering

138 shots in their last three, an average of 46 per game. Buffalo failed to take advantage of that trend. The Senators out shot the Sabres 30-15 through the first two periods, and held them to 30 shots for the game.

Buffalos' special teams cost them the game. The penalty killers surrendered three goals to an Ottawa team that has ranked dead last at 31st in the league on power plays but has been hot lately with six goals in their last four games. Ottawa also added a shorthanded score, they have now scored three shorties in the last two games.

Eichel said after the game, "It's not good enough, I mean if we want to make the play-

offs that's not a playoff caliber effort by us so, you know that, I know that, everyone in the room knows that."

Of tremendous concern was a late game injury to goalie Linus Ullmark who appeared to move awkwardly in his crease and left the ice unable to put pressure on his left leg. Ullmark has started 18 of the teams last 20 games as veteran Carter Huttons' play has fallen off substantially. The Sabres recalled Jonas Johansson from Rochester where he had a 13-3-3 record, a 2.19 GAA and .925 save percentage. If Ullmarks' injury keeps him out of the lineup then the Sabres are left without a viable NHL goaltender.

Eichel's goal was his 29th of the season, a new career high. Jeff Skinner returned from injury, finishing with one shot on goal and a minus two. Old friend Tyler Ennis had a goal and assist for Ottawa.

The Sabres next game is Thursday against the Montreal Canadiens at Keybank Center.

## Longer Life

It takes a long time to grow old. Many, many years. I found that out recently. Not so suddenly I have reached the "golden years." Here in Florida, the community where we spend our winters, seems like we have all become not only senior citizens but old senior citizens. When we moved into this particular location 20 years ago, it being new, everyone was recently retired and in their early sixties. That was twenty years ago. Those that are still here are all in their eighties and nineties but still going strong. Except if they contract some deadly illness, with modern medicine and lots of pills, life goes on.

My parents passed in their mid sixties back in the mid sixties. At that time that was considered an older age believe it or not. My grandfather passed at 83 but he was

an invalid and did nothing but sit for years. I think those that are old enough to remember those days would agree. Heart attacks were common and people died of them. Spending an active winter outdoors in the sunshine most of the day has to contribute to our

good health. Whether it is the medicine or the atmosphere I am amazed at the agility of some of the older residents here.

One of the best golfers here is 92. You would expect someone at that age to be using a walker or at least a cane. I do not see him playing tennis but I have golfed with him and he puts me to shame. He bounces up and down the golf mounds like they do not exist. He is just one of many. Most of the golfers that have been here for a while, are still as good as ever. In all honesty some have slowed but not too many. It is only recently I have inquired as to how old some of my friends are. Some of the answers astonish me as I would have never guessed it.

We have a group here called the volunteers. It is a group of men who volunteer their time to work on projects within the boundaries of our community. Now these are hard labor projects like pouring concrete, building walls, fixing the many foot bridges and just doing whatever needs to be done to make it a better place to live. There is always a crew working every day as they are very

visible. They wear a yellow vest, not only for safety but to be recognizable. This one fellow, who is also our Bocce captain, and seems to be one of the most hard working of the group, although they all work hard, told me he was 87. He still works on these hard labor projects. The concrete specialist of this group has been doing concrete all his life. We played bocce against him the other day and he is about the same age. Told me he had back surgery and is finding it tougher to swing a sledge hammer now. Are you kidding me?

Like I said it takes a long time to get old. Guess it depends on some factors as far as how you live your life. How you take care of yourself. The concrete guy poured concrete all his life. The 92 year old good golfer was

a lawyer. These are two completely different life styles but both seem to have longevity.

The big factor of course is modern medicine. I know I personally should be gone by now except for good doctors and early diagnosis. I was found to have had the same thing my mother died suddenly with. My doctor found I had it in the early stages. After doing lots of research we found a procedure to correct it. So I am still here El Gloppo. I am sure lots of people have similar stories to tell. It just amazes me how things were back then and how they are now. To see these people and their outstanding health condition. We all want to hang around as long as we could. At least I do, as I still have people to see and places to go.

## Ask Rusty - About Warnings to Make Sure I "file properly"

**Dear Rusty:** I am currently 63 years old and planning to delay retirement until 70 to maximize my benefit. I've been seeing a lot of financial planners advertising claims that you can lose thousands of dollars in benefits if you don't "file properly." Is there really anything more to it than simply applying for benefits when you are ready to retire? Do I really need to pay a financial advisor just to tell me how to apply to get the most benefits? Signed: Skeptical

**Dear Skeptical:** Nearly all the advertisements you see using language like that have an underlying purpose of trying to sell you something - usually a book, a subscription, or financial services. The phrase "losing thousands if you don't file properly" are very ge-

neric words meant to lure you into contacting them so they can sell something to you. Reality is that "filing properly" means simply choosing the right age to file for benefits given your specific personal circumstances. And personal circumstances are different for everyone. There aren't any tricks in the filing process itself - it's really quite straightforward, and you can get all your Social Security filing questions answered here at The AMAC Foundation's Social Security Advisory Service. Our staff of Social Security Advisors are fully trained and certified by the National Social Security Association (NSSA®), and we have years of experience on this complex topic. We provide Social Security information and answers to several thou-

As for when you should file, everyone's personal situation is different, and your marital status should always be considered. But as an individual, waiting until age 70 will give you the maximum benefit available to you. If you are now 63, your age 70 benefit will be 29.3% more than it would be at your full retirement age of 66 years and 4 months, and

about 65% more than you'd get at age 64. And provided you are in good health and expect at least average longevity (about 84) not only will your monthly payment be more, but you'll collect more in cumulative lifetime benefits by waiting. And here's an extra bonus - if you are married and you predecease your wife, her survivor benefit will be based upon that larger amount you were receiving because you delayed claiming. If she has reached her full retirement age, as your widow your wife will get 100% of your actual benefit. But if you were to claim earlier,

your wife's survivor benefit would be based on that smaller amount.

The answer to your specific question is that there is no magical way to apply for benefits once you determine the age at which you wish to file. You can file by calling the Social Security Administration directly, either at their general number (1.800.772.1213) or your local office (find it at [www.ssa.gov/locator](http://www.ssa.gov/locator)), or you can also file online at [www.ssa.gov/retire](http://www.ssa.gov/retire). Filing online is by far the easiest and most efficient way to complete and submit your application for benefits.
