# Taste of Buffalo Goes Virtual



# In response to COVID-19, an 'at home' event will replace the traditional festival to support local restaurants, wineries and FeedMore WNY.

Together with Tops Friendly Markets, organizers of the 2020 Taste of Buffalo announced plans for a virtual version of this summer's food festival. To ensure the health and safety of guests, the Taste board of directors made the decision to introduce Taste of Buffalo at Home, a virtual food

festival.

The 37th edition of the Taste, the nation's largest two-day food festival, will take place on July 11 and July 12 on the event's Facebook and Instagram channels. Taste of Buffalo at Home will embody the spirit of a live festival, bringing a fun, community-centric

atmosphere into peoples' homes with food, cooking demonstrations, live music, contests, games and more – all hosted online.

At the heart of Taste of Buffalo at Home will be the "Taste Takeout" initiative. More than half of the restaurants, food trucks, and wineries that Continued on page four.

# **Girl Scouts of WNY Cancel Summer Camps**

The Girl Scouts of Western New York will not open its day and resident camps for more than 2,000 girls this summer due to safety concerns about the COVID-19 virus, officials announced today.

In addition to campers, that means that some 160 seasonal staff cannot be hired. Families, past staff, and Girl Scout members were notified of the decision earlier today. Girl Scouts of Western New York [GSWNY] plans to offer virtual and alternative camping and

Girl Scout programming instead.

"While this is obviously a hard decision, we doubt this comes as a



surprise to most people," said Girl Scouts CEO Alison Wilcox. "We must put the safety of girls, fami-

lies, volunteers and staff first, and there's no way we can see accommodating campers in proximity to each other and staff in camp settings safely during this time."

GSWNY operates day camps at Camp Piperwood in Fairport and Camp Windy Meadows in Lockport; and resident camps at Camp Timbercrest in Randolph and Camp Seven Hills in Holland. Last summer, a total of more than 2,000 Girl Scouts attended those camps through Continued on page six.

## Memorable Sabres Moments


With the NHL season on suspension, we are looking back at great moments is Buffalo Sabres history. On May 8th 1975, the Sabres defeated the Montreal Canadiens 4-3 in Game six of their Eastern Conference playoff semi finals at the fabled Montreal Forum. With this victory, the Sabres eliminated the Candiens and advanced to the Stanley Cup Finals for the first time in their history.

Although both teams had finished the regular season with 113 points, and Buffalo held the home ice due to tie breakers, the Sabres were considered underdogs to the impressive Canadiens. The expansion Sabres had opened the series with a pair of victories at their home rink, the Memorial Auditorium, 6-5 in overtime in game one and 4-2 in game two. When the series shifted to the Forum, the Canadiens annihilated virtually Buffalo with 7-0 and 8-2 victories in games three and four. With these dominant wins, Montreal seemed to demonstrate that they were the vastly superior team and were assured of victory in the

But the Sabres rebounded with a 5-4 overtime victory in game five back at the comfortable confines of the Aud, setting the stage for their game six victory. At the Forum for the decid-

ing game, the Sabres checking game was so determined that the Canadiens shot counter registered a single shot on goal throughout the second period, which would establish a franchise record for offensive futility. When the shot counter mysteriously rose to three as time expired with no apparent increase in the actual shots, it was presumed by some that the Canadiens had simply increased the number to avoid the embarrassment of taking a single shot on goal while facing playoff elimination.

The Sabres victory over the Canadiens stands as their greatest playoff success. Montreal's lineup was a dynasty in the making which included 12 future Hall of Famers including coach Scotty Bowman and future coach/GM Glen Sather. This was Montreal's last playoff defeat before embarking on their dynastic run of four consecutive Stanley Cup championships from 1976-1979.



# Ask Rusty - About the "Earnings Test" and "Registering" with Social Security

Dear Rusty: Does tax filing status matter when calculating how much you can earn without a reduction in your monthly SS payout? My wife and I have filed a joint income tax return for years. My wife is working and I'm 62 and wondering - if I start drawing SS, does the earnings limit only relate to what I earn, or does it include what my wife earns as well? Is the earnings limit tied to our IRS filing status? I need to know if I should file my taxes as a single to be sure my wife's earnings are not combined with mine to affect my Social Security payment.

Also, I've read that it's recommended to register online with SS if you're 62. As I understand it, this should be done even if one's not intending to start benefits yet. Is this true? What are the benefits for doing this? Does it make for a quicker start of payments once the election to start benefits is made? Would it help my wife should I die prior to starting my benefits? Signed: Wondering

Wondering: Dear Income tax filing status doesn't matter when it comes to determining if your earnings from work exceed Social Security "earnings limit." If you collect SS before you reach your full retirement age (FRA), your wife's earnings from working will not be counted toward your personal SS earnings limit. The earnings test looks only at your personal earnings and, if you exceed the limit, SS will take back some of your benefits. But only your personal earnings as reported on your  $\mathbf{\widetilde{W}}$ -2

or Self-Employment tax return – count. If you're not working, then your Social Security benefits will not be affected by the earnings test, even if you file a joint return which has an Adjusted Gross Income (AGI) which is more than the annual earnings limit because your wife works.

As for your second question: it is not necessary, nor would it gain you any advantage, to "register" with Social Security before you are ready to claim your benefits. Indeed, Social Security does not even provide you with a way to do that. What they do provide is a way for you to create your own personal "My Social Security" online account, which gives you access to all of the online features provided by the Social Security Administration, including allowing you to apply for your benefits online (the fastest way to claim) whenever you're ready to do that.

Having an online SS account doesn't provide you with any benefit advantage, but it allows you to monitor your lifetime earnings record, get a replacement SS card if needed, and get esti-

mates of your current and future Social Security benefits to help you decide when to claim. You can create your personal "My Social Security" account by going to www. ssa.gov/myaccount. They use a "two-factor" security process, which means you'll not only need to set up a password but also a second way to confirm your identity (usually via

a code sent to a text-enabled cell phone or your email account). But, even if you have this online account pre-established, your wife will still need to contact Social Security directly to claim her survivor benefit if you predeceased her. Survivor benefits must be applied for by the surviving spouse directly contacting Social Security.



various summer sessions. Piperwood served 338 girls, Seven Hills hosted 929, Timbercrest 568, and Windy Meadows more than 200 Girl Scouts.

All camp property rentals are cancelled through August 31, 2020 and pre-registration fees for campers and rentals will be refunded in full within 30 days. In addition, the suspension of all in-person Girl Scouts activities is extended until

at least June 30, 2020.

Camp staff last summer included 58 at Piperwood, 62 at Seven Hills and 40 at Timbercrest. Volunteers fully staff Windy Meadows. Camp directors will continue to work this summer, assisting with virtual and other programming GSWNY plans to offer. GSWNY is currently surveying families to determine what type of summer programming they seek.

"We made the decision now so seasonal camp

staff have as much notice as possible to help them make alternate plans for summer jobs, and parents have notice to find alternative child care for the summer," Wilcox said. "We also understand the disappointment our Girl Scouts and their families will feel without these opportunities. We want them to know Girl Scouting has remained strong for over 100 years and our camp programs will still be here for future summers."


