

Phase Three Begins Next Week



Phase three will include bars and restaurants, although restaurants that offer outdoor seating already are able to serve customers outside, as long as tables are spaced at least 6 feet apart.

Western New York continues to be on track for a third phase of re-opening next week that would include bars and restaurants at a limited capacity.

The key to keeping the spread of the virus down will be the wearing of masks when people are out in public and not able

to maintain a social distance of 6 feet or more.

A predictive graph based on various percentages of the public wearing masks showed a huge spike in hospitalizations in Erie County into September, if only a quarter of the public don masks. But if three-quarters of the public follow local, state

and CDC recommendations on mask wearing, hospitalizations will be very low, according to the model.

The rate of positive cases in the Western region, which includes Erie, Niagara, Chautauqua, Cattaraugus and Allegany counties, has fallen on a

Memorable Sabres Moments

This day in Buffalo Sabres History, in a draft day blockbuster trade on June 8th 1983, Coach/GM Scotty Bowman essentially shipped out his second line to the Quebec Nordiques sending Tony McKegny, Andre Savard and power play specialist J.F. Suave for Real Cloutier and a first round pick in 1983 (11th overall -

Adam Creighton).

Cloutier had been a legendary junior player scoring 93 goals and 216 points with the Quebec Remparts in 1973-74. While he had also been a scoring star in the WHA with 60, 66, 56 and 75 goal seasons from 1975-76 through 1978-79, his NHL totals were more modest and had been de-

clining steadily 42, 15, 37, 28 from 1979-80 onward in his first four injury shortened NHL seasons.

Bowman had gutted his teams depth at forward for this fading player who played only one more NHL season scoring 24 times for Buffalo in 77 games. McKegny who had just scored 36 goals for Buffalo played 8 more seasons in the NHL with five more seasons of 20+ goals including a career high of 40 goals with St. Louis in 1987-88. Savard scored 29 goals for Quebec in 95 games, essentially equaling Cloutier's production for Buffalo.

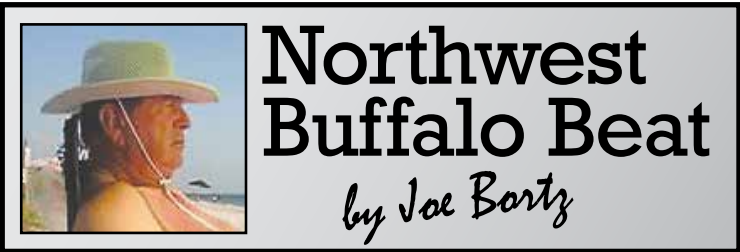

Virus Effecting Everyday Life

A tale of two cities was an interesting novel. How about a tale of two States. Florida and New York during a pandemic? I have a little tale to tell as during this crisis, I have been in both. As readers of this column know I spend the four months of winter in our southern Florida home. Happened to be there when the virus warnings ignited. Both states did not begin the same. Everything was shut down in Florida, all social functions were cancelled immediately. Golf, tennis, bocce, all outdoor and indoor activities were on hold. Stay in your home, wash your hands, and no social gathering. We did that in Florida, we went nowhere as did our neighbors, as we are all high risk candidates. I even shopped online at Wal-Mart, who I never patronize as they sell too many “made in China” items. It was convenient at the time as you order your food online and they had a very organized pick-up system with no contact. Besides it was close. Did that in the beginning as the stay in the house was crucial, we were told. After a couple of weeks I was doing my shopping at the local super market, Publix. First time I went in there to shop, many shelves were empty due to hoarders. I did not wear a mask and almost no one in the store did. After a while almost everyone did. If you remember at the start, the experts said masks were not necessary.

Lowes and Home De-

pot were wide open. All their doors were open and social distancing was suggested with signs. Most restaurants stayed open with pick-up and delivery. Some even offered buy one get one free. The fast food places never closed and those with outdoor seating did great. Remember the weather there is fine in the winter. There was a lockdown but nowhere near what was happening in New York State as I watched the news every day especially in the middle of April as that is when we start planning our return trip. The difference was enormous. At that time the deaths from the virus in Florida was extremely low compared to New York. Even considering the population is greater in Florida. 20 million compared to 19 million in New York. The whole state was in complete lockdown. So why return to that? So we extended our stay in paradise for another five weeks. By the time we were leaving Florida we were able to go into restaurants and be served by masked waitresses. I went to Lowes to buy some flowers. We parked near the garden shop as there were flowers on display outside. You could not enter that door. You had to go in the front door to enter. If you wanted to buy anything outside you had to bring it to the front door. The best part is the walkway to the front door was filled with merchandise so you had to walk out into traffic to get to the front door. My wife uses a walker and had to go out into traffic to get to check out. Then there was a long, long line as there were only two checkout clerks and neither knew what they

Ask Rusty- When Should We Claim Our Benefits?

Dear Rusty: We served overseas for several years, not earning many quarters for Social Security. However, we have made sure that we paid in over time so we can receive a benefit, but it will not amount to much. For the past several years now, we have been back in the US, earning some professional salaries. Now it looks like at full retirement age my husband will get \$1147/month, and I will get \$1026/month. I was born in 1957 and my husband in 1956. Question #1: For the most financial benefit, when should we each start collecting SS (either now or at full retirement age)? And question #2: Will our amounts change because we are married and both collecting? Signed: Overseas Worker

Dear Overseas Worker: To answer your second

question first, no, your benefit amounts will not change because you are married and both collecting. Based upon the numbers you provided, neither of you will be eligible for a "spousal boost" from the other because your benefit amounts at your FRA are too similar, so maximizing your individual benefits should be your goal. As for your other question, when you should start collecting depends upon a number of factors, including your financial needs and, importantly, your expected longevity. Both of you can get the maximum benefit available to you by waiting until you are 70 years old to claim, but that only makes sense if you are in good health and expect at least average longevity (about 84 for a man and 87 for a woman).

If you claim benefits before you reach your full retirement age (66 ½ for you and 66 plus 4 months for your husband), those benefits will be cut. If you collect now, your benefit would be cut by about 27% and your husband's by about 22% (based upon your respective years of birth). Further, if you claim before your full retirement ages and continue to work, you'll be subject to Social Security's earnings test, which limits the amount you can earn before they take back some of your benefits (the 2020 earnings limit is \$18,240; if you exceed that they'll take back half of anything you earn over the limit). The earnings limit changes annually but goes away at your FRA. At your full retirement ages, you'll be entitled to 100% of the benefits you've earned from your lifetime of working (approximately the amounts estimated now). If you can and do wait beyond your full retirement age (FRA), for each month you delay you'll earn delayed retirement credits of 2/3 of 1% per month of delay (8% per year of delay), up to age 70 when your maxi-

mum benefit is reached. As a point of information, if you wait until your full retirement age to claim, you will have collected the same amount of money at age 78 as if you had claimed at age 62; and if you wait until age 70 to claim you'll have collected the same amount of money at age 82 as if you had collected at your full retirement age. If you live at least until "average" longevity, you'll collect

more in cumulative Social Security benefits by waiting. So, when should you claim? If you're still working and earning "professional salaries", then waiting at least until your full retirement age would be a wise choice. If you expect at least average longevity and don't need the money right away, waiting until age 70 would be a prudent strategy.

biweekly basis from 7% to 4% to 2%. Western New York's peak of around 30% came about nine weeks ago..

Western New York started the reopening process with a first phase on May 19, when nonessential construction, manufacturing and wholesale trade businesses, along with agriculture, forestry,

fishing and hunting, and curbside pickup at retail businesses were allowed to resume operations.

Phase two of the reopening, which included hair salons, offices, real estate and vehicle leasing and sales, among other activities, began June 2. Phase three will include bars and restaurants, although restaurants that offer outdoor

seating already are able to serve customers outside, as long as tables are spaced at least 6 feet apart.

The reopening phases are staggered at least every two weeks to allow health officials time to determine whether the rate of infections and other key metrics continued to improve, according to state officials.

Fireworks Displays Cancelled

As public fireworks displays are canceled across the country, NFPA urges people to refrain from using consumer fireworks when celebrating on and around July 4.

In a typical year, the National Fire Protection Association (NFPA) encourages the public to only attend public fireworks displays put on by trained professionals, reflecting its' long-standing position against consumer use of fireworks. However, with public fireworks events around the country being canceled this year, NFPA is vigorously discouraging individuals' use of consumer fireworks, recog-

nizing that the likelihood of such activities may increase in the absence of public displays.

"While fireworks are an emblem of July 4 celebrations, in the absence of public displays this year, we strongly encourage people to find safe and creative alternatives for celebrating the holiday," said Lorraine Carli, vice president of Outreach and Advocacy at NFPA. "Fireworks are simply too dangerous and unpredictable to be used safely by consumers. Even sparklers, which are often considered harmless enough for children, burn as hot as 1,200 degrees Fahrenheit

and can cause third-degree burns."

In addition to the harm consumer fireworks can inflict on individuals, Carli notes that fireworks' incidents place undue burdens on first responders and emergency room staff.

As all of us continue to navigate the evolving situation with COVID-19, NFPA remains committed to supporting you with the resources you need to minimize risk and help prevent loss, injuries, and death from fire, electrical, and other hazards.
