## Help Keep Buffalo Safe

Buffalo SafeCam is the Buffalo Police Department's newest crime investigation and prevention tool.

It allows you, the citizens of Buffalo, New York, to register your cameras which may help deter crime and assist the Department with their crime prevention strategies in your neighborhood.

Registration is simple and only takes a few minutes of time. You need to provide basic contact information and where the cameras are located. There is no cost for registration and your personal information is confidential.

Once you complete the registration process a member from the De-

partment will contact you by telephone to request a visit to your residence/business to verify the information you have provided.

Buffalo Police Department will only contact you if there is a criminal incident in the vicinity of your security cameras. Police personnel may request to view and copy video images captured by your camera to assist in the investigation of a crime.

The goal of the Buffalo SafeCam program is to promote public safety in collaboration between the Buffalo Police Department and the citizens of Buffalo. All registrants agree to the following terms and conditions:

**Memorable Sabres Moments**

On July 26th 1951, Richard "Rico" Martin was born in Verdun, Quebec. Martin was drafted by the Buffalo Sabres in the 1971 NHL Amateur Draft with the fifth overall pick. He was the Sabres first selection in their second draft, following the selection of Gilbert Perreault, the first overall choice in the 1970 draft.

Martin scored a then NHL record 44 goals as a rookie, breaking the record of 38 set by Perreault the year before. Perreault and Martin teamed with Rene Robert to form the famous "French Connection" line which swashbuckled their way in the NHL during the 1970's. Martin played for the Sabres for 10 years, tallying 695 points in 681 games along with 53 points in 63 playoff games.

Martin was an electrifying goal scorer and was he NHL's premier left winger in the 1970's. He created many memories for the fans and helped too establish the expansion Sabres as a solid franchise. On April 7th 1974, Martin scored three goals as the Sabres defeated the St. Louis Blues 5-2 at the Aud in Buffalo. Rick Martin led the way with three goals to become the first player in franchise history to score 50 goals in a season.


He had some memorable performances in the annual NHL all star game. On January 25th 1977, Martin scored two goals in the 3rd period of the 30th NHL All Star Game including the game winner with 1:56 re-

maining. He led the Wales Conference all stars in a 4-3 victory over the Campbell Conference all stars earning MVP honors. Marcel Dionne assisted on both of Martin's goals. The game was played in Vancouver's Pacific Coliseum.

The next season in Buffalo the Sabres hosted the NHL all star game at the Memorial Auditorium on January 24th 1978. Gilbert Perreault and Rick Martin, played for the Wales Conference. Both players

delighted their hometown fans by scoring with Martin tying the game with 1:39 remaining in regulation time and Perreault scoring the game winning goal 3:55 into overtime to defeat the Campbell Conference 3-2.

Rico suffered a career ending knee injury against the Washington Capitals when goaltender Mike Palmateer charged him and tripped him while on a breakaway. Following surgery to repair his knee, Martin was traded along with Don Luce to the Los Angeles Kings for two draft choices. One of those picks was used to draft Tom Barrasso. Martin played only four regular season games with the Kings over two seasons before he was forced to retire due to his injury. Martin picked up six points in those four games.

**August 3, 2020**



# Northwest Buffalo Beat

## When the dog bites, when the bee stings.

The horrendous pandemic this year that has forced us to do something we did not do so much other years. Eat outdoors more than ever. We are fortunate that his summer has been a good one weather wise for doing just that. It has been warm and sunny with pleasant evenings. Restaurants have adapted to this new demand by constructing huge tents, adding patio space, picnic tables, umbrellas, and whatever it takes to bring clients to their establishments.

We have a small dog, so we look for places that have pet friendly outdoor seating. There are enough around this area but nowhere near as many as there are in Florida. That is ok as we understand not all people accept having an animal where they dine. So it is limited but those that do are usually really nice about it and start by bringing a little dish of water for

the canine. Being as we are older and with a slightly disabled wife we have preferred to enjoy the outdoors more than other years.

Restaurant dining could be expensive so we have found a delightful alternative. Buy take out, which is the other Pandemic spinoff, and eat at a park by the water. Not the best nutritional thing to do but it is quick and easy. We have ordered a pizza, subs, hamburgers, fried chicken, hot dogs, and whatever we can pick up on the way. So far we have hit most of the parks by the water, Isle View, Fort Niagara, Olcott, Wilson, Evangola just to name a few. And of course dog friendly if on a lease. It has in that way been a great year and that is not counting the backyard bar-b-ques.

My one son is allergic and swells up if stung. I once had the experience of getting stung by dozens of bees at once. They are not to be messed around with, I found that out.

We had a nest located in the crack in the concrete right in the middle of the garage door opening. Had to walk through them if you entered that way. Took some time but I slowly proceeded to carefully seal the crack little by little. The yellow jackets swarmed around me every day but did not bother me. Eventually it was sealed and they went away. Not so in the firewood pile out back. Hav-

ing been successful with the first hive, I thought I was an expert with getting rid of bees.

Seeing a few dozen flying around the outside of the firewood pile, figured this was going to be a piece of cake. No problem getting rid of these pests as I know what I am doing. Not! As I walked close and moved one piece of log, about a hundred angry, nasty, yellow jackets surrounded me almost immediately. Stinging away with reckless abandonment. I went running and screaming as I was receiving dozens of bee stings and they hurt. I did not want to go into the house as I thought they would follow me in. Fortunately the further you get away from the nest; they are less

likely to follow. When I was sure they were gone I went inside in complete agony. My arms, my legs, and the worst was the top of my head. Now what do I do? Call 911? No, what can they do. So we called Landmark for advice. Baking soda pastes is the best treatment and take a couple of Tylenol. It was a horrible night, but I was okay in a couple of days. Good enough to get my revenge. Took a couple of weeks and determination, with respect, they departed my wood pile. Those that survived. I learned my lesson and want no part of them anymore. So happy that so far, with all this outdoor dining, bees have not been a problem. Doesn't that seem a little strange? Kind of a needed blessing.



## Ask Rusty- Can My Mother Get Benefits from Common Law Marriage?

**Dear Rusty:** My 71-year-old mother has a very small Social Security income. It is not enough to find her housing. I am working to file for increased VA benefits, as she is a veteran. Her partner of 21 years (common law spouse) has passed away, and we have an appointment next week to apply for spousal benefits. First question: We have the option of applying for her partner's SS benefits, and we are completing the form SSA-753 statement regarding marriage. Is there anything else I should have to be prepared for the appointment? Second question: My mother and father were married for 27 years before they divorced. I was going to request filing for his benefits as it is easier to prove than a common law relationship. Is there anything else you could recommend being

prepared for the appointment? Signed: Concerned Daughter

**Dear Concerned Daughter:** Whether your mother will be able to collect a survivor benefit from her "common law" spouse will depend upon the state in which their relationship was established. Social Security's rules specify that for their relationship to be recognized as a "marriage" for Social Security benefit purposes, it must have been established in a U.S. State which recognizes "common law" marriage. And only a small number of U.S. states currently do.

For clarity, it is only required that the relationship be established in a State which recognizes "common law" marriage. If their relationship started in a state which recognizes it, and they subsequently moved to and resided in another

state which doesn't, SS will recognize that relationship as a valid marriage and your mother will be entitled to survivor benefits based upon the deceased's SS record (100% of the deceased's benefit amount).

States which currently recognize "common law" marriage are Colorado, Iowa, Kansas, Montana, New Hampshire, South Carolina, Texas, and Utah, plus the District of Columbia. A number of other States previously recognized common law marriage but have since stopped doing so. If the relationship was established in a state which, at the time, recognized common law marriage, Social Security will also recognize the marriage. Various U.S. states have, over the years, changed their laws regarding common law marriage, and Social Security will evaluate your mother's eligibility for survivor benefits based upon where and when the common law relationship was established. They will be looking for proof of the marriage relationship, such as joint bank account statements, joint asset ownership records (e.g., a car registered in both names, joint home ownership, etc.) and it

would be good to have multiple forms of such proof available. They may also require a copy of the death certificate for her common law spouse and, obviously, his Social Security number.

Regarding your mother's other alternative for benefits from her marriage to your father, if your mother and father were married for 27 years, she may be eligible for a spousal benefit from your father as his ex-spouse. If your father is still living, and if she isn't eligible for an SS survivor benefit from her common law relationship (SS doesn't recognize her common law marriage), your mother may still be eligible for as much as 50% of what your father's SS benefit

was at his full retirement age (FRA), plus any COLA increases given since his benefits started. Spouse benefits from a living ex-spouse are not as much as the survivor benefit from a current spouse – the survivor benefit is up to 100% of what the deceased spouse was receiving at death; the benefit from a living ex-spouse is up to 50% of the ex-spouse's FRA benefit amount (if that is more than your mother is eligible for on her own SS record). Of course, if your father is deceased, your mother would be eligible for a survivor benefit on his record, which would be equal to 100% of the benefit amount your father was receiving at his death.


