## How to Vote Safely

If you plan ahead you can protect your health while doing your part to keep democracy alive.

Mask wearing can go a long way toward mitigating coronavirus risk at the polls. Never mind the usual Election Day hurdles: finding a parking spot at your voting site, waiting in line. This year, the pandemic has made voting for president trickier by several orders of magnitude.

With COVID-19 infection rates rising in many states, mailing in your ballot instead of voting in person may sound like the safest move, at least from a health standpoint. But if the political heat around mail-in ballots has you wondering if voting in person is the best way to make your voice heard, how do you do it safely?

you plan ahead can protect your health while doing your part in the democratic process. Here are the questions to consider before you make your decision.

Voting at the polls during the pandemic is similar to other public activities, like shopping in a supermarket, that keep you indoors surrounded by other people for a certain period of time.

It really helps to benchmark the risks against other risks you accept daily. We are all pretty com-fortable getting into cars, but cars are quite dangerous. So, remind yourself that there are risks you accept every day, as long as it's worth it. COVID-19 is scary, but so is no longer living in a democracy.

Assess Your Local COVID-19 Situation. In evaluating the safest way to vote, you might want to consider the COVID-19 positivity rate in your area and the percentage of coronavirus tests that come back positive. The higher the number, the greater the odds of coronavirus exposure at a public place like a polling site.

## Reinhart, Ullmark Sign and Avoid Arbitration

With arbitration hearings pending for three Sabres free agents, Sam Reinhart and Linus Ullmark opted to sign one year contracts. This avoids the often contentious atmosphere of arbitration where each side prsents their position with the team arguing to diminish the players value. This process has created some bad experiences for players so it's no surprise that the vast majority of players sign contracts and avoid the that negative atmosphere.

Reinhart signed for \$5.2 million. This was an increase over the \$3.7 million he earned last season but below his estimated arbitration award of \$6+ million. This works for the team because their available cap space was only \$13.625 million and saving a million dollars here helps ease the strain on the cap. For the player he is expecting a good season back on the top line with Jack Eichel where he could be expected t score 25 goals and 65 points. This would b put Reinhart in a good position for a multi year con-tract paying \$6.5-7 million. The risk he takes is that if he gets slotted playing on a second line with Eric Stahl and Jeff Skinner he would

not get the offensive opportunities that Eichel creates and 50 points is more likely in that second line role.

Ullmark accepted a deal for \$2.6 million. The Sabres had offered \$1.8 million while the player had been seeking \$4.1 million. Ullmark was sidelined for 18 games last season with an ankle injury. This hampered his ability to present a strong argument for a higher salary. Ullmark needs to establish himself as a player capable of playing 60 games in order to be paid at the \$4 million level. And the Sabres need him to play 60 games relegating Carter Hutton to a backup role.

These two signings leave the Sabres with just under \$6.6 million in cap room available and an arbitration hearing scheduled for November 4th for their lone RFA remaining, Victor Olafsson.

Because the NHL has frozen it's salary cap at \$81.5 million players have less incentive to sign long term deals heading into next season. So another one year deal is expected for Olaffson.

with other measures like social distancing and hand hygiene, can go a long way toward mitigating this risk. In states that require face coverings, the possibility of coronavirus exposure at polling sites will be lessened, especially if those requirements are followed and enforced.

Currently, 33 states plus Washington, DC, and Puerto Rico require face coverings by state order. But keep in mind that in some places the state orders are being contested and overturned in court. Vote in person before election day if you can. Getting to the polls before November 3 might give you the best possible chance of finding shorter lines and a quicker, safer overall process.

Most states are offering early in-person voting before Election Day. Check your local election guidelines for the locations, dates, and times when polls will be open for early voting.

The states that will not offer early in-person voting are Alabama, Connecticut, Delaware, Iowa, Maine, Michigan, Mississippi, Missouri, Montana, New Hampshire, New Jersey, Pennsylvania, South Carolina, South Dakota, Vermont, and Wyoming.

Instead, those states are offering absentee voting in-person, so you can still hand-deliver your ballot but avoid long lines.

In some states, certain counties may offer early voting in person if they opt to do so. Those states currently include Arizona, Idaho, Illinois, New Mexico, North Dakota, Texas, and Wisconsin. Check with your local election office for the latest updates and details on your county. Vote early in the day on November 3 to avoid crowds. In response to the pandemic, some states are consolidating polling locations or directing people to countywide voting centers instead of neighborhood polling sites. This has the potential to cause long lines and crowds.

Crowding in poorly ventilated indoor spaces poses the greatest coronavirus hazard. As you cycle more and more people through an environment, and as we come to believe that aerosols pose a risk, when a lot of people are coming through in a short amount of time, there's not a guar-antee that you will avoid COVID transmission even if you're trying to stay socially distanced and wear a mask. In states where there are few opportunities to vote and where a large portion of people have to show up in the district over a short period of time, those are the most risky.

Going to the voting site early in the day can be one way to reduce risk, and to give yourself more flexibility. "Maybe try to go early in the morning, so if you find a long line you might have the luxury to go back later in the day. Your best bet is to show up at a time when you can find crowd levels of a density like you'd find in a supermarket.

What extra safety precautions can you take when you go to vote? It bears repeating that in any situation, you can lower your coronavirus risk by keeping your mask on, social distancing, and maintaining hand hygiene, cleaning your hands before touching your eyes, nose, or mouth, or after touching a door knob or anything else other people frequently handle. But there are a few special strategies you may want to employ when voting: Be antisocial.When you're standing in line avoid talking to other people. Bring headphones instead. If you're just standing there wearing a mask and not talking, you won't be sharing any droplets.

Be diplomatic while you're standing in line use common sense and pay attention to what's around you. If someone is creeping up on you, ask them to go ahead of you. You don't want someone breathing down your neck, and you don't want to start a fight.

Leave the kids at home. Try not to bring young children if possible. Kids will get restless and start wandering around. Pack a few supplies. If you're going to be in line for four hours, or if it could be raining, you might want to bring a second mask in case the first one gets wet or soiled or if you're having allergy problems.

Bring your own hand sanitizer and use it as soon as you vote, and after you've had to go through some doors, and again after you leave, just as you would after shopping. And bring your own pen so you don't have to worry about theirs.

In case you're waiting for a while and might need a snack, bring something that comes wrapped, like a granola bar, nothing you'd have to feed to yourself with your bare hands.

Lastly exercise your right. Many people are struggling to exercise their right to vote, and we don't want unfounded fear to preclude the vote that you would likely cast. Think about it rationally. There are a lot of yahoos who will do anything to take away our right to vote.

## Ask Rusty - Will My Social Security **Benefits Ever Stop?**

Dear Rusty: Has some-one who paid into Social Security for most of their life ever lost their benefits later in life? For example. if they start collecting benefits at age 62 and live to be 85 or longer, could they suddenly lose their benefits? Can Social Security ever come along later and say "Sorry, you've used up all your benefits?" I know there are many people, including me, who have no other income or savings, so if their SS suddenly stopped they would need assistance to survive. I started my benefits at age 62 because I had to. I've always been in reasonably good health, so I wonder - what if I live to be 85, 90 or 95 - will I still have enough in the system to get my Social Security check? Signed: Living on SS

**Dear Living:** Please put your fears about losing your Social Security aside

– you will never stop receiving your benefits even if you live to be 110 years old. The system isn't designed to compare what you've collected to how much you've contributed. If you meet the basic eligibenefits. So, the benefits you are now receiving are not being deducted from a personal account in your name. Everyone currently working and contributing to Social Security helps pay for your benefits, as well as benefits for everyone else already collecting. Any money left over after all benefits are paid are invested in special issue government bonds, which are held in the Social Security Trust Funds, earning interest which accrues into the Trust Funds. Money from income taxes on Social Se-

curity also contributes to SS revenue to pay for benefits. As of the end of 2019, the Social Security Trust Funds held about \$2.9 trillion in assets, reserved to cover any shortage of SS income received vs. benefits paid out.

If the Trust Funds are fully depleted, Social Security can only pay out as much as the income received, which would mean a benefit reduction of about 21%, according to current predictions. Sadly, Congress already knows how to fix Social Security's finan-

cial issues - what's lacking is the bipartisan cooperation needed to accomplish it. Personally, I do not believe that Congress will ever allow the Trust Funds to run dry, requiring a cut in benefits (it would be political suicide to do so). Given the vitriol permeating Congress today we'll probably need to wait a while for a solution, but one will eventually come. In any case, please rest assured that your Social Security benefits will never stop, no matter how old you get. You can't "use up all your benefits.'

Adults like to dress up. Proof of this can be seen on our Buffalo Rocket Archives Facebook page. I put dozens of pictures of past Halloween parades that were held in North Buffalo over the years. You will see adults as well as the kiddies in costumes. The best are the home made ones. If you were ever in a North Buffalo Halloween parade, you may be in there.

Growing up on the West Side of Buffalo, the Halloween parades were massive. I recall one on Grant Street that had 300 children marching. Then after the parade these kids would go out "tricks or treating" into the neigh-borhood. One thing better today than it was then is the tricks. What these little darlings did as a trick was apply wax to the windows of a store that was closed. They would throw eggs at a house if it was dark. The day after Halloween was clean up day. Know how hard it is to clean a window loaded with wax. It does not wash off. Fortunately they later changed to bars of soap for marking windows.

Having eight children, Halloween was a big day for us. My kids would come home from tricks or treating with a bag full of candy. They used shopping bags that would be so full they had to come home and dump some out and return to the streets. We used to get so many little monsters at our house that one year we ran out of candy and had to use the children's loot from their rounds to supplement our extin-guished supply. No eggs on our house.

Since we had eight children, it was not possible to afford commercial costumes. Hence they were all

hand made. The most popular and most used by everyone was a hobo. Old clothes and a little charcoal on the face was all that was needed. Being that my wife was creative our costumes were unique. The one I liked most was Snow White and the seven dwarfs. Hard to describe so I have inserted a picture to show the work that went into it. We only had seven children at the time and she was dressed as Snow White. Now you may wonder where Prince Charming is. He is taking the picture and did not even have to dress up. Everyone in the room knew I was "Prince Charming"!

## Things You Didn't Know About Daylight Saving Time

No, it wasn't started to help farmers. In fact, according to National Geographic, farmers had a lobby that campaigned aggressively against Daylight Saving Time. That's because it gave them one less hour in the sunlight to send their crops to market. To this day, many farmers don't like it, especially because cows like to be milked on a schedule and moving the clocks disrupts that. Farmers in the U.S. lobbied successfully to stop Daylight Saving Time after World War I, and it wouldn't go back into effect until the next world war.

It started in Europe. Time reports that in 1907, William Willet wrote a book called The Waste of Day-light, arguing for a Day-light Saving Time. "The sun shines upon the land for several hours each day while we are asleep," he wrote, but there "remains only a brief spell of declining daylight in which to spend the short period of leisure at our disposal." Willet lobbied Parliament for the change, saying it would increase people's enjoyment of sunlight and also save money

on fuel, but it wasn't passed there until after his death. People think it may help

conserve energy. Between January 1974 and April 1975, the entire country went on daylight saving time year-round to combat the energy crisis. And in 2005, Congress passed a law that extended Daylight Saving Time by a month to keep energy costs down. But the Washington Post reports that a study found that it really only saves a tiny fraction of our electric bills at best, especially since if you stay indoors, you're more likely to run your air conditioning.

It's more recent than you think. Benjamin Franklin is credited with coming up with the idea in 1784, and Germany was the first country to try it out in 1916. President Woodrow Wilson first made it law in 1918, but it was repealed seven months later, the Chicago Tribune reports. President Franklin D. Roosevelt relaunched it in 1942, the time change wasn't official until 1966, when President Lyndon Johnson signed a law to make the start and end dates of Daylight Saving Time uniform across the country.

Not everyone observes it. Arizona (except for the Navajo Nation), Hawaii, Puerto Rico, American Samoa, the Northern Marianas, and the U.S. Virgin Islands don't recognize Daylight Saving Time. Parts of Indiana didn't as well until it was adopted statewide in 2006. Several state legislatures have tried to abandon the time change in recent years. And around the world, only 70 countries actually observe it, according to CNN.

It might be bad for your health. According to The Atlantic, the time shift might be detrimental to people who suffer from seasonal affective disorder, a depression that kicks in when the seasons change. That's because it changes your sleep cycle, and it turns out that change could even be linked to higher risks of heart attacks, car accidents, and even malfunctioning medical equipment.But it could cut down on crime. Popular Mechanics reports that Daylight Saving Time has been shown to reduce robberies, as they tend to happen more under the cover of darkness. With more light, there are likely fewer threats
