Winter Parking Restrictions Postponed

The City will offer free parking at metered spaces on Black Friday, November 24th, to encourage holiday shopping downtown and citywide

With no snow in the long-range forecast, Mayor Byron W. Brown announced postponement of Winter Parking Restrictions on Metro Bus routes until Dec. 1. This marks the second postponement


of the seasonal parking rules, which by statute, are in effect from November 15 through April 1, each year.

"We've had some frosty days and nights, but so far no measurable snow in the City of Buffalo. Based on the long-term forecast from the National Weather Service, there's no snow in sight, so the Winter Parking Restrictions on bus routes will remain sus-


pended until Dec. 1," Mayor Brown said.

When Winter Parking Restrictions are in effect, parking is banned on bus routes in the City of Buffalo between the hours of 1:30 a.m. and 7 a.m. to clear the path for snow plowing and salting. Earlier this month, the Mayor announced the restrictions would be postponed until November 22nd.




In spite of it all, hopefully we will all have a great day and are still around next year to really have a day to be thankful for. Happy Thanksgiving!
