
tary® Curriculum Art Contest for children 5-12 years of age begins today. Children are asked to draw, paint, color or sketch ocean creatures or ocean

Kearns Announces Extension for Driver Licenses and Permits

Erie County Clerk Michael P. Kearns announced that per Executive Order the Governor has extended the expiration dates on all New York State driver licenses and permits amid the ongoing COVID-19 pandemic.

Motorists will now have until January 1, 2021 to renew either document which includes all classes of licenses. However, this extension does not pertain to non-driver identification cards or vehicle registrations which needed to be renewed by November 3, 2020.



NHL 2021 Season Ready to Start? Maybe Not

With much fanfare the national hockey media have carried forth the news that the NHL owners and Players Association (NHL-PA) have resolved their financial issues and such as players salaries held in escrow and are ready to charge ahead into a shortened season on January 16th.

Under terms of the collective bargaining agreement, owners and players divide hockey related revenue 50-50 each season. If player salaries are greater than 50% then a percentage is withheld in escrow. After the season, total revenue is calculated, and if the league is not at its 50% share, the difference is paid out of the players escrow funds. Any money left over is returned to the players. Since this agreement went into effect in 2013, the players have always owed escrow money

to the owners at the end of the season.

In 2013-14, the first full season under the current collective bargaining agreement, 14.7 percent of the players' salaries was withheld, and at the end of the season, the players got 3.8 percent back, a loss of 10.9 percent of salaries. For 2021 the NHLPA and NHL agreed to a 20 percent escrow with a salary deferral of no more than 10 percent. That has been the basis of reporting that all of the financial issues have been settled and that the season is ready to commence on January 16th. Not so fast.

The biggest issue of all has not yet been addressed, prorated player salaries. The proposed schedule of 56 games is 68% of the normal 82 game season. The players are adamant that they be paid 100% of their salaries, less the escrow.

The league can use a force majeure clause, a common clause in contracts that essentially frees both parties from liability or obligation when an extraordinary event or circumstance beyond the control of the parties, such as a war or a global pandemic, to force unfavorable terms upon the players - such as prorated salaries. The NHL could also use Paragraph 17 of the Standard Player's Contract or Article 5 of the CBA, both of which deal with the league's ability to cease or suspend play and dictate the terms of the season

But the players believe that the league lost significant negotiating power with it's players over the last two weeks when the NBA obtained \$900 million at discount interest rates from the private financial markets for distribution its teams. Each team will receive \$30 million to cover lost revenues and cover costs related to the covid19 pandemic. The NHL hasn't discussed this type of fi-nancial move. The players feel that their negotiating posture has been strengthened by the NBA's actions.

While these issues can be resolved in the short term, this story is far from over.

Ask Rusty - Will My U.K. Pension **Affect My Social Security?**

Dear Rusty: I lived and worked in the United Kingdom prior to coming to the US at age 45, which qualified me for a UK State Pension worth the equivalent of about \$740 US dollars per month. Since moving to the US I have contributed to the US Social Security system for 14 years and my estimated UŠ Social Security benefit is \$1,643 per

month. I have heard about something called "WEP" and must be honest and say I don't fully understand. Can you provide some advice or references so I can understand what happens to these sums when I retire? I don't have any other pension income, so understanding these numbers is important. FYI, I hold both US and UK passports and will retire in the USA. Signed: Blessed from the

Dear Blessed: The "WEP" provision you refer to is known as the "Windfall Elimination Provision. It affects anyone who is eligible to collect Social Security benefits, but who also has a pension from another entity (corporation, public agency, or foreign country) which did not participate in the U.S. Social Security program (meaning that SS FICA payroll taxes weren't paid during that employment). WEP will reduce your US Social Security benefit by using a special formula to compute your benefit amount. Generally, the WEP reduction is determined either by the number of years of substantial SS-covered earnings that you have, or the WEP maximums (one of which is that your U.S. Social Security can't be reduced by more than half of your non-covered pension). With less than 20 years paying into the US system, you will incur one of the maximum WEP reductions.

Something else important to understand is that

the current estimate you have from Social Security doesn't include the WEP reduction. That estimate assumes that you will continue to earn at your current level until you reach your full retirement age. You haven't shared your birthdate, but from your email I assume you are now about 60 years old. If you were born in 1959, your full retirement age (FRA) for U.S. Social Security purposes is 66 years and 10 months (if you were born after that your FRA is 67, and if you were born before that subtract 2 months for each year prior to 1959). Your FRA is when you will get your "full" SS benefit. If you claim before that (age 62 is the earliest you can claim) your benefit will be reduced (even before WEP), and if you wait beyond your FRA you'll earn Delayed Retirement Credits (DRCs) which will increase your benefit amount. DRCs stop at age 70.


Based upon what you've told me, I believe that your WEP reduction will probably be limited to one of the maximums, either half of your monthly U.K. pension, or the maximum for your "eligibility year" (2022?). We don't yet know what the standard maximum WEP reduction for 2022 will be, but for 2020 it is \$480. That is the most that your Social Security benefit could normally be reduced. But if your U.K. pension is about \$740 USD then your maximum reduction should be about \$370, because the WEP reduction can't be more than half of your non-covered (U.K.) pension. So, your US Social Security benefit of \$1643 will most likely be reduced by about \$370 to about \$1303. You will need to contact the UK pension system to see if any of your UK pension will be offset by your US Social Security benefits.

The point I want to make is how great those first years were. Going into each and every establishment in the area and meeting all the merchants. These were mostly family businesses and the founders or fathers were there then. me with a big smile hello. Back across the street to talk to my two buddies Bob and John Hazlet, who have advertised in the Rocket almost since the beginning and are still there. Both men had their wives and children working the pizzeria at one time or another. John's son Tom is still the owner.

Hertel and Norwalk the Barone brothers at Barone furniture, When I called on Tom Passanisi his dad was always there along with his sister Connie and brother, Domenic. A place converted from a frozen pizza factory into a bar and dealing with the elder Tom Lombardo and his son Tommy to make it one of North Buffalo's finer restaurants. Bill Blatner had the Sunoco station on Hertel and Colvin with his two sons. Sammy's Market on Hertel near Colvin with Sam Cerolla and his two sons.

I just mentioned some of the people I called on back in the day. I loved doing it. Met so many wonder full hard working business people and this is without mentioning Delaware Avenue. Mr. Shab's, Scime's Market, Frank's Sunny




The Passanisi Family back when I used to call on them. Elder Mr. Passanisi on the left with his wife. Tom, Christina and smiley Dominik.
