## Christmas Celebrations

Our North Buffalo parishes will be celebrating the Feast of Christmas with our normal schedule of Christmas Masses, with all health and safety protocols in place as mandated by state, county, and diocese regulations. Also, new this year, Holy Spirit has added video and audio connections from the church upstairs to the church hall downstairs, thus enabling the Mass as it is celebrated upstairs in the church to now be also live-streamed to the large screen downstairs in the church hall, where Eucharistic Ministers will also bring Communion. This innovation allows more people to come to Mass (both

upstairs and downstairs) while at the same time respecting social distancing requirements. Wearing of face masks is required, as it is in all public gatherings. ## Buffalo Bills are Number One Contender

Following the Buffalo Bills 26-15 victory over the 11-1 Pittsburgh Steelers on national TV Sunday night, their second consecutive impressive win on national prime time TV, the national media have now jumped on the Bills bandwagon. Most relevant websites have the Bills seeded as the number two team in the NFL behind the Kansas City Chiefs. Some have Green Bay as number two with the the Bills third. Mike Greenberg of ESPN has anointed the Bills as the team most likely to beat the Chiefs.

The Bills dismantled the Steelers vaunted pass defense and pass rush in a dominating second half performance. The first half was a defensive slug fest with the Steelers pass rush dominating as defensive tackle Cameron Heyward constantly got into the Bills backfield frustrating quarterback Josh Allen and limiting the Bills offense to three points. But the play of the game came when Slot cornerback Taron Johnson picked off Steelers QB Ben Roethlisberger late in the half, giving the Bills a 9-7 lead at halftime.

In the third quarter the Bills showed their resilience making adjustments that allowed them to take control of the game. Heyward was double teamed and Offensive Coordinator Brain Dabol had Allen making quicker throws, often on the run out of the pocket. This resulted in touchdown scoring drives on their first two possessions.

Stefon Diggs dominated the Steelers with 130 yards receiving on 10 catches. He leads the NFL with 100 catches which also tied Andre Reed for the team record. Allen was very impressive on both drive, especially the pass to Davis

in the corner of the end zone after looking off the safety and faking a pass with a pronounced shoulder shrug.

The Buffalo defense dominated Pittsburgh in the second half, with Matt Milano sacking Roethlisberger for the first time in 257 pass attempts. The Bills limited their offense to only 224 yards. Steelers leading rusher James Conner gains only 18 yards on 10 carries with 1 yard in the second half.

After Levi Wallace intercepted Roethlisberger with seven minutes remaining the Bills ran out the clock to seal the win. A sign of Buffalo's dominance was that the Steelers finished the game with a timeout left over which they didn't use to stop the clock while the Bills ran out the game. It's as if the Bills strong performance had sucked the will to win from the Steelers.

**Fun Fact:** The Bills are the only NFL team with 20 first downs in every game this season.



## Ask Rusty - Should a Working Widow Claim Now or Wait?

*Dear Rusty: My husband died 13 years ago at age 50. I am now 64, never remarried, and work full time making a healthy income. I have never claimed any of his benefits. What are my best options? Signed: Working Widow*

**Dear Working Widow:** You have several options available as both a widow and a worker entitled to your own Social Security benefit.

1. You could collect a reduced survivor benefit (only) from your deceased husband and allow your own SS benefit to grow to a larger amount. At age 70, your own benefit will be about 29% more than it will be at your full retirement age, or FRA, which is 66 years and 4 months (your own benefit stops growing at age 70). If you take your survivor benefit now, since you are claiming it before you reach your FRA it will

be reduced by about 11% from the amount your husband was eligible to receive at his death. But at your FRA your survivor benefit would reach the maximum of 100% of what your husband was eligible for at his death.

2. If your survivor benefit from your husband at your FRA will be more than your own benefit will be at age 70, you should strive to maximize your survivor benefit by waiting until your FRA to claim it. You can find out what your survivor benefit will be by contacting Social Security. They can also tell you what your age 70 benefit will be, but you can get that too by creating your "My Social Security" account, which is easy to do at [www.ssa.gov/myaccount](http://www.ssa.gov/myaccount).

3. If your own benefit at age 70 will be your highest benefit, you should strive to maximize your

personal benefit by claiming your survivor benefit (only) first, as described in 1. above, and delaying the claim for your own benefits until age 70.

So, what is your best option, considering the above? Well, if your earnings from work are substantially more than the annual earnings limit, you may find that you will not receive any benefits, even if you were to claim. That's because they will "take back" benefits by withholding your future Social Security payments until they recover what you owe. For example, if your annual earnings are \$60,000, you would exceed the limit by about \$41,000, which would mean you would need to repay them \$20,500. If your monthly SS benefit was about \$1500 (about average), they would withhold benefits for about 14 months to recover what you owe, meaning you wouldn't be getting any SS benefits while you were earning that much money. Thus, you may find your best option right now is to wait until your FRA to claim any Social Security benefits.






**With Erie County in the orange zone, restaurants can no longer offer indoor dining while other nearby counties can still have indoor dining with restrictions.**
