Armed Forces Week 2021



Armed Forces Week is a celebration of the days coming up to Armed Forces Day (the third Saturday of every May). For American service citizens, Armed Forces Week is an time to recall all times of service for all branches of the service. It is the consolidation of a single remembrance.

On Armed Forces Dav itself, the combination of all the events of Armed Forces Week is represented, which can begin as early as the second Saturday of May and ends the following Saturday with the observance of Armed Forces Day. There are many ways military communities observe Armed Forces

In addition to what has already been described above, there are base-level gatherings including parades, military aircraft "flyovers" and air shows, luncheons, and fitness or health themed events. Oftentimes there will be an Armed Forces Week theme with specific events

planned for each day of the week.

Since Armed Forces Week does not result in federal installations closing, many military bases may offer extended access to the public including the viewing of "static displays" of aircraft or other military hardware on base.

This year, Armed Forces Day is celebrated on May 15, the third Saturday of the month.

Providence Farm Puts Down Roots in Orchard Park

Committed to empowering autonomy and ownership among its 300 immigrant, refugee and Black farmers, Providence Farm Collective (PFC) makes

transformational move to ensure secure, longland term tenure for its farm communi-

ties this spring with the help of a generous supporter.

In its 2020 inaugural year, amidst a pandemic, eight unique communities came together as Providence Farm Collective on leased land in East Aurora, NY, to grow 23,000 pounds of nutrient-dense fresh, and culturally relevant produce on 8.5 acres of converted horse pasture. Although 90% of PFC's farmer participants have farming experi-

ence and multi-generational agrarian roots in their home countries, its farmers experience fresh food insecurity with few means of producing or

accessing healthy, affordable foods important to their traditions in the City of Buffalo. This

past season, elders and parents were able to share their farm and culinary heritage with over 120 youth in their families and communities through PFC's summer education and employment opportunities. Over 2,200 individuals in Erie and Niagara Counties' USDA food deserts accessed the produce grown at Providence Farm.

When Is the Best Time to Claim Social Security? - Ask Rusty

Dear Rusty: I will be 64 in May of this year, and I'd like to know the best time to claim Social Security. Signed: Anxious to Retire

Dear Anxious: First, please understand that there is no one "best time" to claim your Social Security benefit, because when you should claim depends upon several factors, such as:

- Your current health
- Your life expectancy
- Your immediate financial need
- Whether you are married
- Whether you are still working

When you should claim also depends upon your personal benefit goals. For example, if you wish to maximize your monthly SS benefit amount you can best do that by simply waiting until age 70 to claim. For each full year you delay past your full retirement age (FRA), your SS benefit will grow by 8%, up to age 70 when you get the maximum you're entitled to. If you are married and die first, that will also provide your widow with a higher benefit as your survivor if your wife's own benefit is less than yours. But waiting until age 70 to maximize isn't for everyone.

If you are in poor health and don't expect to enjoy at least average longevity (about 84 for a man your age now), then claiming earlier would be prudent. But claiming earlier also means a smaller benefit. Your full retirement age (FRA) is when you get 100% of the benefit you've earned from a lifetime of working. Your FRA is 66 ½ and if you wait longer than that you will earn Delayed Retirement Credits (DŘCs) of .667% for each full month you delay. That means that if you delay until 70, your ŠS benefit will be 28% more than it would be at your FRA. But if you claim before you have reached your FRA, your benefit amount will be permanently reduced by .556% for each full month earlier than your FRA that you claim. If, for example, you claim your SS to start at age 64, your benefit will be cut by about 17% from what you'd get by waiting

until your FRA to claim. And, if you are married, that smaller benefit is what your widow's survivor benefit would be based upon if you die first.

Anytime SS benefits are claimed before you have reached your full retirement age, you are subject to Social Security's "earnings test" which, if you are working, limits how much you can earn before SS takes back some of your benefits. For 2021, the annual earnings limit is \$18,960 and if that is exceeded, they will take back benefits equal to \$1 for every \$2 you are over the limit. The earnings test applies until you reach your FRA, after which there is no longer a limit to how much you can earn. In your specific situation, if

you were to claim for your benefits to start mid-year (e.g., in May at age 64), you would be subject to a monthly earnings limit of \$1,580 for the remaining months of 2021, and if you exceed that monthly limit in any month, you won't be entitled to any benefits for that month. Then in 2022 you'll be subject to the annual limit, which isn't yet published but will be slightly more than the 2021 limit.

Exceeding the earnings limit means that Social Security will make you repay some of your benefits and, unless you make special arrangements to do otherwise, they will withhold future benefits until they recover what you owe. That means going without benefits for some months, and if you have a spouse or other dependent(s) collecting on your record their benefits will also be suspended for that amount of time. So, as you can see there is no one simple answer to your question of when the best time is to claim Social Security. But a careful look at your personal circumstances relative to the above information should help you make that decision.

I welcomed the invitation and began sticking around. This tall blond girl directly across the street had a swing glider on her porch that was more comfortable than the stairs. Yes, like my girlfriend, whose house I could see right across the street, this blond and me would also sit and talk. However this girl did not have any inhibitions. It happened one night. She happened to be more than willing and seemed experienced in the art of kissing. She did not have teeth braces. Needless to say I relented. I thought to myself I will just confess it next Saturday night at the confessional. So I went into it with a full head of steam. Surprisingly, I was all too willing. Surprising-

I do not recall if I ever
