

# Happy Father's Day



Father's Day for the year 2021 is celebrated/observed on Sunday, June 20th.

It took more than 60 years from the birth of the idea to Father's Day actually being recognized as a federal holiday, but a lot happened to threaten the parent-celebrating holidays during that time. In the 1920s and 1930s, there was a national movement to get rid of both Mother's and Father's Day and re-

place them with one "Parent's Day." Beyond that, some men didn't even want a Father's Day to begin with. The Great Depression and World War II, however, helped boost the idea of Father's Day. Struggling retailers pushed the gift-giving holiday during the Depression, and during

the war, Father's Day became a war to honor the many fathers serving overseas. By the time President Nixon signed the proclamation making Father's Day a holiday, it was already a national institution. Father's Day is observed on the third Sunday of June. It honors all fathers, throughout time.

## Works, from Home, a Mural Project from the Albright-Knox Public Art Initiative

In April 2020, the Albright-Knox's Public Art Initiative asked sixteen local artists to respond to the initial lockdown requirements of the pandemic. To build community spirit, the museum sent artmaking materials to these artists at their home studios, and they worked to produce a

sixteen-piece collaborative mural. The mural, now located at 43 West Chippewa Street, speaks to individual and collective experiences of the pandemic. The Public Art Initiative assembled small kits containing mural supplies from the museum's inventory, including pre-cut sections of a

material called Polytab and UV resistant acrylic paints. Polytab can be adhered to a wall using a clear acrylic gel, creating a resilient mural. The Public Art Initiative has previously used this method in the creation of Betsy Casañas's mural *Patria, Será Porque Quisiera Que Vuelas, Que Sigue Siendo Tuyo Mi Vuelo* (Homeland, Perhaps It Is Because I Wish to See You Fly, That My Flight Continues to Be Yours), 2017, on Niagara Street and Welcome Wall, 2017, by Keir Johnston and Eriel Martinez on Fillmore Avenue. ## "Just Buffalo" Art Project

Just Buffalo Literary Center invites Western New Yorkers of all ages to submit short pieces of poetry or prose on "the power of words to move you" for an upcoming public art project in collaboration with the Niagara Frontier Transportation Authority (NFTA). The deadline for submissions is June 30.

"Just Buffalo's public art projects create opportunities to discover and connect with literature in unexpected ways," said Barbara Cole, Just Buffalo's Artistic Director. Recent LIT CITY projects include a series of banners along Buffalo's Literary Corridor on Washington Avenue honoring the region's notable writers; the ongoing installation of spray-chalked poems on city sidewalks; and Lit City Voices, a series of video poems highlighting local writers. The league schedules close to 25 games on a Saturday, hoping for beautiful sunshine, but not all are treated to the Star Spangled Banner.

It's almost 9:30 am on a Saturday morning and Shoshone Park is quiet. The Sun has been shining brightly in the sky for almost three hours. Teams have gathered at various diamonds, getting ready to play the first games.

Suddenly, a voice comes over a loudspeaker, welcoming all to Shoshone Park. He politely asks all players to stop throwing a baseball or swinging a bat. He tells us of our police and fire units, our first responders and the Military. Then he introduces us to a man who sings our National Anthem. With the observance of Flag Day this past Monday and the fourth of July less than

a month away, the Hertel North Park Youth Baseball League delivers youth sports to thousands of boys and girls for generations in North Buffalo, just like the Pro's do Downtown at Sahlen Field.

The Cardinals won their first game of the year Tuesday night, June 8 after suffering a winless streak of eight games. Jubilation was next after relief pitcher Trevor McDuffie welcomed all teammates to the mound after an 8-3 win over the Mets. Charlie Duggan ended the game nicely with a double play in the infield and Ryan Gogola had three hits and drove in two runs at the plate. Other Cardinal

players like Jack Guarino, Jonathan Green, Adrian Butera or Oscar Barry will try to turn their season around.

In other Major Boys games, the Reds defeated the Dodgers, 9-4. The Cubs topped the Nationals, 6-1 and the Braves defeated the Giants, 11-7 under the lights. Baron Nieves hit a two run homerun and teammate Tim Gannon pitched three scoreless innings for the win.

In Triple AAA games, Jeremiah Cash and Linus Ward both homered to lead the first place Mariners to a win over the Royals. The White Sox topped the Yankees and the Tigers defeated the Blue Jays, 9-6. The Marlins picked up their first win of the season, a 5-4 victory over the Brewers and the Pirates gave the Cardinals their first loss of the season, a 2-1 decision on an RBI single by Joseph Marie.

In Rookie Boys, the Red Sox picked up their first win of the season over the Twins, 2-1, getting big hits from Michael LoTempio and Wes Polster. The Angels have won two in a row, including last Thursday nights, 2-0 shutout of the Mariners. Hunter Gallagher homered while teammates Alexander Mann and Max Capaccio had big hits and played well at first base to go to 6-2 on the season. The Royals lead the division with an undefeated 7-0 record.



## Why Did Social Security Ask My Mother This Question? – Ask Rusty

**Dear Rusty:** When my father passed away and we went to update my mother's Social Security benefits, a question arose that I was confused by. We were asked "Do you want to claim just your father's benefit (which was larger) or claim my mother's benefit and the difference between the two?" Either way it would come to the same amount. Is there a reason to claim one way over the other? Perhaps a caveat that we are unaware of? Is there a loophole that we are missing that may potentially benefit the survivor? We are soon to face this question again as my father-in-law is very ill. **Signed: Curious**

**Dear Curious:** Well, they are basically the same amount but there is a nuance in the rules that many survivors aren't aware of. Here's why Social Security asked that question:

It is possible for a surviving spouse to claim only the survivor benefit and defer claiming their own SS benefit until a later age if their personal benefit would be more than the survivor benefit would be. A survivor

benefit reaches maximum at the survivor's full retirement age, but their personal SS benefit can grow until they are 70 years old. Thus, claiming the survivor benefit (only) first, and allowing their personal benefit to grow up to age 70 is often a wise move. Doing so allows someone to collect survivor benefits upon becoming a widow(er), while still maximizing their personal benefit. When later claimed, the higher personal benefit will replace the smaller survivor benefit. Of course, this option only makes sense if one's personal benefit would later be more than their survivor benefit.

Social Security is required to ask this question because the person may be eligible for a higher benefit on their own if they wait until a later age to claim it, but the "survivor benefit only" option is useful only if the survivor has not yet reached 70 years of age. After age 70 they would always take whichever benefit is higher. In most cases SS pays the person's own benefit first and then a "boost" to bring the payment up to the higher amount due as a survivor. But the choice to claim the

survivor benefit only is an option if the survivor has not yet reached 70 and if their own benefit could later be more than their survivor benefit.

So, the question is – which option did your mother choose? And is your mother-in-law under age 70? If your mother's own benefit at age 70 would not have been higher than her survivor benefit from your father, then it doesn't matter which way it was recorded. And if your mother-in-law is over age 70, it doesn't matter either. But if not and either personal benefit at age 70 would be more than their earlier survivor benefit, then opting for the survivor benefit only and waiting to claim their own later would be (or have been) a better choice. With SS, you can easily do so at this link: [www.ssa.gov/myaccount](http://www.ssa.gov/myaccount).

So, the bottom line is this: If you have contributed to U.S. Social Security from "substantial" earnings for at least 30 years, your Social Security benefit will not be affected by your U.K. pension; if you have less than 30 years of contributions to SS, it will. As you may know, you cannot collect your U.S. Social Security until you are at least age 62, but if you claim at that age your benefit amount will be reduced by 30%. You'll reach your full retirement age at age 67, and that is the point at which you will get 100% of what you've earned by working in the U.S. – subject to WEP reduction only if you have less than 30 years of contributions to Social Security.

## Northwest Buffalo Beat

### Avenue Soda Bar

Recently on social media someone mentioned the Avenue Soda Bar. The place that once was a favorite Ice cream stop for those longing for a trip to an exotic delight. Located on Delaware near Tacoma it was famous for its large concoctions of mouth watering treats. The comments were mostly about the first owner who was fondly known as Ed, the man who always wore a white tee shirt. He was there for over thirty years before he passed away in the mid-eighties. The place was art deco and kept that look till the very end. Wire ice cream chairs with small round tables and an au-

thentic Soda Bar right out of the middle of the 20th century. What was also special is they made their very own ice cream. Two huge ice cream machines and a blast freezer to convert the soft mixture into frozen delights. A total of thirteen unusual flavors and one just as good as the other.

A little bit of history for those who have been around long enough to remember. When I purchased the building 2497-2507 Delaware in 1980, it had as tenants the Avenue flower shop, my print shop in the middle, and the Avenue Soda Bar on the end. Next to this building was Mr. Shab's pizzeria, and a formidable ice cream competitor, the Alco Bar. Which was also a candy store. Blatner's Automotive was on the corner of Delaware and Tacoma. They bought the building the Alco Bar was in and turned it into a garage. The Alco bar moved across the street. Eventually Frank's Sunny Italy

bought Mr. Shabs and then Blatners and now have that whole corner. They also own the parking lot across the street. The building that was there and demolished, once held La Nova pizza.

After Ed had passed away, his son took over the business. Not really knowing anything about the ice cream business, I became interested as its location was in my building. We worked out a purchase, but it had to include the girl who worked there, Debbie Russell. She was receptive and willing to see the continuation of what had been established over the years. She knew how to run the ice cream making machine, work the counter, and make all the thirteen assorted flavors the Avenue became noted for. The Soda Bar was also the home of exclusively named treats. Starting with the "Monster", served in a flower vase, thirteen scoops of ice cream with every different available topping. topped with whipped cream and a cherry. A few were able to eat it all, but most shared with a partner. It was beautiful at first, and very colorful. Most who tried to finish it, would give up. Their eyes were bigger than their bellies. When this mixture was about half gone it turned gray and not very appealing.

Then there was the ever popular "Pigs Dinner" served in a wooden trough. Four scoops of ice cream of your choice and four toppings. Even this was big for a dessert. The traditional Banana boat served in a glass boat had the three normal flavors, Vanilla, chocolate, and strawberry. Then the standard Sundae and Sodas. Personally, I liked the ice cream as it came out of the ice cream maker. It was soft before freezing, creamy and fresh. One of the few things I did there was taste the assorted flavors as they came out of the machine. Terrible job but someone had to do it.

The soft ice cream had to go into a large metal container for the blast freezer, frozen, then used for scooping. The rest were set into pint and quart boxes to sell retail. Pictured are the ice cream sandwiches that were a good seller. The Soda bar did very well in the summer months and at times had customers waiting outside to get in. Especially on a sweltering day. Unfortunately, there are too few of those hot days in Buffalo. Ice Cream is not exceedingly popular in the winter, and we have a long one here.

After a couple of non-profitable years, and trying everything possible to keep

it alive, it was time to put the Soda Bar to rest. Have to say it was an adventure owning an ice cream shop. That may have been where I gained twenty pounds. It was fun, the people were mostly fun and in good spirits. Almost no complaints and we would see the same customers returning year after year. Feeling is that if you were ever in the Avenue Soda Bar, it was a most happy time for you. Everyone loves ice cream.
