Joe Mccarthy And The Angels!

This season of the Hertel North Park Youth Baseball League will not only be remembered for its bounce back year from the dreaded Covid-19 Pandemic. It will also be the time of record breaking registration numbers of over 1,000 boys and girls signed up to play baseball and softball in Shoshone Park.

The tiny Park, located on Hertel Avenue near Main Street with seven perfectly laid out diamonds for children to play the game was the place to be in North Buffalo since early May this year every night during the week and practically all day Saturdays. But this season the League had help for the first time since its earliest beginnings.

Not far from the home of Hertel North Park sits another tiny Park on the other side of Main Street. Named after the legendary former Manager of the New York Yankees, Joseph V. McCarthy, five more beautiful diamonds were able to be used this season for Hertel North Park League games. Just like a clutch hit at home plate with the bases loaded in the bottom of the ninth, it couldn't have come at a better time.

For the first time this season, a ten year old like Oliver Scott or any other ten year old boy playing in the Triple AAA Division of house baseball, was able to stand at home plate in McCarthy Park and swing a bat while looking at a high school football stadium like All-

High between pitches after 6:00 pm on a week-night.

With over 125 ten year old boys registered to play in the Triple AAA division, ten teams were formed and got a chance to travel over to McCarthy Park at least twice during the season. On the night we were there, the Blue Jays defeated the Angels, 6-3 and the Tigers roared over the Athletics. Brayden Goodberry and Ayano Silverman each homered for the Blue Jays to lead the way. Three Tigers, Isaiah Cormack, P.J. Doyle and Blake Pereira blasted homeruns against the A's.

Near home plate, a small sculpture sits along a pathway connecting all diamonds. It reads: "A man whose knowledge

of Baseball and dedication to sportsmanship has been an inspiration to the youth of America." Dedicated August 5, 1979 to "Marse" Joe McCarthy who led the New York Yankees to seven World Series titles in 1932, 1936, 1937, 1938, 1939, 1941 and 1943. A member of the Baseball Hall Of Fame in 1957, McCarthy made his home in Niagara Falls, upon his retirement from the game and will forever be remembered for connecting this area to what most people feel as the greatest baseball team ever.

The Angels won the Championship in the Triple AAA Division, defeating the Mariners in two straight games to end their great season. They were led by Ethan Brolinski, Vince Farley, Greyson Gordon, Luis Guzman, Parker Kresse, Jordyn Lara, Seamus Mahoney, Vince Majchrzak, Shane McGillicuddy, Easton Ramos, William Ramsdell, Mark Robertson and George Rudzinski.

Does Paying SS Tax Now Increase My Benefit? – Ask Rusty

Dear Rusty: I started drawing my benefits at age 62 due to being laid off from my job at age 60. I have continued working part-time and been paying Social Security and Medicare taxes ever since. I am now 66. I have been told that even though I continue to pay these taxes, it will not help increase my monthly social security benefit. Is that true? **Signed: Working Beneficiary**

Dear Working Beneficiary: Paying Social Security and Medicare through “FICA” taxes withheld from your paycheck doesn’t change your Social Security (SS) benefit amount. Those taxes aren’t held in a separate personal account for you; rather, they are used to pay benefits to all those who currently collect SS benefits and help offset healthcare costs for current Medicare enrollees.

From its inception decades ago, Social Security has been a “pay as you go” system where all those working help pay for those currently collecting benefits. And if you happen to work even after you start collecting Social Security benefits, the FICA tax you pay still goes to help pay benefits for you and for millions of others also collecting Social Security.

Of the 7.65% FICA tax you pay, 6.2% goes to Social Security, and 1.45% helps fund Medicare (your employer pays the same amounts). The 6.2% SS tax you pay to Social Security isn’t deposited into a personal account which determines your benefit pay-

ment. Instead, your benefit is determined using your earnings record for the 35 years over your lifetime in which you earned the most (with early years adjusted for inflation). Your average earnings in those 35 years are what determines your benefit amount, not how much you paid in FICA tax. Thus, continuing to pay FICA taxes because you are still working won’t affect your Social Security benefit amount. And because of the way the program is structured, you don’t need to worry about how much you contributed to Social Security in taxes; you will continue to receive Social Security for as long as there are people working and contributing to the program (for the rest of your life) – those now working pay for Social Security benefits now being paid.

What could, however, affect your personal SS benefit amount now is your earnings level while working. Even after you start collecting Social Security benefits, if your current earnings from work are more than any of those in the 35 inflation-adjusted years used to originally compute your benefit, that benefit will be recomputed and increased as appropriate. And just in case you’re wondering, studies have shown that, on average, SS beneficiaries usually recover everything they paid into the system within about five years. Said another way, over your lifetime, you’ll almost certainly get back much more in benefits than you paid in FICA SS taxes. The pay-back time is more for those who are self-employed (because they must pay both employee and employer portions of FICA), but Social Security is, nevertheless, a pretty good deal which pays a guaranteed retirement benefit for as long as you live after benefits start.

So what you were told is correct. Paying FICA taxes now won’t help increase your monthly benefit amount. But high earnings now, which are more than any in those 35 inflation-adjusted years used to compute your SS benefit, will.

I can still picture what they all looked like when we would spend the day there. Sally with her flaming red hair. Handsome buddy and my favorite, "Fats".

Aunt Dot always made pies and we looked forward to her fresh, still hot out of the oven, apple and cherry offerings. When we visited in those days, the older siblings had moved on and the ones that were there were the younger seven or eight. Since all that lived there back then are gone, I think the possibility of my finding where that farm was is also gone, sadly. Still, it is one of the great things about life, we have our memories. We can go back to anywhere and anyplace, even if it is

just in our minds. We can relive wonderful times we have had as many times as we want. Even if it is just in our minds. We can re-visit friends and family who are no longer with us, even if it is just in our minds. We thank our creator that we can do that as it is one of the joys of living, our memories.
