### Safety Tips For Backyard Grilling

Grilling is a popular way to enjoy the nice summer weather, but grill fires can start easily and spread quickly when the gas or charcoal grill is placed too close to any fire hazards. Learn how you can help keep your home and family safe by following our grill safety tips.

1. Only use grills outside. It may be tempting to set up your barbecue grill inside of your open garage or under a covered balcony, but propane and gas, charcoal grills are strictly designed for outdoor use where there is plenty of ventilation. Any combustible materials that surround or hang over the grill when it's in use can catch fire easily and quickly. Make sure that the area over top and around your grill is clear and un-

obstructed.

2. Place your grill away from your home

Barbecue grills are often placed just outside the back door or on the back deck against a railing.

You should avoid placing your grill in these areas because it can pose a potential fire hazard.

Grills that are placed too close to the house or other wood structures can heat up adjacent materials and cause a fire to start. Be sure to keep your grill at least 10 feet from your home or other structures.

3. Make sure your grill is located on a flat, level surface

Grills that are placed on slopes or other uneven surfaces can tip over easily and cause a fire. Make

### Outdoor Swimming Pools Will Not Open This Summer Due To Lifeguard Shortage



**The National Lifeguard Association and American Red Cross estimate between one-third and one-half of pools and beaches across the U.S. will remain closed this summer due to the on-going lifeguard shortage.**

The City of Buffalo's nine outdoor swimming pools will remain closed this summer due to the shortage of certified lifeguards, which is impacting pools and beaches across the nation, and here

in Western New York. The Buffalo Common Council to raise lifeguard pay to \$20 an hour, from the current \$16 an hour, in an effort to retain and attract additional lifeguards.

"The decision to not open our outdoor pools this summer came down to the safety and welfare of our residents," Mayor Brown said.

Starting in January, the City engaged in multiple efforts to attract, train and hire certified lifeguards, knowing it would be impacted by the national, regional and local lifeguard shortage. Locally, the City of Niagara Falls and the Town of West Seneca will keep pools shuttered this summer. The Cities of Rochester and Syracuse have announced at least half of municipal pools and beaches will be closed due to lifeguard staffing issues.

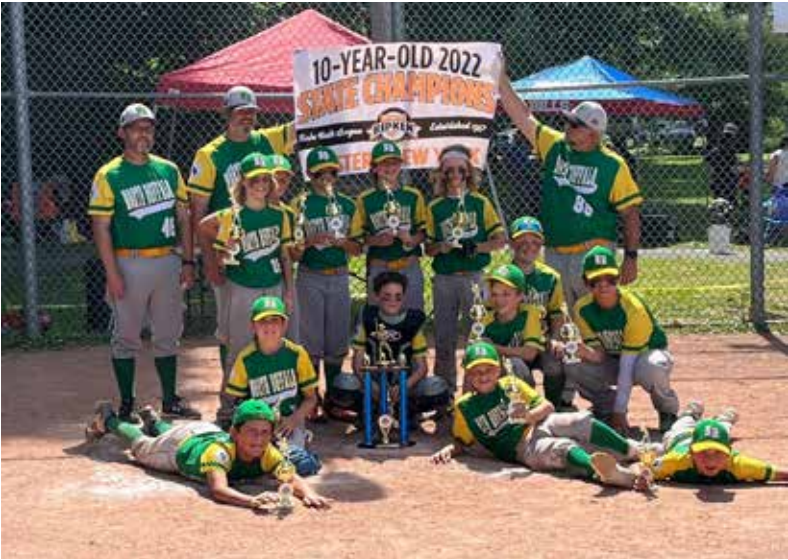

In front of thousands of Bisons fans ready for a win and Friday Night Fireworks, Lundquist yelled "PLAY BALL!" into a microphone down on the field with the Triple AAA team after the National Anthems on a beautiful Night for Baseball in Downtown Buffalo.

For twelve consecutive seasons now, the 8U Blaze Travel Team has been a part of the Bisons' Dream Team Program where North Buffalo Boys experience Baseball up-close thanks to Jim Daley, the Hertel North Park Travel Director and manager of the 8U team. This year, as many as 25 excited North Buffalo Boys, clad in their green and gold jerseys and baseball caps were on the diamond, behind home plate, waiting for their names to be called from the

public address announcer above them.

Down 4-3 in the eighth inning, the Bisons battled the Saints, the Triple AAA affiliate of the Minnesota Twins, the North Buffalo Blaze team was consistently shown on the Bisons Scoreboard as never giving up hope for a Buffalo victory as the game progressed into the night. The crowd erupted along with the Blaze after the winning hit that scored the go-ahead run.

"This was a great night for the Bisons, but an even

greater night for North Buffalo," said one parent afterward. Just then, the fireworks started and Downtown Buffalo was hot for the Bisons.

This past weekend, North Buffalo and Shoshone Park hosted the 10U State Championships for Babe Ruth League Baseball. Playing against GLO Academy from nearby Wyoming County, the Blaze team needed two victories in the best of three Finals to advance to the Regionals. Linus Ward pitched a perfect game in just three innings against nine batters and teammate Paul Rubino hit a three run homerun over the fence for a 15-0 victory. Ask Rusty – I’m Getting Spouse Benefits – What Happens to My Own?

**Dear Rusty:** I was born in late 1951. When I retired 5 years ago, I was made aware that my own Social Security benefit was less than half of my husband’s SS Benefit. So, I chose to take half of his. What happens to my undisposed SS dollars? On the off chance the balance increases beyond the amount I am now collecting, can I eventually switch to my own full SS amount? **Signed: Curious Senior**

**Dear Curious Senior:** Much depends on exactly how you claimed your SS benefits five years ago and your age when you claimed. Because you were born in 1951, if you had reached your full retirement age (FRA) of 66 when you claimed SS five years ago and your husband was already collecting his benefits, you had the option to file a “restricted application for spousal benefits only” which would have enabled you to collect only your spouse benefit while letting your own benefit continue to grow. But if you were not yet 66 when you claimed, the “restricted application”

wasn’t available to you, so you are now receiving your own benefit plus an additional amount to bring your payment to your spousal amount.

I expect that the latter is the case (that you didn’t file a “restricted application”), which would mean that your current payment amount consists of two parts – your personal benefit (from your own lifetime work record) plus a “spousal boost” to bring your payment to your spousal entitlement. Except for the restricted application, Social Security always pays your own benefit amount first and then supplements your own benefit with an additional amount to give you what you’re entitled to as a spouse. Thus, your personal benefits aren’t “undisposed” – you’re already getting them, plus a spousal supplement.

Just to complete the picture, if you did file a “restricted application” at age 66, then your own benefit continued to grow until you were 70 (at which point it reached maximum). The growth

amount would have been 8% per year additional benefit, so at age 70 your own benefit would have been 32% more than your FRA amount. If you know what your own FRA benefit amount was, then increase that by 32% to see if your own amount is now higher and, if so, contact Social Security to apply for your own higher benefit.

If you don’t know what your personal FRA amount was and/or are uncertain if you filed a restricted application, you’ll need to contact Social Security directly to see if you’re entitled to any additional amount based on your own lifetime work record. You can contact Social Security at either the national center (1.800.772.1213) or

at your local office (find the number at [www.ssa.gov/locator](http://www.ssa.gov/locator)). If you are currently getting spouse benefits only under a restricted application and your personal benefit is now higher, since you’ll soon be 71 you should request six months of retroactive benefits when you switch from the restricted application to your own benefit.

It is no wonder that Einstein said time is a fourth dimension. Life as we know it could not exist without time. One thing we all wonder is, how much time do we

have left before we go to the timeless zone? That is something we want to know but really do not want to know. What is that timeless zone like? If it is motionless what fun would that be? To stand around and do nothing all day. Whoops, there are no days. I do know some people who do that now. They are good at it. Do nothing to make their existence worthwhile. They would fit right in with the motionless do-nothing crowd. Just kidding. All I know is it is time to end this column. See, there is an end.

You can also search "Erie County Board of Elections" or "New York State Board of Elections." Both government websites contain similar information.

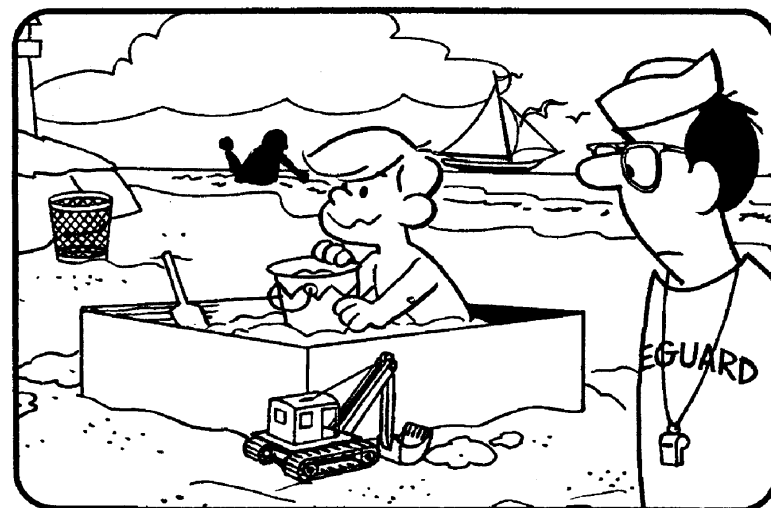
An educated voter is an empowered voter. It is our civic duty to vote and cast an educated ballot for the candidate of our choosing.

As for my mom, it was an honor to drive her to her polling place to vote for her son. At least I hope she did.

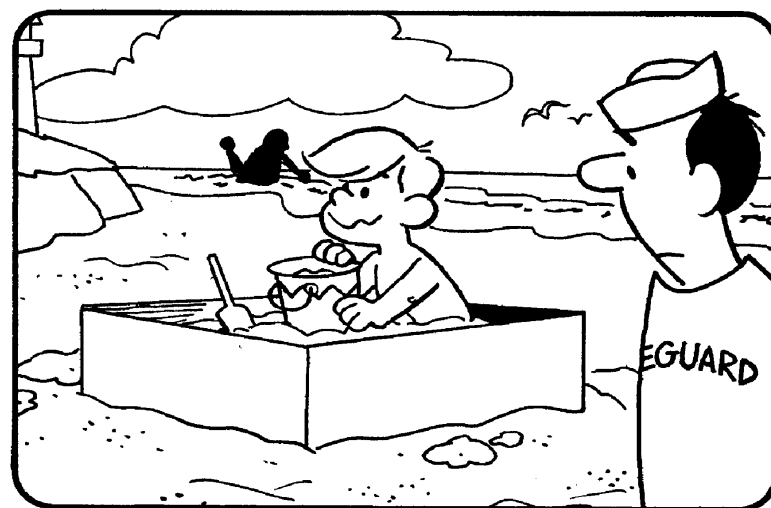

# Safety Tips For Backyard Grilling

*Continued from page one.* sure that your grill is set up on a stable surface such as a concrete pad so that it remains level while cooking food.

4. Always clean your grill after use

Barbecuing regularly causes grease to build-up on the grill plates and collect inside the grease tray. If not cleaned, the build-up can then act as fuel and catch fire while the grill is in use. Clean your charcoal or gas grill after each use with a grill brush and empty the grease tray when it begins to fill up.

5. Never leave your barbecue grill unattended while in use

Never leave the grill unattended while you are cook-

ing food. You should never walk away from your barbecue while it's in use. Barbecues use high heat and open flames to cook food, and when left unattended can become a safety and fire hazard. If you must leave the grill, ask another adult to watch the grill for you.

6. Wear appropriate clothing

Articles of clothing that have long sleeves or pieces that dangle can catch fire easily when too close to an open flame. If a piece of clothing does catch fire, remember to stop, drop, and roll to extinguish the flames quickly.

7. Keep a spray bottle on hand

It's common for grills to flare up as fat drips from meat as it cooks, and this can

cause a section of the grill to remain on fire as it burns away. If left alone, the flames will continue to burn and cause excess smoke to billow out from under the lid. Keep a spray bottle filled with water beside your grill so that you can quickly extinguish smaller flames before they spread.

8. Always have a fire extinguisher close by

In the event that a fire does break out, follow these tips on and ensure you have EZ Fire Spray within reach. It is simple to use, just point and spray to extinguish the fire.

Following these charcoal and gas grill safety tips and having the right protection will help you and your family enjoy a safe grilling season all summer long.
