the Mission's annual operating budget. It funds the resources necessary to sustain the year-round programs and services that the Mission provides to the poor and homeless in our community.

## Buffalo Bills Fans Donation KC

Buffalo Bills quarterback Josh Allen is being talked about as an early season MVP of the NFL. He's on pace to throw for close to 6,000 yards and 50 touchdowns.

Before we start talking about Bills fans watching one of the greatest ever, let's focus on great Allen and #BillsMafia news.

First, Zoom Buffalo jokingly renamed Hertel Avenue in North Buffalo "Hurdle" Avenue in honor of Allen's soaring jump over Chief's defender Justin Reid.

In addition to placing a temporary sticker renaming the roadway "Hurdle Avenue," a jumbo cutout of the game photo itself was placed above the street sign at Hertel and Wellington.

It's a nice reminder of how the Bills and Allen are energizing fans in ways we haven't seen since their Super Bowl appearances.

Second, #BillsMafia is showing its heart in helping others across the country. Last season the Chiefs took 13-seconds to score against the Bills, force overtime, and eventually beat the Bills in January's playoff

**Ask Rusty – How Do I Get My Social Security As Soon As Possible?**  
*Dear Rusty: I am a 61st birthday in November 2022. I was wondering*

*how far in advance of my 62nd birthday next year should I file my Social Security benefits paperwork in order to get my first check the same month I turn 62? I usually work a part time job during the winter months – but that job fell through this fall 2022. So, I do not want to waste any time getting that first check arriving the minute I turn 62 in November 2023. I don't want to take any chances*

*of delays in starting my Social Security retirement benefits since I am currently not working.*  
**Signed: Ready to Retire Soon**  
**Dear Ready to Retire:** Unless you were born on November 1st or 2nd, you will first become eligible for Social Security in December of 2023. That's because you must be 62 for the entire month before you can get Social Security for that month.

If you were born on either the 1st or 2nd of November, then November 2023 will be your first month of eligibility and your first payment will be received in December. But if you turn 62 after November 2nd, your first month of eligibility will be December 2023 and your first payment will be received in January 2024 (Social Security pays benefits in the month following the month they are earned).
