The Blotter Felonies

North Buffalo November 6, 2022

Hertel Avenue - Defendant did show up to complainant's house unwelcome. He did get out of his car, said "B*tch, I'll clap you", and pulled a handgun from his pocket and pointed it at her. He did leave the scene and arresting officers did stop defendant at Gibson and Broadway. Defendants actions put complainant in fear for her life. Patrol officers approved arrest.

November 1, 2022

Hertel Avenue – On 10/23/2022, defendant failed to exercise reasonable diligence in such control of her juvenile son at which time her juvenile son was found to be out of her care placing the juvenile in substantial risk while possessing stolen vehicle(s) all throughout the early morning 4-5am, her juvenile son was observed on video footage at 7-11 located 2078 Niagara Street continuing his Criminal Acts by using unauthorized Credit Cards attempting to buy various items. The defendants' son could be observed entering and exiting the store with no parental control at anytime during the incident.

November 4, 2022 Delaware Avenue - Sus-

pect was arrested for a larceny upon search of suspects property at cell block, suspects property did have 2 sublingual films at 8mg of Naloxone. Not in original container. Suspect did not have a prescription anywhere in his property.

West Side November 5, 2022

Elmwood Avenue – On the above date, time, and location and suspect pushed victim to the ground causing her to hit her head on the fridge causing a small laceration on the top of her head.

November 5, 2022

West Ferry Street - Officers did investigate defendants suspicious activity at above address. Defendant did admit to using crack cocaine and upon search officers did discover a crack pipe on person right jacket pocket crack pipe and did have a white residue.

November 4, 2022

Elmwood Avenue - While officers were responding to a call of threats harassment, officers did find a vehicle matching the description is suspended and upon inventory search of vehicle in plain view was a black handgun loaded with 10 9mm rounds in magazine; Glock 19.

November 2, 2022

Bird Avenue - While landlord (complainant) had a maintenance man at the apartment the defendant did become irate. Landlord then did call police and while police were on scene defendant did threaten to punch the landlord.

Once inside the defendant took 4 bags Burgundy bag with makeup (\$100.00), a blue bag with Bank of America credit/debit card and cash app card (\$300.00), a black bag with \$300.00 cash (bag - \$30.00) and a brown grocery bag with \$30.00 in merchandise. Defendant identified at Delta District by victim. After search suspect did have 2 bag of Naloxone not in original container.

November 1, 2022

Tonawanda Street - Officer responded to a call at Tonawanda Street at Roesch Avenue, patrol officer did observe a strong odor of alcohol and red glassy eyes on defendant. Patrol officer also observed multiple open containers of alcohol in the New York registered vehicle which was operated by the defendant. Further investigation showed the defendant's licensed to be revoked. Breath test performed by arresting officers. Defendant blew .16% BAC.



ment age (FRA), which is 66 years and 8 months. But I also heard that full widow benefits for those born in 1958 are available at 66 years and 4 months. Which is correct?

Then I heard that her getting 100% of my social security is NOT the case because I started social security at 70. I heard this is because widow benefits are based on my benefit at my full retirement age. So, will my wife get 100% of my Social Security if she starts it at her FRÅ, or will she get my smaller FRA amount?

My wife is now getting spousal benefits and I also heard that for those getting

spousal benefits, Social Security automatically changes that to widow benefits when the other spouse passes. If I die before my wife reaches her FRA, can she tell Social Security to NOT give her widow benefits at that time? Can she wait until she is at her FRA and then start widow benefits to get 100% of mine? Signed: Concerned Husband

Dear Concerned: I'll be happy to clear all this up for you. There are two "full retirement age" numbers which will be in effect for your wife if you pass first -1) her "normal" full retirement age (FRA), and 2) her "widow's full retirement age."

Your wife's "normal FRA" is 66 years and 8 months and that is when her personal SS retirement benefit can be claimed without reduction, and when she will no longer be subject to Social Security's earnings test if she is still working. Your wife's "widow's FRA' is determined by subtracting two years from her birth year and the FRA number for that year becomes her "widows FRA," which is the age at which she becomes eligible for unreduced survivor benefits. In your wife's case her "widow's FRA" is 4 months earlier than her normal FRA, or 66 years and 4 months.



On a whim because I was off the beaten path for my print shop, to say the least, I decided to print a slinger advertising my service. Tacoma in North Buffalo is not the most traveled avenue and to start a business there is a pig in the poke. Four months after opening the doors at old 277 it became

obvious that the print shop needed help. Had a young fellow, Rich Briandi, who used to hang around the shop go up and down Hertel to see if anyone wanted to print their business card on an advertisement piece I was doing. Would be delivered door to door in the neighborhood. Got enough to

make it fly. Did it once a month for the next six. It was the birth of the Rocket. In the seventies it became a weekly tabloid with neighborhood stories and pictures,

The original slingers were delivered by my children. Started out with three thousand. When we went to a weekly newspaper, it was up to 10,000. We needed help in delivering these puppies. Placed an advertisement in my publication looking for delivery people. Had to be 12 years or older, male or female. Back then the dailies had only paper boys. This opened it up for the girls to make a few pennies. Established routes of approximately 500 papers to make them doable for these young

Pay was one cent per paper delivered. Does not sound like a lot but remember, no collecting and one day a week. Deliver on Wednesday, get paid on Thursday. No problem getting people to be Rocket deliverers. Even had some adults. Was fun having these dozens of little workers coming in to get their pay at our place on Tacoma. Cash on the barrelhead. Had Rocket delivery people for ten years from 1970 to 1980. Had many families, some

two or three or even four at the same time.

Zengers had the most. Boyds, Shamrocks, Mattars, Ostrowskis, had at least three. Cannot recall them all but some stick out in my mind as they lasted for years. Some members of the same family would pass the route down to the younger siblings. Needless to say, I became friends with my extended families.

Like all young people there were those that were outstanding others who were not. Hated to get calls telling me tied bundles of Rockets were laying by the rail-road tracks. Used to be a problem trying to find who the culprit was till we started marking the bundles. What easier way was it to make five bucks than to say you delivered and not do it. It was fortunate for us that the paper was popular, and people would call if they did not get it. We did know who was and who was not doing their job. One time I even witnessed one of our delivery people stuffing the Rockets down a sewer. When I confronted him, he said they were extras. The rule was you delivered till you were out. Circulation and distribution in the beginning were tough but it got us off our feet.

In 1980 we bought the West Side Times and with it came the Professional delivery service, City News Distributors. It was termination time for my little people. Sad that I had to let them go. I did miss the teasing of them in our meetings on pay day. Met so many good kids over those 10 years. Still run into them now and again even 50 years later. They do not look the same and it is almost impossible to know who they are when they approach. It is nice that they do remember me and the good old days. Even had one invite me to dinner as some of my former delivery people were in town. Thought it would be nice to reminisce with the old boss. I really appreciated the invite from the Mattars who I believe had routes in the Wallace area. Yes, "Hurt in a car, Mattar", was one of the families that did deliver the Rocket. There were four or five of them.

Nice memories of those days and those kids. The Rocket was more of a neighborhood item with our local delivery gang. Just hope those days remain as pleasant to them as they are to me.


