New Citywide Position Of Fleet Director

Mayor Brown announced he is seeking to bring a new role, a Fleet Director, to his administration. Mayor Brown and Commissioner of Administration, Finance, Policy and Urban Affairs Delano

Dowell have already filed the necessary Budget and Personnel Amendment to create the position. While the Depart-ment of Public Works,

the Buffalo Police Depar ment, and the Buffalo Fire Department all have fleet managers, those individual roles serve to oversee and maintain the various, specialized vehicles and equipment in each department. The Mayor's Fleet Director will be a central, omnibus figure to cross-coordinate the fleets within Buffalo to respond to emergencies.

'As we all saw in the Buffalo Blizzard, powerful storms are pushing equipment to the maximum. Our vehicles, our partners' vehicles, utility crews' equip-

THE CITY OF B ent were all working in full force to repair Buffalo, with as many as 600 pieces of machinery on the roads. An incoming Fleet Director will provide crucial oversight on available

vehicles and equipment, as well as work to bolster our city-owned assets," said Mayor Brown.

The Fleet Director will be an exempt appointment to spearhead Buffalo's preparation for regular city maintenance as well as emergency situations. This will include performing a full inventory of all equipment, across departments, including existing purchases of equipment in production. Also the Fleet Director will review and assess new advances in technology, in order to build a robust line-up of supplies within the City of Buffalo.



Damar Hamlin, Buffalo Bills

When watching the Buffalo Bills game live, whether it be in person as a fan or on Monday night football, the collision at the 36-yard line did not at first glance appear to be a life-threatening hit. Replays told a much different story,

As the Bills cornerback lay motionless on the turf before a national audience, ESPN color commentator Dan Orlovsky communicated the seriousness of the situation following the traumatic injury. "That's scary," said the former quarterback who played 12 seasons in the NFL. A cart and ambulance immediately took the field for the inevitable drive to a Level One trauma center.

This was Week 2 of the early NFL season. Highmark Stadium. Buffalo Bills hosting the Tennessee Titans. The injured player, Dane Jackson, eventually recovered from the vicious hit that snapped his head back. Jackson not only survived, he returned to the Buffalo Bills lineup and practiced nine days after his scary injury witnessed by the entire country.

Shortly after that sobering moment, friend and teammate Damar Hamlin spoke to "One Bills Live" television hosts Chris Brown and Steve Tasker about the power of prayer and the fragility of life. How in one split second, everything can change.

"I cherish it (life) every second that I can. Every second, of every day. We just had our prayer, our DB (defensive backs) prayer that we do every Wednesday. He (Jackson) was next to me, and I grabbed his hand just a little bit harder. You never know if your last day could be that," said Jackson's close friend Hamlin, who was also a teammate at the University of Pittsburgh. Little did Hamlin know that months later, he would be the one in dire need of prayer to save his life after suffering a horrific medical emergency on Monday Night Football.

Fast forward from the second game of the season to the second to last game of the year,

Approximately 105 days later, it was Week 17 when the world was stunned by the moments after Hamlin himself made what appeared to be an average tackle in a football game.

After taking down Cincinnati wide receiver Tee Higgins, Hamlin, the second-year safety, rose to his feet, barely made contact with the right shoulder of Bengals halfback Joe Mixon, then collapsed backwards at approximately 8:55 PM.

Stunned players sobbed. They prayed. It was all they could do as doctors and paramedics frantically performed CPR to save Hamlin's life. We now know he suffered cardiac arrest.

Every city with an NFL team has a designated Level One Trauma Center where teams of surgeons are available 24/7 to save the life of a player who may have suffered a life threatening injury. Nineteen minutes after he collapsed with doctors frantically trying to resuscitate Hamlin, he was rushed to University of Cincinnati Medical Center.

Regardless of who made the decision, it was the absolute right call to cancel the game. I'm surprised it took the NFL almost one hour to come to that sensible conclusion. Can you imagine being at your job, when a close co-worker suffers a heart attack right next to you, paramedics work to save your friend's life before your very eyes in the office, then your boss comes in and demands you finish out your shift for the rest of the work day?

NFL officials claim that was never under consideration, despite ESPN announcers stating players were given a five minute warm-up to resume play.

The "game" is insignificant. So is home field advantage, AFC standings, playoff position, or whether or not the Bills-Bengals game will even be replayed.

Every single ounce of energy must remain focused on the health and well-being of Damar Hamlin.

What followed the devastating collapse of Hamlin should restore all of our collective faith in humanity.

Players of both teams passionately and fervently prayed together, in the same way Hamlin did for his teammate Jackson when he went down with an injury on the gridiron. Folks in the stands quickly made makeshift signs that stated "Pray For Hamlin."

Some Bengals and Bills fans left the stadium and met at the hospital for a candle-light vigil for Hamlin, where they too gathered as one to pray for his recovery.

Prior to his collapse and cardiac arrest, Hamlin posted a "GoFundMe" fundraiser to buy Christmas presents for kids in his native Pittsburgh with a goal of raising a mere \$2,500. #BillsMafia and football fans flooded the site with donations, which now totals in the millions of dollars.

Jill Kelly, wife of Buffalo Bills Hall of Fame Quarterback Jim Kelly, and hundreds of fans held a prayer vigil at One Bills Drive in the pouring rain to pray for Hamlin's recovery.

ery. "Bring healing and restoration to Damar Hamlin," said one.

"You are a good God of love, mercy, hope, deliverance, and healing," prayed another.

Keep in mind, this young man is just 24-years-old. To many of us, he's old enough to be our son. One minute, he's playing in prime time before a national audience in what many thought was the "most important game" of the season.

Seconds later, his almost lifeless body lay motionless on the turf of Paycor Stadium, doctors and paramedics shocking his heart to keep him alive.

At this point in time prayer and good deeds are what binds us together in our collective hope that Damar Hamilton survives.

Next to Saint Francis, Padre Pio is my favorite Catholic Saint. His simple yet powerful prayer rings true now more than ever, especially in light of the events that unfolded in the Bills-Bengals game:

"Pray, hope, and don't worry. Worry is useless. God is merciful and will hear your prayer."

No doubt the Good Lord is hearing a lot of prayers for Damar Hamlin, for his family, and for his health care providers that are desperately trying to save his life.

Let us not worry, especially after we all experienced this lesson from afar at how fragile life can be, that no matter our lot in life, it can change and end in an instant.

What we can do is learn from Damar Hamlin himself, what he did, when no one knew whether or not his fellow teammate would recover following an injury on the field. He prayed. So should we. Felonies





benefits or is deceased. the family maximum is calculated from a formula that yields a figure between 150 percent and 188 percent of the breadwinner's primary insurance amount — his or her monthly benefit if claimed at full retirement age. That age is 66 and 4 months for people born in 1956 and will gradually increase to 67 over the next few years. Is this calculation only applicable at full retirement age (in my case 66 and 4 months) or is it still applicable if I de-lay_taking SS until 68 or 70? My assumption is the "breadwinner" is the spouse with the higher income. Signed: Planning my Retirement


Dear Planning: The Family Maximum applies only when more than one dependent is collecting benefits from the record of a worker who is either deceased or collecting Social Security retirement benefits (the "breadwinner"). That might typically be a spouse and a minor child, multiple minor children, or, perhaps, multiple children and a spouse as well.

The Family Maximum doesn't apply, for example, when both a current spouse and an ex-spouse are collecting benefits from that "breadwinner" - only when a current spouse and minor children are collecting too. The Family Maximum also does not apply when only one dependent (e.g., a spouse) is collecting benefits from the "bread-winner," or when no de-pendents are collecting benefits on the "breadwinner's" record. Neither would the Family Maximum restrict your benefit if you wait until you are age 70 to claim your maximum personal benefit. So, if your concern is that the Family Maximum might limit your, or your wife's benefit if you wait until age 68 or 70 to claim, you can discard that concern.

You are correct that the Family Maximum formula, when it applies, yields a maximum total limit of 150% to 188% of the worker's "primary insurance amount² or "PIA," which is the amount the worker is due at full retirement age (FRA) and, as you know, your FRA is determined by your year of birth. If the Family Maximum applies because multiple dependents are collecting SS benefits on your record, Social Security will determine your maximum family dollar amount, deduct your PIA (your FRA benefit) from that amount, and the remainder would be available to be shared equally among your multiple dependents. But if no one else, or only your wife, is collecting benefits on your record, the Family Maximum does not apply.

Mostly soft in palette with fluid shapes, lines and textures, they capture light and the feeling of a space, be it intimate or expansive. Resident Smoking Free With Support From NYS Smokers' Quitline

Quitting smoking or vaping is challenging; however, people across New York State achieve lasting success every day with prop-er support. The New York State Smokers' Quitline (Quitline) celebrates those who pursue and maintain tobacco-free living and encourages those who smoke or vape to make a quit-attempt in 2023 – whether it's a first time or trying again. The Quitline reminds all New York State residents personalized support from trained tobacco treatment specialists and free resources are available seven days a week by 1-866-NY-QUITS calling (1-866-697-8487), texting QUITNOW to 333888 and visiting nysmokefree.com.

For Dana B. (pictured), age 51 of Amherst, N.Y., timing was everything in his journey to become tobacco-free. He smoked a pack-a-day of cigarettes since age 18 and tried to stop a few times throughout his life, but usually never for more than a few days. Suddenly on March 2, 2020, Dana suffered a brain aneurysm and went to a Buffalo hospital.


"The neurosurgeons discovered a black-colored plaque leading into the main vessel to the brain," Dana recalled. "I always felt like a fit individual despite my smoking. The images of the plaque showed the damage cigarettes were doing to my health. I learned I essentially had a 1-in-3 chance of dying, a 1-in-3 chance of paralysis and a 1-in-3 chance of walking out of the hospital."

Fortunately for Dana and his family, the latter of the three possibilities happened. He received his hospital discharge in late March, just before hospital beds became increasingly occupied by more patients at the onset of the COVID-19 pandemic. Be-fore he left for home, Dana learned about the New York State Smokers' Quitline and called 1-866-NY-QUITS to speak with a trained tobacco treatment specialist.

By May of 2020, Dana weaned from the nicotine patches and nicotine gum. He developed new routines to keep himself busy in place of smoking. Dana knows without the tools from the Quitline and the added encouragement from his family and healthcare professionals, the past three years of his life would look very different.

Most New York State adults are eligible to receive a free starter supply of nicotine replacement therapy (NRT) medications via mail, typically in the form of nicotine patches and often with supplemental nicotine gum or nicotine lozenges. When used appropriately and in combination, NRT medications can double or triple the odds of becoming and staying tobacco-free.

For those who prefer support via text, the Quitline reminds all New York State residents to try the new Learn2QuitNY six-week comprehensive program by enrolling at nysmokefree. com or texting QUITNOW to 333888. The Quitline also recommends all tobacco and vape product users to visit the CDC's "Resolve to Be Smokefree in "23" website, complete with tips, resources, links and app recommendations.

SPCA Issues Winter Pet Safety

Continued from page one. Keep a Tight Leash: Never let your dog off the leash on snow or ice, especially during a snowstorm. Pets can lose their scent on snow and ice, especially if snow is falling at a fast rate, and your pet can easily lose his sense of direction. Pets may also panic during a snowstorm and run away; many pets are lost during the winter months. Remember to keep current identification on your pet at all times!

*Keep Pets At Home: Never leave your pet alone in a car during cold weather. A car can act as a refrigerator in the winter, holding in the cold. Your pet could literally freeze to death.

*Always Dry Pet's Wet Feet: Thoroughly wipe off your pet's legs and stomach when she comes in and out of the rain, snow or ice. Check her sensitive foot pads, which may be bleeding from snow or ice encrusted in them. Your pet may also pick up salt and other chemicals on her feet accidentally. These chemicals could hurt her if she swallows them while licking her feet.

*Lay Straw for Dogs' Visits Outdoors: Can't get your dogs to wear booties? Lay straw on top of snow for trips outdoors by dogs reluctant to step out onto a freezing surface to relieve themselves.

*Check Cars for Cats: During the winter, stray or neglected cats outdoors sometimes sleep under the hood of the car where it's warm and comfortable. If you start the motor, cats could get caught in or flung about by the fan belt, causing serious injury or death. To prevent this, bang loudly on the hood and sides of your car before turning on the ignition to give the cat a chance to escape.

*Keep Outdoor Sessions Short: Take your dog outside only for as long as it takes for him to relieve himself. Dogs, particularly small, short-haired breeds like Chihuahuas and terriers, suffer from the cold despite their seemingly warm fur coats. Live within Buffalo city limits? Don't forget Buffalo's new laws pertaining to tethering dogs in inclement weather.

*Bathe Pets Only When Necessary: Your pet runs the chance of catching a cold when wet, especially in cold weather. If you absolutely must bathe your pet, consult a professional groomer or veterinarian.

*Keep Pets Warm: Limit the clipping of your pet's hair in the cold winter months, keeping your pet as warm as possible. Brush your pet daily in lieu of clipping to keep your pet's coat healthy, shiny, clean and mat-free. Make sure your pet has a warm place to sleep far away from outside drafts.

*Hungry Pets: Speak to your veterinarian about increasing your pet's supply of food, particularly protein, to keep his fur thick and healthy through the winter months. Inquire about vitamin and oil supplements.

*Antifreeze is poison to pets: antifreeze, even in small doses, is a lethal poison for dogs and cats! Because of its sweet taste, animals are attracted to it. Be sure to clean up spills thoroughly, and consider switching to an animal-friendly antifreeze. Ensure that, if you store Antifreeze in a garage, shed, or other places accessible to your pets, it is well out of pets' reach.




