Buffalo Marathon Weekend is seven days away. This year we are thrilled to continue our growth back towards pre-pandemic levels with 6,400 athletes from 13 countries and 41 states participating. All events sold out in early April.

A weekend/summer kickoff party, which is open to everyone, will be held on Chippewa Street on Friday night (May 26) from 5 p.m. to 10 p.m. The Strictly Hip will be performing and the night will be capped with a spectacular fireworks display at approximately 9:30.

A new, free Plogging event will be held Friday, May 26 at 5:30 starting near Chippewa Street. Plogging is a

combination of jogging and picking up litter to enhance the aesthetics of our city. Registration is required.

The Health and Wellness Expo will be held on May 27 from 9 a.m. to 6 p.m. and is open to the public.

The Shopper Chopper, a giant street-legal motorized shopping cart will be making an appearance at the Friday night happy hour and will again lead the race.

Buffalo families have one more opportunity to experience The Buffalo History Museum's Train Gallery, which is scheduled to temporarily close on June 3. For more than 30 years, the expansive display has featured 1900s replica model trains running on more than 200 feet of track,

a scale Erie Canal lock, and 100 miniature hand-made buildings portraying 19th century Buffalo and Western New York. The Train Gallery has been maintained and operated by the Rail Barons, a longtime dedicated team of volunteers who custom built the model.

A whole Sports column devoted to all the Baseball and Softball highlights and scores in Shoshone Park from boys and girls playing the games since Opening Day. Ten straight days of great weather, enough to get the Hertel North Park Youth Baseball and Softball League off to a great start to the 2023 season. Let's take you right to Shoshone Park and get you caught up.

Seamus Mahoney had two hits and teammate Emerson Anderson-Strait hit a two run double and Owen Beasley stole home to lead the Double A Cardinals to a 4-2 vin over the Pirates on Opening Day. In Rookie Girls, Jordan Woods knocked in teammate Brielle Taylor in the top of the fourth inning, leading the Shamrocks to a 1-0 win over the Stars. In Rookie Boys, Luke Nikiel had two hits and teammate Luke Vitrano went 3 for 3 to lead the Yankees over the Red Sox 6-3.

Colin Poppenburg and teammate Jack Kromer played well at shortstop and catcher on the diamond to give the Royals their first win of the season, a 10-1 win over the Yankees in Triple A Division. Sheridan Neely helped lead the Rebels to a 6-1 win over the

Ravens and Colin Kleeh blasted a two-run homerun to rally the Mets to tie the Dodgers at 3-3. Grant DePasquale, Chris Nance, River Haisch and Charlie McDermid all helped lead the Mariners to a 4-2 win over the Astros in Rookie Boys.

Patrick Donoghue drove in three runs in the bottom of the 5th inning to rally the Royals over the Mariners, 6-3 in Triple AAA. Brothers Jadin and Carter Horan three three inning apiece on the mound and smacked doubles at the plate to lead the Braves to their first win of the season, a 9-7 victory over the Reds. In other games, the Purple Eagles got their second win on the young season with a 9-7 victory over the Bulldogs. The Dodgers beat the Mets, 2-1 in Double A and the Yankees rallied to tie the White Sox 6-6 in games at nearby McCarthy Park.

This Saturday, May 20th, Hertel North Park is asking all players to be present at their games as scheduled. The League's photographer will be in the Park, snapping team photos and individual pictures throughout the Day. Picture Day is set well in advance so all may receive great photos of themselves by seasons end on

your Summer in Shoshone Park. The Photographer will return again on Saturday, June 10th.

Dan Kooshoian and Rocco Diina both went three for three at the plate and combined to pitch scoreless innings to lead the Reds over the Cardinals, 6-3. Aria Callahan had three hits and Demi Martin hit a double to lead the Diamonds over the Devils, 2-1. Rodrigo Bonilla had two triples and knocked in two runs to lead the Brewers over the Phillies, 6-0. Luke Barry pitched two innings of no-hit ball and smacked a triple. The AAA Tigers won their third game in a row on two singles by Ben Stothart in a 6-1 victory over the Blue Jays.

In other games Saturday, Tim Bartels homered and nine year old teammate Colin Stimpson pitched two innings to lead the Royals to a big win over the Angels. Vinny Majchrzak tripled and Ben Willis singled to help pitched Nathan Smith on the mound in a Padres win over the Giants, 8-2. Gabe Brighton made some solid plays defensively.

Lincoln Day hit a two out, two run single in the 6th inning to break a 3-3 tie that gave the A's a 6-3 win over the Twins. Braden Westfield, Max Capaccio, Noah Lundquist and Matthew Rickert shared mound duties for the team's first win of the season. Luke Kuwik tripled while pitching two innings and teammate Elian Sosa got his first hit of the season as the Cardinals defeated the Dodgers, 5-1.

Games are played every night during the week Monday through Friday at 6:00pm and all day Saturday beginning at 9:30 and continuing 11:30am, 1:30 and 3:30pm. Come on out to Shoshone Park, home of the Hertel North Park Youth Baseball League.

The gallery is closing to make way for the transition of offices from the Julia Boyer Reinstein Center across the parking lot into lower level where exhibit is located. Built in the 1920s as a private home and music studio, the Reinstein Center has housed staff offices since 1992. The Museum is currently in discussions to redevelop that property into a new attraction.

“I know it is difficult for the Rail Barons and museum visitors to see a beloved exhibit come to a close and we are grateful for their dedicated support to the gallery,” said Buffalo History Museum Executive Director Melissa Brown.

“We have limited space in our historic buildings and need to make this move as part of our multi-year plan to further activate the entire museum campus.”

The trains in the Train Gallery will be operating from 11 am to 3 pm on Saturday May 20, May 27, and June 3.

Museum staff will take great care disassembling the exhibit, storing the model buildings and trains in the museum’s permanent collection for possible inclusion in a new children’s exhibit in the future.

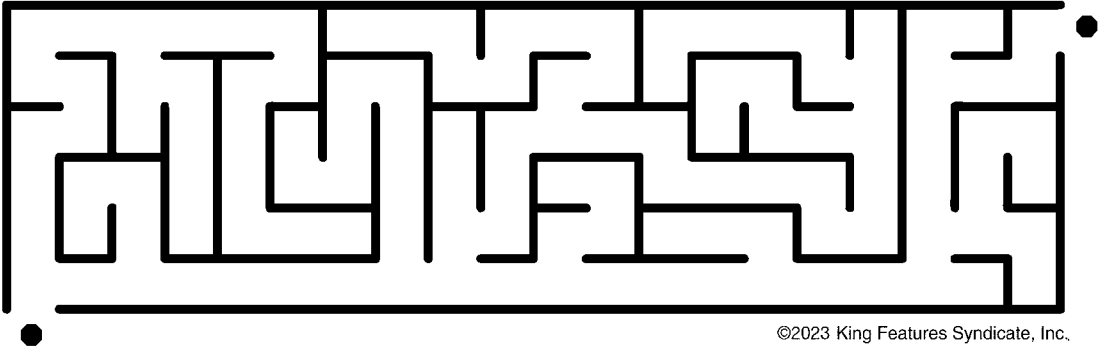

Sleep



Sleeping.

Do you get your eight hours of sleep? There is general knowledge that to remain healthy you need to get at least eight hours sleep each night. Not sure who says that, but it must be knowledgeable people who have done studies and research to come to that conclusion. Makes sense that you should spend one third of your day sleeping. Un-

fortunately, that is not true for me, personally. I can speak for myself and what I do. I am 88 years old so 5-6 hours a night must have worked for me. Like I said I am going to speak in my case particularly as I know it best. As a young boy I always loved the mornings. Loved the summers as we get daylight as early as 5 AM. Could not wait for

the sun to come up and get out of bed to start a new day. In my lifetime I have seen many sunrises. How many have seen the sun come up in the morning? Not too many I bet. How about sunsets? That is a big deal for a lot of people. Down in Florida the beaches are loaded with people waiting for the sun to set.

There was a group of us that would stop at Subway to buy a sub and go down to the beach and wait for the day to end with the sun disappearing over the horizon. It is like a special event. Hundreds of people, cameras clicking and then they usually break into applause when it ends. Not sure if they are there every night but on the ones I was there, this is what happens. Remember, in Florida the sun comes up almost every day, so every day there is a sunset. And it does not disappoint. They are spectacular.

Personally, I love the sunrise more than the sunset. It means the start of a new day. Like I stated as a young lad I used to get up early and go down to what was then the front park and feed the horses. Back then, policemen rode horses and there was a stable down there full of horses and in the morning, they would have let them out of the barn. The grass in the fenced-in area they were in was

all gone. Plenty just outside the fence so I used to feed them that grass. Did it for many summers till the stable and the horses were no more. Then, having a Courier Express route helped to make me an early riser. It was a morning paper and had to be delivered before 7 AM. So 5 AM was my get up and get to work beginning. Never minded doing that. Loved the long days.

Getting back to sleep and the amount we get. Again, personally I do not think I ever got eight hours sleep in my lifetime. Maybe there were times, but I do not recall. I was always an early riser and eleven or twelve was my bedtime. Did not want to miss anything. Always plenty to do, places to go and people to see. The longer the day, the better. Why waste it by sleeping? I have seen some of my grandchildren go to bed at eleven and get up at eleven or twelve. They, like a lot of people, just love to sleep. What a waste of the day. To me anyway. I guess some people just need their sleep. I am not one of them.

Okay five or six hours, maybe seven on occasion. How about naps? Personally, I do not take naps. To me napping is delib-

erately laying down with the intention of sleeping. I have a brother-in-Law who takes a nap every day like clockwork. Like in Mexico, it is siesta time. Napping in the afternoon. I do not take naps deliberately. Dozing, that I do a lot. Sometimes I doze for an hour. I fall asleep watching a boring movie, I doze off in my office chair, and sometimes I even doze off while driving. Only once did I end up in a field. It was level so no harm done. Since then if I feel dozy, I will pull over at the nearest rest area and take a 10 minute "nap". Then I am ready to go. Done it numerous times. Especially on the many trips back and forth to Florida.

Okay, so to me the question is do you need eight hours sleep? Elon Musk, who most have heard of, claims he gets five hours sleep and is still able to function. I use him as an example as he is extremely successful in what he does and is able to multitask. He is a lot younger than I, but we must both feel the same way. Sleep is much needed but a waste of time. I would like it if we did not need to sleep at all. But that is just me. In any case, have a good night.



Ask Rusty – I’m Concerned About Social Security Solvency

Dear Rusty: I retired at age 58. My husband and I worked 40 years of employment each. I had a 401K only...no other benefits. We saved, we invested through our financial advisor, and have done okay watching our investments grow (except for the last 3 years). Neither my husband nor I have taken Social Security; we were both waiting until age 70 to get full benefits. Do you think this is still wise? I'm concerned there will not be any funds in 5 years when we both turn 70. **Signed: Concerned Senior**

Dear Concerned Senior: Your question relates to Social Security solvency, no doubt inspired by the recent spate of media discussion on this topic. Most articles I've read promote a "doomsday" scenario and, in fairness, Social Security's financial issues are serious. The latest report from the Trustees of Social Security warned Congress that the reserves now held in Social Security's Trust Fund (which enable full benefits to be paid) will be depleted as early as 2033. What you may not know is that this is not new news – the Trustees have sounded the same warning for decades to multiple Congresses which have neglected to enact corrective measures. And, unfortunately, they are likely to continue to drag their feet

for a while because the reform needed is not politically palatable and the impact is still a few years away.

Nevertheless, although Social Security's looming financial issues are serious, they are not fatal. Congress already knows how to fix Social Security's financial issues – they just currently lack the bipartisan spirit and political will needed to do so. The clock, however, is ticking and Congress will be forced to act soon, which we are confident will happen before the Trust Funds run dry. What motivates most politicians is getting re-elected and allowing an across-the-board cut to all Social Security recipients (which would happen if the Trust Fund reserves were depleted) would be political suicide. Therefore, I'm confident that reform will occur in time, and I don't suggest changing your Social Security claiming strategy over worries about Social Security's solvency.

Let me further allay your fears by explaining what would hypothetically happen in the worst-case scenario (if Congress doesn't act and Trust Funds are depleted). If that were to occur, when the reserves are depleted in about 2033 everyone would face an across-the-board benefit cut. Social Security can't go bank-

rupt because there would still be about 175 million workers contributing to the program but, since Social Security (by law) can only pay benefits from revenue received, everyone's benefit would be reduced by about 23% (according to the Trustees). Every beneficiary would still get benefits, but only to the extent available from income received. This brings me to your specific question – whether it is still wise to wait until age 70 to claim (or to claim your benefits now).

Ask yourself this question: which would result in a larger monthly payment, a 23% cut to your age 70 SS payment amount, or a 23% cut to your current benefit amount? The answer, of course, is that your monthly payment would be more if you stay with your current strategy and wait until age 70 to claim (a plan which I assume you developed considering your current financial needs as well as your life expectancy, both of which are very important to that decision).

Again, I do not believe the worst-case scenario will happen. Congress already knows how to restore Social Security to full solvency, and they will almost certainly act in time to avoid an across-the-board cut to everyone's benefit. The Association of Mature American Citizens (AMAC) has proposed legislation that would restore the Social Security program to full solvency for generations without raising payroll taxes, a summary of which you are welcome to review here: www.amac.us/social-security.

AMAC has provided this proposal to various members of Congress for consideration.
