Buffalo Waterfront will host a variety of fun, family-friendly activities at Canalside and the Outer Harbor as Western New York celebrates Labor Day weekend. Wilkeson Pointe will host the final two Sounds of Buffalo live music events on Friday, Sept. 1 with a Night of the Grateful Dead featuring Dead Alliance of Buffalo at 7 p.m. and Saturday, Sept. 2 with Buffalo Music Club Live. These



events will kick off the final weekend of operation at the Wilkeson Pointe Beer Garden. Food and beverage specials will be available throughout the weekend, with Sept. 4 marking the last day open to the public until spring 2025, as the area undergoes construction of a new food service building with restrooms, a new outdoor seating area, and renovations to the trail and parking. The Roller Rink at Ca-

nalside will host Game Night-themed skating on Friday, Sept. 1 from 6 p.m. to 10 p.m. All the favorite traditional rink games will be played, like limbo and four corners. The Longshed remains open to visitors as staff and volunteers with the Buffalo Maritime Center construct a replica of an 1825 Erie Canal packet boat. Only a few weeks remain to visit this attraction. Spartans Win Championship!

And the heart and soul of the team was Reagan Hornung who came back from a broken wrist to play the final 2 playoff games, providing the lift the Spartans needed to win the championship. Every time you spoke to James Hornung Jr in Shoshone Park after his game, the excitement in his voice told you most of the story. The story was that the 9-10 year old Triple AAA Spartans defeated the #1 ceded Crimson Tide in two straight games to win the Championship in this Division, 14-13 Tuesday August 1 and then again, the next night, 7-4 and won their first title using the new Spartan nickname.

This season, for the first time, the Girls teams of the Hertel North Park Youth Baseball and Softball League had changed their team nicknames prior to Opening Day, in early May. Instead of a boys team name like the Mets or Yankees, Girls soon found themselves cheering for their friends on teams like the Purple Eagles, Gators, Bulldogs and Volunteers. Their uniform colors matched the College or University teams as well. A team named the Wolverines won the Double AA Di-

vision recently and now the Spartans were looking for the same type of glory.

Sienna Smith was a star pitcher on the mound for the Spartans all season long. She worked at least two innings and set the tone for the game in the field. Morgan DeLaPlante supplied the power at the plate offensively every game, leading the team to seven homeruns in the season, most of them over the fence on Diamond #7. But the Heart and Soul of the team belonged to ten year old Reagan Hornung, who had to sit out most of the season with a broken wrist until the team's last two games and shined for the team in the clutch.

"It was a great season for all the girls, all the Spartans," said James Hornung Jr, the team coach afterward. "It was great to be Spartans this year with the new team colors. The Girls faced some serious competition from the Crimson Tide and the Gators es-

pecially. Jason and Darryl both had really good teams but the girls were all up to the task."

With just four losses and a tie during the regular season, the Spartans won seven games to finish second in the Division. Addison Ryan was a consistent hitter all season long and was able to play just about anywhere. Another girl, Jaliyah Jones, was a great contact hitter and happy to play wherever the coaches asked of her. Zeta Allen always had a strong glove and came up big defensively down the stretch of the season. Vera Riordan was rock solid at third base. Molly O'Sullivan's bat got hot for the Playoffs.

In round one of the Playoffs, the Spartans defeated the Bulldogs 15-12 under the lights back on July 18th and advanced to face the Crimson Tide in round two a week later. The team suffered their first loss, 10-9 against the Tide in a close game. Three nights later, the Spartans bounced back with an 18-17 walk off win over the Gators in a crucial game that put them into the Championship against the Tide.

"All of our games against the Tide, five of them in all, were decided by just one run," said Hornung. "It was truly a testament to how hard all these girls played. I was so proud of watching these girls develop and play hard when it mattered."

Other Spartans players included power hitter, Chryssandra Brown, Remy Eckman with her clutch hits, Michaela Bullock coming off an injury during the season to return to help in the playoffs. Talia Salerno provided back-up support to any other starter on the field and Betsy Ware was always ready to help, especially in the playoffs.

In other Divisional Championships in Hertel North Park for the 2023 season, the Cubs defeated the Braves 11-1 in Major Boys. The Huskies defeated the Ducks 12-2 in Major Girls and the Mariners defeated the Tigers in Triple AAA Boys.

Here are the winners in the other three Divisions. Angels in Rookie Girls. Wolverines in Double AA Girls, Cardinals in Double AA Boys. A great season in Shoshone Park.





Raising Eight Children

Ever wonder what it would be like to raise eight children? Been there and done that and I can only say it was a struggle but fun. Just imagine a house with ten different personalities, desires and needs. What foods they liked, how they argued, how they loved each other. Not too many people can say that unless they have a large family. Many people have asked me, "How did you do it? I have two and can hardly control them". It was a different world not that long ago. Very few, if any, have that many kids today with all the birth control and means of preventing childbirth.

Let me say none of my children were planned, they just happened. But every one of them were welcomed with love. Fortunately, I was able to buy a four-bedroom house on the West Side when we had just two little ones. It was never the plan to fill the bedrooms but that we did. The kids just kept on coming and coming. Besides the four bedrooms the house had a large kitchen, dining room, two parlors and a den. Lots of room to roam. Dining room had enough room for a large table to fit our ten people at supper-time. Dinner was special. We always ate together, all ten of us. Discussing the day's events with each one of them. Those were the days my friend, I thought they'd never end.

As far as hardships, we had enough of them. Remember though that the older children take care of the younger ones, so the burden is not just on the parents. Eldest daughter changed a lot of diapers. She was the second mother. She oversaw seeing that the table was set before we ate and the clean up after. Each child had specific duties. Set, clear, wash, dry, and put away the dishes. With ten people there were lots of dishes, pots, and pans. The boys wanted to clear as they would get to eat any leftovers. Not too many of those. No scraps for the dog in that house.

How about feeding and clothing such a gang? I had quit school at 16 as I also came from a family of eight. Being financially set was not a way of life for me growing up. Needed to help at home. I say that without

an education, the only jobs I could do were as a laborer. Back then even finding a job was difficult. Still, I needed to feed my family so I worked two jobs when I could find work. Drove an Ice Cream truck, did landscaping, whatever I could find to help the cause. There were times when money was tight. I used to buy cereal wholesale, the large box with twelve regular size boxes inside as it was cheaper. Problem was they all had to eat the same kind of cereal every morning day after day. No choices. Any meat we had was baloney and hot dogs. Of course, we had plenty of spaghetti and meatballs. Lots of homemade soups and peanut butter and jelly sandwiches. We survived and we were one big happy family.

With so many kids there are so many stories as one would expect. If one would get a contagious disease all the rest would. Chickenpox, measles, mumps, flu, some at the same time. Then the individual illnesses. We were regulars at the children's hospital emergency room. Each time there was trauma in the household, till the rest of the family knew everything was alright, there was lots of praying. Lots of feelings and love. That still did not mean they did not have their moments. Five boys? Yes, they loved each other but that did not mean they did not fight. Many disagreements that would lead to pushing and shoving. I would always say, "Go out on the lawn and fight, I will referee". They never did and would settle their differences.

As far as clothes, lots of people gave us things that their kids grew out of. Much to the dismay of the older ones. My wife used to make some of their clothes. The sewing machine was always going. Then of course the younger ones would get the hand me downs. I knew a little about that as I wore nothing but hand me downs from my three older brothers. Never had bought ten clothes until I was able to work and buy my own. Just a fact of life that with large families with limited income, you wear hand me downs.

Have to say looking back I would not have it any other way. The kids

made it through and are now all successful in their own lives. It just was fun when we were all together in the big old cold house. We sang, we played games, we laughed, we cried, hugged, and kissed and always respected one another. To this day, even with the loss of my wife and their moth-

er, there still is a bond that she shared with them.

No regrets here in struggling to raise a big family. I would do it over in a heartbeat. It was well worth what we put into raising our children. The wonderful memories are our reward.

Ask Rusty –I’m 64. When Should I Claim My Social Security?

Dear Rusty: I am 64 years old and still working full-time. My question is – when should I start my Social Security? I would like to start it in January 2024 and go part-time at work, but would I be losing much Social Security by not waiting until full retirement age? **Signed: Trying to Plan Ahead**

Dear Trying to Plan: You are smart to evaluate the impact of claiming your Social Security (SS) benefits early. First, be aware that your full retirement age (FRA) for Social Security purposes is 66 years and 8 months, and that is when you get 100% of the SS benefit you’ve earned from a lifetime of working.

It appears you already know that if you start benefits before your FRA, you’ll be subject to Social Security’s “earnings test” which limits how much you can earn from working before they take away some of your benefits. But if you go part-time at work you can mitigate the earnings test and claim your benefits early – just understand that your payment will be permanently reduced by doing so.

If you claim your benefits to start in January 2024, you’ll be taking your Social Security about 18 months early, which means that instead of 100% of your FRA entitlement, you’ll get about 90% (a reduction of 10%). The earnings test will still apply, and we

don’t yet know what the 2024 earnings limit will be, but it will be something more than the 2023 limit of \$21,240. If your 2024 earnings exceed the annual limit, SS will take away \$1 in benefits for every \$2 you are over the limit. They “take away” benefits by withholding future payments until they recover what you owe for exceeding the limit. If you work part-time and don’t exceed the 2024 annual earnings limit, there will be no penalty and you will get every month’s SS payment. If you find you will exceed the annual 2024 earnings limit, you can call Social Security and inform them of that and by how much, and they will suspend your benefits for the number of months necessary to avoid overpaying you. If you don’t inform them and you exceed the annual 2024 limit, they will catch up in 2025 when they get your 2024 earnings info from the IRS and issue an Overpayment Notice requiring you to pay back the amount owed (half of what you exceeded the 2024 annual limit by). As you likely know, the earnings test no longer applies after you reach your full retirement age.

So, the decision on when to claim your Social Security benefit is yours to make, and you are smart to consider your work plans – but should also consider your life expectancy and marital

status. If you are married and eventually die before your lower-earning spouse, your spouse’s benefit as your survivor will be based on your benefit amount at the time of your death. Thus, your age when you claim your benefit may also affect your spouse’s benefit as your survivor; the longer you wait (up to age 70) the more your spouse’s survivor benefit would be. And if you enjoy at least average longevity, which is about 84 for a man your current age, then by waiting until your FRA or later to claim you’ll not only get a higher monthly payment but also get more in cumulative lifetime benefits. If, however, your financial circumstances are such that you need the SS money sooner, then claiming earlier may be the right decision, provided you don’t substantially exceed the annual earnings limit prior to reaching your full retirement age. I hope the above provides what you need to make an informed decision.
