If a pet needs to spend time outside during extreme temperatures, keep both walks and potty breaks short.

Use plastic water bowls for outdoors. A pet's tongue may stick to metal, and they could injure themselves when trying to pull away.



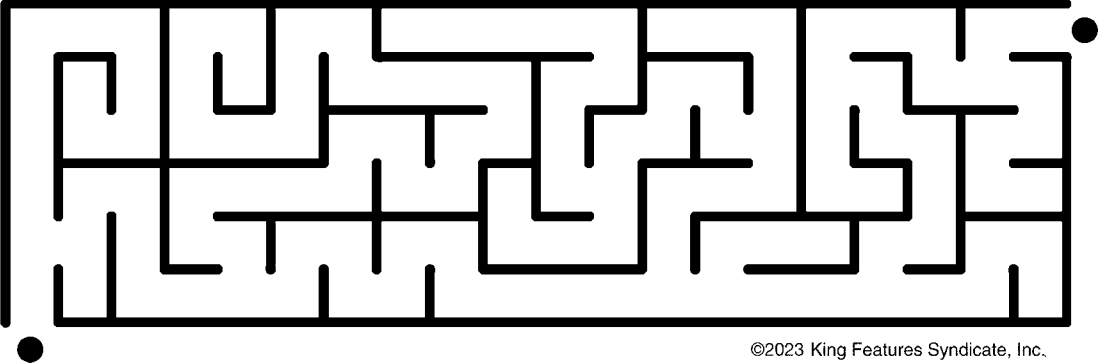

My sunny Florida home.

If you live in Western New York, you are aware of the snowstorms we had in December last year. The last one in particular was the Christmas surprise. Everything was shut down for four days. It was a terrible time to be in that area. It was so bad the Buffalo Bills football team had to play their home game in Detroit. Usually, it does snow some in November and December but not like that. Just dusting or lake effect in the southern tier. Melts in a few days.

Personally, I was stuck in my house for the whole four days, in need of medication that I could not get. Even the Supermarkets and Pharmacies were closed. I had to shovel a path just to let my little dog out for her daily morning routine. She stepped off the last step and into the snow and only her little head was above the white stuff. The only help I could get was my next-door neighbor who shoveled a nice path for my little Angel. He had trouble just to get to my place from his. Snow was up to his waist, and he had to plow through it one step at a time.

The point is, if it is something you could avoid, why not? I have a home in sunny Florida and why fight the snow, cold and ice? Most of us “snowbirds”, as we are labeled by the year-round residents, go down after the holidays. Around the first week of January. My wife and I did that for years, back in the day we waited till the Buffalo Bills playoffs were over as we had season tickets. Last year I went right after Christmas, so I was in the Buffalo area for the storm. Never again. Do not have season tickets so there is nothing to hold me in WNY.

Did not want to miss all the holidays so I decided to head south right after Thanksgiving. At least see some of the family before I leave. Usually I drive, but each year the trip seems longer and longer. My one son has been kind enough to drive us down for the last few years, but he had a massive heart attack and is not available at this time. Last May on my return trip, I managed to drive home alone. Would prefer not to do that again. Flying is a pain as it is like a

mini move. Lots of things to switch from one resident to the other. Driving again was the option. I was about to do it alone again, but my other son offered to go with me. So he did.

Driven the strip south so many times that I know every rest area and bottleneck there is on the route. I-90 to Erie, head south on the I-79 through Pennsylvania and W. Virginia. It is flat till you reach Pittsburgh and the mountains begin. Small to start but then become massive. The last ones in Virginia are so high there are tunnels through them. Breathtaking sights to behold but not fun in the winter or the rain. The last tunnel, the “Big Walker”, seems to be the peak. Feels like you are going downhill into North Carolina. Our first stop is in Statesville as it is about halfway on a two-day trip. I-77 into South Carolina, I-26 to the nightmare. I-95 south. Only 86 miles in South Carolina but generally the worst part of the trip. This time it was so congested that traffic actually stopped dead for a while. It was stop-and-go that whole stretch. It is two lanes through South Carolina and opens to three in Georgia. The 100 miles through the peach state is great. However, reaching Florida does in no way mean it is over. Usually takes 6 hours from the border to where I am in SW Florida. Long way but knowing you are reaching your destination makes the adrenaline flow.

Going down, the weather is a factor, and the days are shorter than the return trip. You leave an area where everything is cold, bleak, and dead. As you travel south, the accumulated snow by the side of the road disappears. The dead looking trees become green, the temperature rises, and the sun shines. Once you hit Georgia, you start seeing palm trees. The Florida Welcome Center gives out free orange and grapefruit drinks. Like Alice in Wonderland, you are stepping into a different world.

This is the earliest that I have been in Florida. I had thought the “snowbirds”

had not arrived. Much to my surprise, seems everyone had the same idea to beat the winter as it is like “the season” here. “The season” is usually January, February, and March. The restaurants are already busy. Year-round residents seem to frown on “the season” as it adds to the congestion. Oh well, just have to make the best of it. Must learn how to cook so I do not

have to go out so much. I’ll manage because it is worth it. See you in the Spring.

Ask Rusty – We’re Planning To Claim At 62; What Do We Need To Know?

Dear Rusty: My wife (born May 1962) and I (born April 1963) are retired and will soon be looking to start collecting our Social Security as we each hit 62. As this is new to us, I’m wondering what things we may need to be aware of or consider as we get closer to her 62 birthday in May. Any advice or information will be appreciated!

Thank you in advance for your service as a Social Security Advisor.

Signed: Planning Ahead

Dear Planning: If you and your wife are both retired from working and have decided to start your (reduced) Social Security as soon as you are eligible at age 62, then there is nothing you need to do in advance of applying. The Social Security retirement benefit amount for each of you will be determined by your individual lifetime earnings record and your age when you claim. If either of you will be eligible for a spousal boost from the other, that will be automatically applied when both of you are collecting.

If your wife plans to claim her Social Security as soon as she is eligible, she should apply for her benefits about 3 months in advance and choose the option on the application which states “I want benefits beginning with the

earliest possible month and will accept an age-related reduction.” For information, an applicant must be 62 for an entire month to get benefits, so your wife’s first month of eligibility will be June 2024. Social Security deals only in whole months and pays benefits in the month following the month earned; so if your wife’s birthday is between the 11th and 20th of the month her first Social Security payment will be received in her bank account on the third Wednesday of July. All subsequent payments will be on that same schedule. Then, when it’s time for you to claim, you should follow the same process as your wife and, if either of you is entitled to a higher amount as a spouse, it will be automatically applied when your benefits later start.

Applying for benefits is a relatively simple process if done online at www.ssa.gov/apply. Note that to apply online your wife will need to first create her personal “my Social Security” account, which is easy to do at www.ssa.gov/myaccount. To prepare for applying later, you can also create your personal online account now (it’s required to apply online), at which you will see what your estimated benefit will be at different ages. Of course, your wife first (and later you) can also call Social Security at 1.800.772.1213 to request

an appointment to apply for SS retirement benefits in person. Applications which are not done online are usually taken over the phone vs. requiring a visit to your local Social Security office, but applying online is, by far, the most efficient method (you can link to the application process from your online account).

One important thing to be aware of: By claiming at age 62, the monthly payment for each of you will be 70% of what it would be at your full retirement age (FRA) and that is a permanent reduction. If you expect at least average longevity – about 84 for you and 87 for your wife – and if it is financially feasible, then waiting longer to claim would yield a higher monthly amount as well as the most in cumulative lifetime benefits. For those with an FRA of 67, SS retirement benefits claimed at FRA are 30% higher than at 62 and, if claimed at 70 are 75% more than at 62. And, although the de-

cision on when to claim is always personal, a married couple should also evaluate their joint needs when deciding.

One final word of caution: although you and your wife are now retired from working, be aware that if

you claim SS benefits before your FRA and return to work, Social Security has an earnings test which limits how much you can earn before some benefits are taken away. The earnings test lasts until you reach your full retirement age.

Gently wipe their feet with a damp towel once they are back inside to avoid a trip to the veterinarian. Wearing boots can protect paws from irritating salt on the street. Many dogs, particularly those with short coats, will be more comfortable if they have a sweater or coat on. If a dog frequently lifts their paws, whines or stops during walks, it is probably because their feet are cold.

Be particularly careful when taking older, arthritic animals and small pets outside. They may become stiff and tender quickly and often find it difficult to walk

on the snow or ice.

Don’t let dogs off the leash during a snowstorm. No matter how much they want to play in the snow, they can easily lose their scent and become lost.

Always make sure dogs are wearing ID tags and are microchipped before you take them out. Always check under the hood of a car’s engine - a favorite hiding space for community cats. Check underneath a car, bang on the hood, and honk the horn before starting the engine to make sure a cat hasn’t taken up temporary housing there.
