

#### USBG Awards 26 Recipients For Urban Agriculture Projects

United States Botanic Garden (USBG) and American Public Gardens Association (Association) are awarding support to 26 public gardens and their community partners engaging in urban agriculture, food-growing, and related education work. The 26 awards total \$445,600 in support for public garden partnerships across the United States that will foster public engagement and education in urban food growing and build capacity in urban agriculture programs.
The Urban Agriculture Resilience Program aims to strengthen collaborations, promote resilience, and gather best practices from across the U.S.

The Buffalo and Erie County Botanical Gardens is one of the 2024 recipients in support of their programming surrounding their impactful Farm Garden. The Farm Garden proudly provides over 13,000 servings annually of fresh produce to Gerard Place located in East Buffalo. Over 30% of Buffalo's population faces food insecurity and record food inflation is affect-

ing everyone. In response to this, food access concerns expressed by the community and with the support of generous donors, the

Botanical Gardens has doubled their food-producing growing space into a large-scale Farm Garden to support Gerard Place's Community Kitchen and outreach programs.

The funds from this award will help programs in 26 states and Washington, D.C. integrate urban food growing and urban agriculture education while addressing food security challenges Continued on page five.

Last weekend, we sprang forward on our clocks and lost an hour of sleep.
Sunday is St. Patrick's Day and we have two Parades we could attend. St.
Joseph's Day Table awaits some of us too.
With all this mild weather, we've been pretty lucky.

If you haven't signed your son or daughter up yet for the 67th Season in Shoshone Park, please do so. Opening Day is Saturday, May 4th and if there's a blue sky and a bright Sun, the League will all meet at the corner of Hertel and Saranac Avenue before 11:00 am near St. Margaret's Church and march up Hertel to Shoshone Park under a Buffalo Police Department escort. It's the best Day in North Buffalo!

After a meeting held this past Monday, the HNPY-BL announced that there's close to 800 boys and girls

already signed up to play on close to 100 teams. You read that right, 100 teams. Registration continues online at www.hnpybl.com where you can just click on the registration tab and join us for another great season.

Registration is \$150.00 for boys and girls little league teams and \$100.00 for t-ball. These are the cheapest rates for your Child anywhere in WNY and the only place to play Baseball or Softball inside the City of Buffalo.

Here's a list of all the names of the boys teams that your son can play on this season. Angels, Astros, Athletics, Braves, Brewers, Blue Jays, Cardinals, Cubs, DBacks, Dodgers, Giants, Guardians, Mariners, Mets, Nationals, Orioles, Phillies, Pirates, Padres, Rays, Reds, Red Sox, Royals, Tigers, Twins, White Sox and Yankees.

Here are the Girls teams: Angels, Bruins, Bulldogs, Bears, Cougars, Crimson Tide, Comets, Ducks, Devils, Diamonds, Griffs, Gators, Huskies, Purple Eagles, Razorbacks, Ravens, Rebels, Spartans, Shamrocks, Stars, Tigers, Volunteers, Wolverines and Wolfpack. Each House team in the Park is scheduled to play as many as 12 games in the regular season that starts May 4th, and will play twice a week during the season, once on Saturday and also a weeknight game. All House games start at 6:00 pm and will play six innings. Saturday games are played either during the morning or afternoon. There are no games scheduled on a Sunday.

Every team makes the Playoffs in Hertel North Park and hopes to continue their season in July, after the 4th, when teams need to keep winning in order to win a Division Championship. There is nothing better than to watch your Son or Daughter play some exciting games for the Playoffs and hold a winning trophy up over their heads at home plate.

The League is working hard to make Shoshone Park a safe place for all Children to play this season. Diamond maintenance is always a top priority every day, especially after an overnight rain. Everyone is notified prior to a scheduled game if it cannot be played. The Board of Directors arrive early to run a tractor over an infield and chalk foul lines. New, better lighting will be installed during the season.

With over 1,300 boys and girls registered to play last year, the League also needed to use Joe McCarthy Park to play regular season games in some divisions. This will continue this year as older children will always be accompanied by an adult as they make their way across Main Street in a parents or coaches vehicle.

Plans are underway to celebrate the 2024 season in light of the new Thomas M. Smith Athletic Center presently being built just off the immediate Parking Lot. There's no question that the Parking lot behind the LaSalle Street Metro Rail Station will be utilized at all times. There are other Parking solutions for everyone this season but visitors to the Park must adhere to the various signs posted on residential streets like Shoshone, Tacoma, Parkside Court, or Groveland. 



## Ask Rusty – How Do Survivor Benefits Work For A Married Couple?

Dear Rusty: How does Social Security handle the death of one spouse? Say, for example, the husband receives \$2,000 per month in Social Security and his wife receives \$1,000 per month. How is the death of either spouse handled?

Thank you in advance for your service as a Social Security Advisor.

Signed: Concerned spouse

Benefits to a deceased beneficiary stop as soon as Social Security (SS) is notified of the death (notification usually done by the funeral director who handles arrangements). Benefits are not paid for the month of death, only for the preceding month when the beneficiary was alive for the entire month.

A surviving spouse is entitled to the higher of two benefits - their own personally earned SS retirement benefit, or an amount based on the deceased spouse's benefit at death. In the example you cite, and assuming the surviving spouse has reached full retirement age (FRA): if the husband dies first the wife will receive the husband's \$2,000 monthly benefit instead of her previous \$1,000 amount. But if the wife died first, the husband would continue receiving only his \$2,000 monthly amount because that is more than his deceased wife was receiving. Note in either case, the surviving spouse would be entitled to a one-time lump sum "death benefit" of \$255.

The surviving spouse would need to contact Social Security to claim the "death benefit" and – unless the surviving spouse

was previously receiving only a spousal benefit – also to claim the higher monthly amount, if eligible. If the surviving spouse was previously receiving only a spousal benefit from the deceased (and not entitled to SS retirement benefits on their own), then Social Security would automatically award their higher survivor amount when notified of the death.

If a surviving spouse has reached full retirement age (somewhere between 66 and 67 depending on year of birth) and is eligible for a survivor benefit, the amount of the survivor benefit will be 100% of the deceased spouse's benefit. But if the survivor claims the benefit before reaching FRA, the amount of the survivor benefit will be reduced (by 4.75% for each full year earlier). The survivor's benefit reaches maximum at the full retiresurvivor's ment age.

If a surviving spouse has not yet reached their FRA, and if they are entitled to (not necessarily collecting) their own Social Security retirement benefit, the surviving spouse has the option to delay claiming the survivor benefit until it reaches maximum at their full retirement age. And if the survivor's personal SS retirement benefit will ever be more than their maximum survivor benefit, the surviving spouse also has the option to claim only the smaller survivor benefit first and allow their personal SS retirement benefit to grow (to maximum at age 70 if desired).

With Social Security there is hardly ever a simple answer to a question but, in the example you use, if both are over their SS full retirement age:

If the husband dies first, the wife will get 100% of the amount (\$2000) the husband was receiving, instead of the small amount (\$1000) she was previously receiving.

If the wife dies first, the husband's monthly benefit will remain at \$2000, and he will get no increase in his monthly amount.

In either case, the surviving spouse will be entitled to a one-time lump sum death benefit of \$255.

The program seeks to leverage the strength of public gardens working with partners in their communities, ranging from schools, universities, and urban farms to food pantries, community gardens, local government agencies, and nonprofit organizations. This year, the program especially sought to support collaborations involving smaller public gardens, as well as organizations demonstrating a strong commitment to inclusion, diversity, equity, and accessibility.

Over the UARP's previous four years, the program has awarded \$1.57 million to 80 collaborations in 30 states and D.C. These programs have grown and shared over 690,000 pounds of produce, distributed more than 260,000 seedlings, and provided more than 46,000 hours of

urban agriculture training to students, interns, and trainees.

"The collaborations supported through this year's Urban Agriculture Resilience Program demonstrate many creative ways that urban agriculture can connect people and plants through food," said Dr. Susan Pell, USBG executive director. "We are thrilled to embark on a fifth year of supporting such vital urban food-growing programs across the country and to expand the existing Urban Agriculture Resilience Program community with these 26 new projects."

## Northwest Buffalo Beat

### Florida vs New York

I have been coming and going back and forth from Buffalo to Florida since 1994 so I believe I have the ability, on a personal basis, to compare the two areas. There is good, and not so good, in both. Sometimes you have to take the good with the bad but in my case, I chose to take the good only. Meaning I try to eliminate the bad in both places by being a seasonal resident, and only the good season of both.

The year-round residents of Florida call us northerners who invade their territory in the win-

ter to escape the cold and snow, "Snowbirds." I have lived with that and do not mind. The businesses love when the "snowbirds" come down as that is what keeps them alive. The residents cannot wait for them to go back home. Traffic is heavier, long waits at restaurants, food prices are in-flated to take advantage of the influx of business, whatever the market will bear, etc. Only natural for the Florida Crackers to have a disdain for us seasonal visitors. I once seen a bumper sticker that read, "If snowbirds are in season,

why can't we shoot them?" Humorous, right?

Let's compare some of the advantages and disadvantages. Taxes. There is no state income tax in Florida. Huge savings there. I have a single home in both places with approximately the same market value. Property taxes are about half in Florida as in New York. Sales tax is 6% compared to 8.75% in New York. Sounds small but makes a significant difference in higher priced items.

Insurance, New York wins that one. Florida has much higher premiums due to the elevated risk of hurricanes and flooding. Not enough to make up for the higher taxes. Auto insurance is also higher in Florida. Electricity is higher in NY, but water is much cheaper. No five cent deposits on bottles but they have a recycling program that seems to work. They give you recycling containers and pick them up every week. These are minor comparisons as the important thing is the weather.

Both places have weather advantages and disadvantages. We of course know about the winters up north. Advantage, Florida. It does get freezing cold and lots of snow and ice. 


