Total Eclipse Over Buffalo



A total solar eclipse will be observable only on Monday, April 8th, starting at 2:04 PM and beginning its totality at 3:18 PM. It will end at 4:32 PM.

A once-in-a-lifetime event is coming April 8th, a total solar eclipse and members of the City's Eclipse Task Force, along with representatives from partnering organizations and medical professionals, provided an update on the eclipse planning efforts to ensure a safe and enjoyable experience for all, including the hundreds of thousands of visitors expected to converge on the Buffalo area to view the event.

Mayor Brown said, "Four weeks from today, a

total solar eclipse will darken the skies across Buffalo for nearly four minutes. While we want this once-in-a-lifetime cosmic event to be enjoyed, we are asking City residents today to take this rare event seriously, to plan ahead if you haven't already, be patient and be prepared. With Buffalo so uniquely positioned to view this celestial event, people from around the country will be flocking here to see it for themselves. Public safety is our top priority, and we will be

ready to ensure it will be a safe and enjoyable experience for all."

During the afternoon on April 8th, Buffalo will plunge into eclipse darkness for 3 minutes and 46 seconds as the moon passes between the sun and earth. Below is the eclipse timeline in Buffalo.

- o Partial eclipse will begin at 2:04 p.m.
- o Totality will begin at 3:18 p.m.
- o Totality ends at 3:22 p.m.

Earned Income Tax Credit Puts Money In Your Pocket

If you worked in the past year you can get your federal and state taxes e-filed for free, and you may qualify for the Earned Income Tax Credit (EITC). For tax year 2023, the maximum Earned Income Tax Credit is worth \$7,430—that goes to a family with three or more qualifying children if you earn less than \$56,838 (single filers and head of households) or \$63,398 (married filing jointly). That is why I am pleased that the Erie County Clerk's Office is raising awareness of the critical support of United Way's MyFreeTaxes program.

In partnership with the IRS's Volunteer Income Tax Assistance (VITA) program, MyFreeTaxes helps filers prepare their tax returns on their own or have their return prepared for them for free while assisting low and moderate-income individuals and families with reliable assistance by opening access to tax credits and other benefit programs. Let VITA help you navigate through the somewhat confusing aspects of tax preparation including applying for the Earned Income Tax Credits.

Additionally, if you weren't aware of the Earned Income Tax Credit before now, you can file an amended return to claim them. The IRS will accept them dating back three years, to tax year 2020.

To qualify for the EITC, you must meet the basic qualifying rules which include:

Have worked and earned income under \$56,838

Have investment income below \$11,000 in the tax year 2023

Have a valid Social Security number by the due date of your 2023 return (including extensions)

Be a U.S. citizen or a resident alien all year

Not file Form 2555 (related to foreign earned income)

The IRS estimates that four out of five workers claim the EITC, which means millions of taxpayers are putting EITC dollars to work for them.

Nationwide last year, roughly 23 million eligible working families and individuals received nearly \$57 billion in EITC. The average amount of EITC received nationwide was \$2,541 and in New York State the average amount was \$2,416. Those EITC dollars had a significant impact on the lives and communities of the nation's lowest paid working people who are struggling to make ends meet.

If you think you may qualify for the Earned Income Tax Credit, I encourage you to have your return prepared through the IRS' VITA program before the electronic filing deadline of April 15th, 2024. Call 2-1-1 to make an appointment and find a free tax preparation site near you or visit myfreetaxes.com to get started.

Man Steals McDonald's Cash Register On Foot

North Buffalo
March 16, 2024
 Commonwealth Avenue - Victim states subject did slap her in the face after a verbal argument. Suspect also broke victim's glasses (\$200.00) and broke her cell phone preventing her from calling aid.

March 13, 2024
 Hertel Avenue - On 11/13/23 the defendant who is known to the family did take account information from the victim's deceased relative and did order a debit card in the deceased name. The defendant did withdraw money from several ATM locations, made several CashApp transactions and multiple purchases from several locations through 2/22/24. There was no information about the accounts due to the victim being in a rehabilitation facility and the defen-

dant taking the deceased mail. Defendant did take a piece of mail containing a \$10,000.00 bank check did forge the deceased name and cashed the same via mobile deposit. The total amount taken is approximately \$40,000.00.

West Side
March 15, 2024
 Niagara Street - Victim reports her and defendant got into an argument about keys and escalated when defendant did punch victim in her face and head. This did cause victim to have a bloody nose, knots on her forehead and scratch marks on chest.

March 15, 2024
 Niagara Street - While inside McDonalds at 2156 Niagara Street at 0859 hours on 3/15/2024, the defendant did jump behind the counter and did forc-

bly take without permission, (1) cash register with money by ripping it from behind the counter, while being pursued by McDonald's store employees. Defendant did while behind counter throw said register over the fence behind it while victim continued to pursue him. Victim also jumped fence to continue pursuit. The defendant continued fleeing southbound while holding the register with victim running behind him. While in the vicinity of the rear yard of 2128 Niagara Street, still on the thruway side of the fence, the defendant did throw register at victim. Then pulled a knife from his person and did threaten to kill victim with said knife. The defendant then fled up the embankment onto the roadway of the NYS 190 thruway. While the defendant was on the 190 thruway, the defendant did hop the center median and did stop a Black SUV by standing in front of southbound, left lane traffic and while holding a knife in his hand threatening victim, he did then forcibly remove victim from said vehicle and entered the driver's seat without permission. Lieutenant arrived on the scene on the NYS 190 South and observed the defendant next to the open driver's door of the Black BMW. The defendant jumped the median and crossed the northbound traffic lanes and ran down the embankment toward Niagara Street, lieutenant followed in pursuit and apprehended the defendant on the embankment behind the vicinity of 2146 Niagara Street. A knife matching the description was observed by lieutenant on the pavement directly below the BMW's driver's front door. Knife recovered by photo and evidence.

March 15, 2024
 Niagara Street - On 3/14/24 at 2313 hours, defendant did come into Denny's and was sat at a table in the dining room. He ordered food and a drink. Drink was given to him at the table. He stayed for a bit to drink his beverage. He

then walked to the front where the registers are set up and attempted to pry open the drawer to register. When he was not able to get it open, he ripped it from the hostess station, dropping the screen to the ground causing damage (\$275.00). Defendant then ran out of the front door with register in hand. Register was located on 3/15/24 in the parking lot of Jet's Pizza. 2165 Delaware Avenue, defendant's green long sleeve shirt was also located in the parking lot. Photos taken by detective on scene. Register and shirt submitted to evidence. Defendant was apprehended by officers on 3/15/24 at

0916 hours at 2146 Niagara Street, after fleeing from another crime. Defendant was taken to ECMC and treated for related injuries.

 West Eagle Street - On 2/20/24 at approximately 1741 hours the defendant entered 2232 Delaware Avenue Kohl's and selected numerous items from the men's and shoes department. The defendant, identified by Kohl's loss prevention, did then leave the store making no attempts to produce payment. Merchandise value estimated at \$1,500.00.



Ask Rusty – How Do Survivor Benefits Work For A Married Couple?

Dear Rusty: How does Social Security handle the death of one spouse? Say, for example, the husband receives \$2,000 per month in Social Security and his wife receives \$1,000 per month. How is the death of either spouse handled?

Thank you in advance for your service as a Social Security Advisor.

Signed: Concerned spouse

Dear Concerned: Benefits to a deceased beneficiary stop as soon as Social Security (SS) is notified of the death (notification usually done by the funeral director who handles arrangements). Benefits are not paid for the month of death, only for the preceding month when the beneficiary was alive for the entire month.

A surviving spouse is entitled to the higher of two benefits – their own personally earned SS retirement benefit, or an amount based on the deceased spouse's benefit at death. In the example you cite, and assuming the surviving spouse has reached full retirement age (FRA): if the husband dies first the wife will receive the husband's \$2,000 monthly benefit instead of her previous \$1,000 amount. But if the wife died first, the husband would continue receiving only his \$2,000 monthly amount because that is more than his deceased wife was receiving. Note in either case, the surviving spouse would be entitled to a one-time lump sum "death benefit" of \$255.

The surviving spouse would need to contact So-

cial Security to claim the "death benefit" and – unless the surviving spouse was previously receiving only a spousal benefit – also to claim the higher monthly amount, if eligible. If the surviving spouse was previously receiving only a spousal benefit from the deceased (and not entitled to SS retirement benefits on their own), then Social Security would automatically award their higher survivor amount when notified of the death.

If a surviving spouse has reached full retirement age (somewhere between 66 and 67 depending on year of birth) and is eligible for a survivor benefit, the amount of the survivor benefit will be 100% of the deceased spouse's benefit. But if the survivor claims the benefit before reaching FRA, the amount of the survivor benefit will be reduced (by 4.75% for each full year earlier). The survivor's benefit reaches maximum at the survivor's full retirement age.

If a surviving spouse has not yet reached their FRA, and if they are entitled to (not necessarily collecting) their own Social Security retirement benefit, the surviving spouse has the option to delay claiming the survivor benefit until it reaches maximum at their full retirement age. And if the survivor's personal SS retirement benefit will ever be more than their maximum survivor benefit, the surviving spouse also has the option to claim only

the smaller survivor benefit first and allow their personal SS retirement benefit to grow (to maximum at age 70 if desired).

With Social Security there is hardly ever a simple answer to a question but, in the example you use, if both are over their SS full retirement age:

If the husband dies first, the wife will get 100% of the amount (\$2000) the husband was receiving, instead of the small amount (\$1000) she was previously receiving.

If the wife dies first, the husband's monthly benefit will remain at \$2000, and he will get no increase in his monthly amount.

In either case, the surviving spouse will be entitled to a one-time lump sum death benefit of \$255.

- o Totality lasts 3 minutes and 46 seconds

- o Partial Eclipse ends at 4:32 p.m.

- o Overall eclipse duration: 2 hours 28 minutes; During totality, it will become dark even if cloudy.

With crowd estimates of "half-a-million" to a "million" converging on our area, City officials today asked residents to take this event seriously and prepare in advance, much like they would for a winter storm. They want everyone to enjoy this historic moment, but to do so in a smart and safe manner. Below are highlights of today's eclipse update, beginning with the need for everyone to plan in advance and take the necessary precautions, leading up to the event.

- Going to a grocery store, picking up a prescription, or going to the gas station might be virtually impossible on the day of the Eclipse. Officials recommended that people get those things done days in advance or reschedule appointments.

- City residents should plan for (and anticipate) heavy traffic congestion and possible gridlock on April 8th, potentially throughout the entire day and into the evening. Traffic congestion has been an issue at prior eclipse events.

- EMS services may be delayed. Make sure your loved ones have a sufficient quantity of medication on hand.

- City officials say the best place to view the eclipse is from home. There's no need to travel or go to an elevated area. The eclipse will be viewable no matter where you are.

- If City residents plan to attend a viewing party, they urge people to attend one that is in walking distance. Whether it be at a park, at a restaurant or

some other location - stay close to home and walk!

- If you need to drive to an event, like the Outer Harbor or Sahlen Field, the message is simple: Leave early and be prepared to stay late. There's the potential for a long and slow drive home (much like winter storm traffic)! Pack extra food and water in your vehicle.

At today's eclipse update, Dr. James D. Reynolds, professor and chair at The Ross Eye Institute, issued a reminder to people to make sure they protect their eyes when viewing the solar eclipse. He and other medical professionals say that the only safe way to look directly at the un eclipsed or partially eclipsed Sun is through special-purpose solar filters, such as "eclipse glasses". Eclipse glasses are available through several organizations throughout Buffalo, including BuffaloEclipse.org.

To business owners in the City of Buffalo, City officials strongly urged them to have a plan in place for their employees.

- Obviously this is a big event for Buffalo's hospitality and tourism industry. With so many visitors expected, they want these dining and retail businesses to take advantage of this opportunity but to do so in a smart and safe way.

- To Buffalo's non-dining and non-retail business owners, City officials asked them to consider having their employees work from home on Monday, April 8th, or close all together.

Additional information on how to safely view a Total Solar Eclipse in Buffalo can be found on the City's eclipse webpage, www.buffalony.gov/eclipse. Previously announced eclipse updates included the following.

- Families are being encouraged to create a

communication and an emergency plan (or meeting place), as cell phone disruptions may occur on April 8th, meaning people might not have cell service at all for extensive periods of time on that day. When there are too many people in an area, the cell towers get jammed. For more information, go to <https://www.ready.gov/plan> or click here to Create. Your Family Emergency Communication Plan (ready.gov).

- City parks will be open on April 8th but all pre-scheduled activities, (like spring sport practices on fields and diamonds) will not be scheduled on that day. In the days leading up to the event.

- City crews will be putting up fencing at some City parks to prevent potential damage to the grass from vehicles. Extra garbage and recycling totes will be placed in strategic locations to address potential littering.

- Sanitation will begin early on Monday, April 8th. If a resident's garbage pickup day is on Monday in the City of Buffalo, they should take their garbage and recycling totes to the curb on Sunday night.

- If an organization is planning to host a large-scale eclipse event on City-owned property (i.e. streets, sidewalks, parks, etc.), they must complete a City of Buffalo Special Events application, a minimum of 30 days in advance. 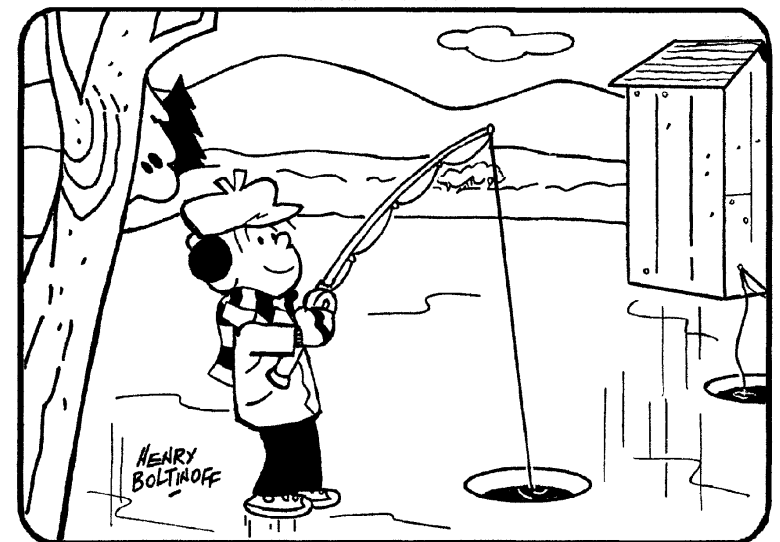

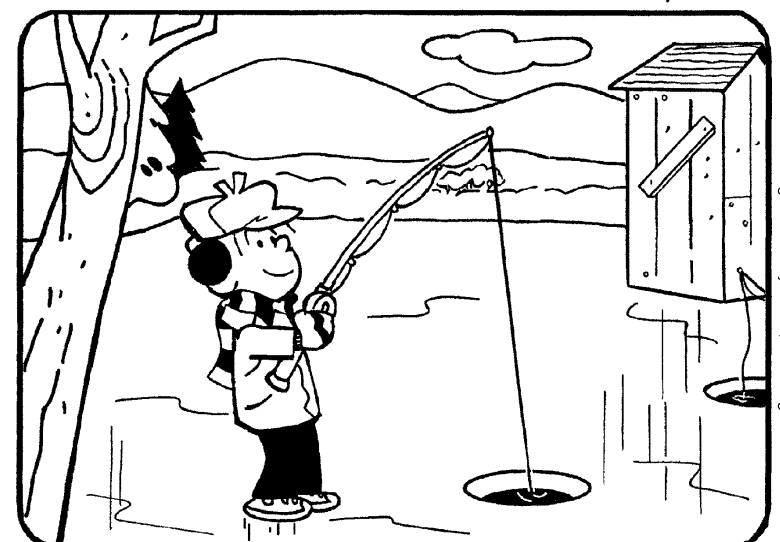

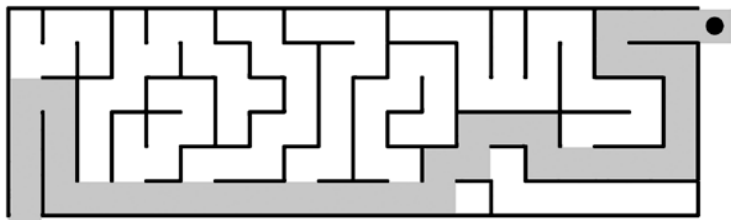
