## Rocket Man

## He Lived Long and Prospered



Rocket Man's year-end verses do not spring full-blown from his transmitter in late December. All year long he squirrels away couplets of news events and notable call-ups, such as this, jotted down last week, filed for publication next Dec. 31st:

"twas 83, so was no shock  
When heaven beamed up  
Mister Spock."

Rocket Man and the Spockman have a past, confirmed by a photo display at Rocket headquarters -- Mr. Smith and Mr. Nimoy, the once-and-future Vulcan submitting to an interview on the occasion of the release of "Star Trek IV," stardate sometime in 1986.

Ah, if only Rocket Man were Brian Williams, he could remember their ban-

ter in detail. In truth, he doesn't, not a word. Logically, that says a whole lot more about the state of Rocket Man's memory banks than it does about Leonard Nimoy as an interview subject.

Niagara Gazette City Editor Mark Sheer sent him off in style Monday: "Most of us didn't know Nimoy, of course. We just loved the character he played so well for so many years. Mr. Spock is one of those iconic figures, a made-up person who manages to somehow infiltrate our collective consciousness and have a lasting impact on popular culture. In our quirky universe, Nimoy was a big part of the family."

Clearly, you needn't toil in the entertainment ghetto or have your picture in a Hertel Avenue display window to craft affection for this unique character and the extraordinarily ordinary man who gave him flesh.

William Shatner. Ah, now there's a memorable

interview, a man so full of himself there's no room for anything else, in a league with Jane Fonda and Wilfred Brimley.

Rocket Man: "Mr. Shatner, this is a funny movie, too. What will the fans say about that?"

Shatner: "They'll say we made a funny movie."

History would later hail "TV" for its rich humor, particular Spock's difficulties in coping with contemporary jargon. Shatner, though, was far too self-absorbed to define or assess the motives for this change in style. As the director, Nimoy surely did, but Rocket Man is darned if he can recall. This suggests only that he was civil and conventional.

Rocket Man had seen Nimoy on Broadway, as a psychiatrist in "Equus" in 1977. This was "between engagements" for Mr. Spock, the TV series cancelled, the movies yet in some far frontier where no investor feared go. He was superb, and an artist, as well. However, in trying to refresh his memory via volume and internet, Rocket Man learned that Nimoy had fallen victim to alcoholism during the series, so perhaps he didn't remember the interview, either.

The solemn, logical man with the Vulcan eardo wrestled constantly with the dilemma of the greater good vs. the individual. In the end, both won. Nimoy lived long; we prospered. Memory, why have you failed me now?
