

Tips to Stay Safe During Winter Storms

The American Red Cross, Western New York/Finger Lakes Region is monitoring developments and is prepared to respond if necessary. With temperatures dropping below zero degrees, along with winds that make it feel even colder as well as several inches of snow, the Red Cross urges residents to prepare for the bitter cold and treacherous driving conditions.

Cold Safety Tips:

- Wear layers of lightweight clothing to stay warm. Gloves and a hat will help prevent losing body heat.

- After the storm, be extremely careful if you have

to shovel snow. It is physically strenuous work, so take frequent breaks and stay hydrated.

- Seek medical attention immediately if you have symptoms of hypothermia, including confusion, dizziness, exhaustion and severe shivering.

- Watch for symptoms of frostbite, including numbness, flushed gray, white, blue or yellow skin discoloration, numbness, or waxy feeling skin.

- Don't forget your pets – bring them indoors. If they can't come inside, make sure they have enough shelter to keep them warm and that they can get to unfrozen water.

- Avoid frozen pipes – run water, even at a trickle, to help prevent them from freezing.

Open the kitchen and bathroom cabinet doors to allow warmer air to circulate around the plumbing. Be sure to move any harmful cleaners and household chemicals out of the reach of children.

Keep the garage doors closed if there are water lines in the garage.

Keep the thermostat at the same temperature day and night. Your heating bill may be a little higher, but you could avoid a more costly repair job if your pipes freeze and burst.

Indoor Winter Precautions

In extreme frigid weather like that courtesy of the 'Polar Vortex', residents may seek alternative methods to keep their homes warm and their houses supplied with power during outages caused by the storm.

The Erie County Department of Health ("EC-DOH") offers these important guidelines to stay safe during these dangerously cold temperatures.

"Everyone needs to be mindful of the dangers of Carbon Monoxide ("CO") poisoning" states Erie County Commissioner of Health, Dr. Gale Burststein. "Improper use of generators or portable space heaters can silently poison you and your family without your knowledge. Carbon Monoxide is a poisonous gas that can literally kill you in minutes. It is invisible, tasteless, odorless and non-irritating which is why taking proper precautions is vi-

tal and having sufficient working CO detectors in your home is critical."

Follow these tips to stay safe:

- When using portable generators, never use them indoors and make sure they are at least 20 feet away from your dwelling.

- NEVER use your oven or range to heat your home.

- NEVER use a charcoal grill, camp stove or other charcoal-burning or gasoline-powered device inside your home, basement, garage or near a window.

- NEVER idle a car in the garage.

- NEVER sleep in rooms where unvented gasoline or kerosene heaters are present.

- Check or change the batteries in your CO detectors every 6 months.

- If you do not have a battery-powered or battery-backup CO detector, make buying one a priority.

Rocket Man

'Saving Mr. Banks'

Mary Poppins may have been practically perfect in every way, but her purvey-or was a pain. After literary testimony, now comes "Saving Mr. Banks," story behind the movie that has captured our hearts and ears since 1962.

(For the record, Rocket Man adores "Mary Poppins." He and his first Little Booster used to duel for decibels with "Super-cali.." in the backyard. When we finished, next-door neighbors applauded, and they were putting on a roof.)

Reportedly, Walt Disney wooed the author known as P. J. Travers for a score of years. She felt her rights would be wronged. Disney she saw as tacky as toffee, all cartoons and giddiness. Her creation she considered closer to a movie character who would surface much later, "Nanny McPhee."

Time doesn't heal all wounds, but poverty provides a poultice. The author is on her uppers when she deigns to meet with Mr. Disney. That's what

she calls him, though he insists on "Walt," even from the least of his associates. He, along with everyone around him, calls her "Pam," or "Pamela," deeply offending her sense of propriety.

Nothing satisfies her, not even the stage directions on the opening page, never to be seen or heard by general audiences. No songs, no cartoons and certainly no sense of romance between Mary and chimney-sweep Bert, who, by the way, must NOT be played by Dick Van Dyke. The Julie Andrews issue never seems to arise.

On it goes. Rocket Man would have shown this shrew the door on day three. Walt, though, seems obsessed with keeping a promise he made to children long since grown. Or, perhaps, he just wanted it because it was there. No sense of Walt the unfettered, rapacious empire builder ever surfaces in "Saving Mr. Banks." After all, this is a Disney movie.

The tedious negotiations

are intercut with scenes of the author's childhood, and there isn't enough sugar in the world to make this medicine go down. Since "Poppins" was recently cited as a national treasure, it's no spoiler to report that Walt gets what he wants.

There've been some marvelous behind-the-scenes movies lately, notably "My Week with Marilyn" and, a couple years back, the late Peter O'Toole's "My Favorite Year." Each had memorable moments in multiples. In this, "Mr. Banks" falls short. Except for the scene in which he deigns to dance to "Fly a Kite," there's not a sincere frame in two hours, and precious little comic relief, as well. Tom Hanks plays Disney as if in a strait-jacket. Emma Thompson's emotions range from A to B. Rocket Man did find something genuine in the work of Paul Giamatti as Pamela's – uh, Mrs. Travers' – driver.

This is a minority opinion. Most critics and civilians have expressed fondness for "Mr. Banks." Rocket Man holds that the man wasn't saved, just mummified. SIX ROCKETS (out of 10). Next week – "Grudge Match."

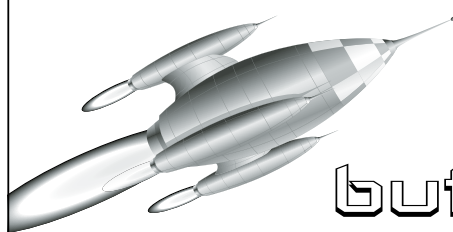

Protect Your Family & Pets from Rabies. There will be a free rabies vaccination clinic on Wednesday, January 29th, 2014 at the North Buffalo Community Center. The clinic, conducted by the Erie County Department of Health in association with the Niagara Frontier Veterinary Society, the Medaille College Veterinary Technology Department, and the SPCA serving Erie County, will provide free rabies vaccinations for dogs, cats, and ferrets.

"These vaccinations are a good way to minimize any problems that may arise from contact between wildlife, pets and possibly their human owners" said Dr. Burstein, Erie County Health Commissioner. "If residents or their pets have been exposed to a

wild animal, or bitten by a dog or cat, they should contact the Erie County Department of Health at 716-961-6800."

Residents are requested to bring their pet to the clinic either on a leash or in a carrier, and if possible, to bring along the animal's vaccination record.

What can you report to 311? 311 should only be used for non-emergency calls. If you have an emergency, please call 911. Some of the issues that you can report to 311 include dangerous sidewalks, pot holes, faulty street lights, snow removal issues, housing complaints, graffiti removal requests, and animal complaints. You can contact the City's 311 Call and Resolution Center simply by dialing 311 (or 851-4890). You can also report and track your complaint online.

Problems can be reported anonymously, but you will need to provide your contact information in order to be updated on the situation's progress. Please note that if you receive a reply that your case is closed, it doesn't always mean the

problem is solved, but that the case has been referred to the appropriate agency or department.

Not Too Late For Flu Shots

It's not too late to get a Flu Shot! According to the United States' Centers for Disease Control and Prevention ("CDC"), New York State is one of ten states reporting geographically widespread flu. Along with the rest of New York State, the number of reported cases in Erie County is also on the rise.

"In the past two weeks, reported cases of influenza have jumped significantly" states Dr. Gale Burst- ein, Erie County Commissioner of Health. "Similar to the 2009 flu season, the majority of those falling ill with this flu strain are between the ages of 18 and 49 years old. However, no matter what your age, you are at risk of getting influenza if you have not been vaccinated during this flu season. Everyone at least 6 months of age should receive the flu vaccine as soon as possible to stem the spread of this disease. While the vaccine

is not 100% effective, it offers the best protection we have against this very serious disease." Burst- ein continues: "Frequent hand-washing is the most important health tip for all of us to remember so that we don't spread illness. When sneezing or cough- ing, be sure to turn away from others and use a tis- sue to cover your mouth or nose and sneeze into the crook of your arm, rather than into your hands." What exactly is the Flu? It is a contagious respiratory illness caused by influenza viruses, which can cause mild to severe illness. It is especially important for certain populations at high risk for serious flu compli- cations to get vaccinated. Those people include:

- People who are at high risk of developing serious complications like pneumonia if they get sick with the flu.
- People 65 years and older.
- People who are immu-

nosuppressed, where their body's immune system or ability to fight off infec- tion may be impaired or not working as effectively.

- People who live with or care for others who are at high risk of developing serious complications.

- Health care providers.
- Young children, espe- cially those under 2 years of age.

Symptoms of the Flu are fever or feeling fever- ish/chills (although not ev- eryone with flu will have a fever); cough; sore throat; runny or stuffy nose; mus- cle or body aches; head- aches; and fatigue. How is the Flu Spread? Flu is spread mainly by droplets made when people with flu cough, sneeze, or talk. These droplets can land in the mouths or noses of people who are nearby. Less often, a person might get flu by touching a sur- face or object that has flu virus on it and then touch- ing their own mouth, nose, or eyes.

- Avoid driving when conditions include sleet, freezing rain, snow or dense fog.
- If travel is necessary, make sure you have a disaster supplies kit in your vehicle which includes: shovel, blanket, flashlight, water, snacks, first aid kit, and extra batteries.
- Keep the gas tank full. A full tank will keep the fuel line from freezing.
- Heating systems are running at full force and many people are resorting to other sources to keep their homes warm. To avoid fire danger, you should remember the following:
 - Never use a stove or oven to heat your home.
 - If you are using a space heater, place it on a level, hard surface and keep anything flammable at least three feet away – things such as paper, clothing, bedding, curtains or rugs.
 - Turn off space heaters and make sure fireplace embers are out before leaving the room or going to bed.
 - If you are using a fireplace, use a glass or metal fire screen large enough to catch sparks and rolling logs.
 - Use generators correctly – never operate a generator inside the home, including in the basement or garage.
 - Don't hook a generator up to the home's wiring. The safest thing to do is to connect the equipment you want to power directly to the outlets on the generator. For additional winter storm preparedness tips, please visit <http://www.redcross.org/prepare/disaster/winter-storm>.
