31st Annual National Night Out

The National Association of Town Watch (NATW) has announced that the 31st Annual National Night Out (NNO) program will culminate on Tuesday, August 5, 2014.

NNO 2013 involved over 37.8 million people in 16,242 communities from

all 50 states, U.S. territories, Canadian cities, and military bases worldwide. National Night Out 2014 is expected to be the largest ever.

National Night Out, a yearlong community building campaign, is designed to heighten crime

prevention awareness, generate support for, and participation in, local anticrime programs, strengthen neighborhood spirit and police-community partnerships, and send a message to criminals letting them know that

This Saturday, August 2nd, (and every first Saturday of the Month) the City of Buffalo Engineering Garage, located at 1120 Seneca Street (between Smith St. and Babcock St), will be open for city residents to properly dispose of their e-waste for recycling. Residents can drop off their old electronic waste for recycling this Saturday

between the hours of 8 am and 2 pm. Electronics recycling services are still available year-round at the Engineering Garage Monday to Friday, 8 am to 3 pm.

Senior citizens or disabled residents who have limited transportation can also contact the Division of Citizen Services (311 or 851-4890) to make special arrangements for e-waste recycling collection.

"Million-Dollar Arm"

It took Rocket Man so long to run down the movie "Million-Dollar Arm," he felt as if he were executing a "pickle" at Shoshone Park. Between other details, real-life ballgames and the occasional deer strike in Allegany County, he didn't get to slap the tag on the Superagent vs. the Subcontinent saga until after Independence Day.

It's probably on Netflix now, or some of those other systems outside his technological expertise. He didn't expect much but he wasn't disappointed and he thinks it's worth your time although, like most professional ballgames, it could probably be 20 minutes shorter.

"Million-Dollar Arm." That's a good one. At today's prices, that doesn't get you a month's rotation. And it's "a true story." Yeah, so is "Music Man," in a way. And here's the pitch ...

A fading agent (that's

the best kind) needs a new wrinkle, dead broke though he lives palatially and drives a car worth more than sum of the whole Clutter City parking lot. In something of the style of a non-baseball movie titled "Slumdog Millionaire," he decides to run a contest in India to try to find a hurler with major-league capabilities, and in the process, open up baseball to another billion fans.

He's inspired by the pace of cricket bowlers. Rocket Man would play cricket this morning if he could find a match, but that laconic game, which almost makes soccer look interesting, has little to do with what happens in "Million-Dollar Arm," counter to the claims of the movie's misleading promos. Neither finalist has ever intentionally touched a cricket ball.

Like so many other India-themed movies, notably "Best Exotic Marigold

Hotel," it makes much of the crowds and evident poverty there. One critic denounced it as stereotypical. But if it's true? Well, anyway, two candidates make their way to the U.S., fish far out of water.

Along the way, the agent, somewhat inspired by the woman who lives as a tenant on his estate (remember, he's broke), comes to an awakening about loyalty and the richness of relationships over Porches. Yeah, you've seen it ALL before, but it's nicely packaged (if too long) and the visitors' response to the agent's budding romance has a chick-flick charm that engaged even grumpy old Rocket Man.

His favorite characters were Bill Paxton, who almost convinced Rocket Man that he IS baseball coach at Southern California, and Alan Arkin as a nearly comatose old scout who can time a pitch by its sound better than can most of his gun-toting peers. Much of "Arm" is pure hokum but Arkin's bird dog is right on the money. Not much baseball, but still decent filler for a rain delay.

computers and electronics, which often contain hazardous substances, such as lead, mercury, and PCBs (polychlorinated biphenyls), can contaminate our air, soil and water. Through proper disposal methods or recycling, these hazardous substances are reprocessed and reused in an environmentally responsible manner.

Items accepted include: computer systems (CPU's, monitors, mice, keyboards, printers, scanners), cell phones, fax machines, wires, televisions, video games, VCRs, DVD players, small appliances, microwave ovens, fluorescent bulbs.

Unaccepted items include: concrete, devices with liquid mercury, dry/

wet cell batteries, hazardous waste/pesticides, yard equipment, gas powered equipment, radioactive materials, roofing material.

New York State Regulations prohibit the City of Buffalo from picking up electronic waste at the curb. Residents who illegally place e-waste at the curb could be issued a summons, with a \$75 fine.


