## Devonte Smith-Pelley: An Upgrade at Forward

While the Buffalo Sabres would like to add another top six forward as they did last summer with Jeff Skinner, the team needs even more help on their bottom six where Vladimir Sobotka was not only the worst player on the team but likely the worst player in the league. Zemgus Girgensons and Johan Larsson are serviceable hard working players but have had little effect in Buffalo on a team perpetually stuck in rebuild mode. These three players contribute very little offense and have seen so much losing here that It is clear that they will not be part of turning around the direction of the franchise. Replacing Sobotka shouldn't be a major challenge.

Scouring around the

list of unrestricted free Agents (UFA) for an upgrade over Sobotka, the name Devonte Smith-Pelly stands out. The bruising 225 lb forward played a key fourth line role on the Washington Capitals 2018 Stanley Cup Championship team with seven goals in 24 games.

He scored two goals in the first round and two more in the Eastern Conference final against the Tampa Bay Lightning, including a key insurance goal in game six. But he was at his best on hockey's biggest stage, the Stanley Cup finals.

Smith-Pelly scored in games three, four and five of the helping the Capitals to win their first championship. He dented the twine in Washington's 3-1 victory in game three of cham-

pionship series versus the Vegas Golden Knights and scored again in game four in the Capitals 6-2 win. But his biggest contribution came in game five with his team trailing 3-2 midway through the third period when Smith-Pelly pressured Las Vegas defenceman Luca Sbisa on the forecheck before skillfully coralling Brooks Orpik's point shot and sliding home the tying goal. Lars Eller scored the game winner just two minutes 31 seconds later.

Instead of cashing in on his productive postseason performance, Smith-Pelly took less money and a one year deal for \$1,000,000 to stay with the Caps. He then had a terrible 2018-19 season with only four goals and eight points in 54 games before being placed on waivers and sent to the minors. He went unclaimed by any NHL team and reported to Washington's farm team the Hershey Bears where he had six goals and 14 points in 20 AHL games. He appeared in three playoff games for Washington without picking up a point.

Smith-Pelly was a second-round pick by Anaheim in 2010, and has 44 goals and 101 points in 395 regular season games with the Capitals, Devils, Ducks and Montreal Canadiens. He also has 16 points (13 goals, three assists) in 51 playoff contests.

With the Sabres over the salary cap they can't do much to tweak the roster until some anticipated trades happen and clear up some cap room. At that point a player like Smith-Pelly provides a low risk affordable upgrade for their fourth line.

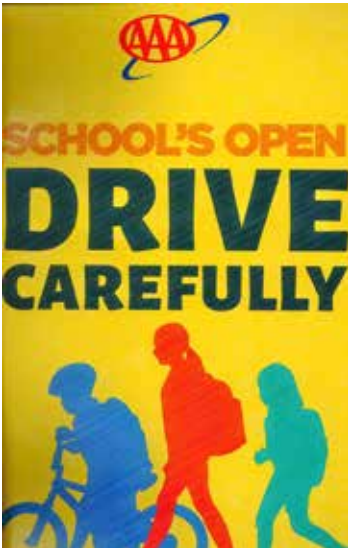
**September 1, 2019**

## Radio to Television

In last week's column. I wrote about how in my younger years, and radio was in its infancy. This amazing electronic device that changed our way of living. Having the ability to hear voices and sounds from a location other than your immediate area. Learning about sending signals through the air and into your home for you to listen to. Thought that was the cat's meow. What will they think of next? Then one day a radio store on Grant and Ferry, had a thing in the window that was said to be the beginning of a new era. Here on display in the window, was a small wooden box with a round tube in the middle that lit up. On this black and white tube were people talking and moving just like in the movies. It had a tiny picture as the tube was probably eight inches around. Still this seemed so amazing at the time. Needless to say there was always a crowd standing in front of the window watching whatever was playing on this little electronic miracle.

It was to become the newest way of communicating and entertaining. They were able to take live shots of talking people and pictures, send the signal from a transmitter, through the air to a television receiver. First there was the telegraph, then telephone and now television. The first television I ever seen was in this window on Grant. Soon other store had them in their windows. At first they were too expensive to buy. Finally they became available to the public. Pricey and with a limited number of things to watch. When they became affordable they had shows to watch. Enough to have a small demand for those who could afford them. That was not us.

We happened to have a family that lived upstairs from us on Fargo, the Capozzis. One of the daughter had saved enough money to buy one of the first ten inch television set. This was

a big deal. Every Saturday night we would all go upstairs and watch "Our Show of Shows" with Sid Caesar and Imogene Coca. My family and her family and some others. Maybe about twenty of us. It was like watching a free movie in the comfort of a house on this tiny little ten inch screen. You could talk to each other during the commercials. One commercial, Texaco. Showed four men servicing your car. One pumps the gas, one checks the oil, one cleans the windshield and the last wipes down you hub caps.

Wipes the hubcaps? Still remember the words to the song they sang in the commercial. Had to have an antenna called rabbit ears to receive the signal.

The test pattern was maybe the most watched screen as it was on before and after the programming came on and went off. Channel four was the only channel in the beginning and after they added channel two and seven. Three channels, wow. After we had our eighth child the priest said maybe we should get a television set and use that for entertainment. My wife agreed. By this time there were many shows and television was on from morning till midnight. We got a nice 18 inch black and white in a blond box with legs. Two more channels were added, 17 and 29 but they were a bit different. Problem was with all those channels, you had to get up to switch from one to the other. Used the kids to do that. Then bought a remote. Had a wire that went from the chair to the TV. But you were able to change channels without getting up! Cool.

I remember in high school a speaker came and said someday they will have color television. That was hard to believe, but as we know now, it did happen. Of course when it first came out, they were too expensive for the average person to buy, but my Uncle Jack was able to get one. So every Sunday afternoon

we would truck out to Williamsville to watch Walt Disney World in full color. His screen was a whopping 23 inches.

We became addicted to shows like Howdy Doody, Gunsmoke, Wyatt Earp. Ed Sullivan to name a few. "Eleven o'clock, do you know where your children are?" The news was on with Irv, Rick and Tom. Channel seven was the dominate news station. Like Clip Smith, who worked there and for the Rocket said, 2 and 4 does not add up to seven. Today we watch a 53 inch or bigger TV with hundreds of channels and full time news. We watch things happened all over the world while they are happening. Do you think when I was a young lad, I would have thought it would come to this? Next they will have a tele item. Send an item across the airwaves, maybe even a person. Transmit a person from one coast to the other in seconds. What a way to travel. Far-fetched? I thought color television was too.

### Ask Rusty - Confused About Survivor Benefits

*Dear Rusty: My husband passed away in 2013 just a few days short of his 63rd birthday. I was 56 at the time and when I went into the Social Security office to notify them of his death I was told I would be able to get a partial draw when I turned 60. Two years after that I was told that I would never draw anything from his account as the rules had been changed, and since he had never drawn Social Security that his benefits were eliminated. I am 62 and intend to keep working but any information you have might be helpful. Signed: Confused Survivor*

Dear Confused Survivor: You've certainly been given some conflicting information, so I'll try to clarify. If your husband had accumulated enough quarter credits to be eligible for Social Security, you are eligible for a survivor benefit even if your husband was not yet collecting Social Security (SS) benefits when he passed. To be eligible for SS, your husband would have needed to work for about 10 years for an employer which participated in Social Security program (meaning, both your husband and his employer

paid SS FICA payroll taxes on his earnings). Most U.S. employers participate in the Social Security program. However, if your husband worked his entire career as an employee of a state or local government which does not participate in SS, or if he worked for the Federal government under their "CSRS" program, or if he worked for any other entity which didn't participate in Social Security, he may not have had enough SS credits to be eligible. But if he contributed to Social Security for at least 10 years and had at least 40 credits (can earn 4 per year) then he would have been eligible for SS, and you would be eligible for a survivor benefit from his record.

The rules haven't changed for any of this. If your husband was at least eligible for SS (not necessarily collecting), you became eligible for a survivor benefit at age 60 although it would have been reduced by about 28.5% from what you would get at your full retirement age (FRA). You are still eligible for the survivor benefit but, if you take it now at age 62, it will still be reduced for claiming before your FRA,

and since you are still working you'll also be subject to Social Security's earnings limit (\$17,640 for 2019). If you exceed the earnings limit, SS will withhold from future benefits \$1 for every \$2 you are over the limit, which would mean you wouldn't get benefits for some months until they recover what is due. If your current earnings are high, it may not be prudent to claim early SS benefits even if you're entitled to them. The earnings limit changes annually, is considerably higher (by 2.5 times) in the year you reach your FRA and goes away once you reach your full retirement age.

For your awareness, the survivor benefit reaches the maximum amount when you reach your full retirement age (but is reduced if you claim it earlier). You have the option to restrict your claim to survivor benefits only, and you may want to do this if your own SS benefit from your lifetime earnings record will be more at age 70 than your survivor benefit will be at your FRA. Your goal should be to collect the highest benefit possible for the rest of your life. If you so choose, you can collect your survivor benefit first and delay your own SS benefit past your full retirement age, which would allow you to earn delayed retirement credits on your own benefit. That will increase it by 8% per year of delay, up to age 70 when your maximum Social Security retirement benefit will be reached, and at that time you would switch to the higher benefit.
