Memphis Belle And Rare P-40 Take Flight Over Buffalo



“Memphis Belle”, a restored WWII B-17 “flying fortress” bomber and Rare Curtiss P-40 Warhawk will take to the skies over Buffalo.

The restored World War II Boeing B-17 Flying Fortress “Memphis Belle” and a newly restored Curtis P-40E Warhawk will take to the skies over Buffalo. Public flights will begin in the morning with ground tours in the afternoon. Hours are

from July 21st - 22nd from 10AM to 5PM each day.

The Liberty Foundation’s Boeing B-17 “Memphis Belle” is one of only 13 B-17’s that still fly today. The B-17 dubbed the “Flying Fortress” as a result of her defensive fire power saw

action in every theater of operation during WWII.

The majority of all WWII B-17’s were operated by the 8th Airforce in Europe and participated in countless missions from bases in England deep into enemy territory. There were 12,732 B-

17’s produced between 1935 and 1945, of these 4,735 were lost in combat. Following WWII, the B-17 saw combat in three more wars, B-17’s saw service in Korea, Israel used them in the war of 1948 and was even used during Vietnam.

“Memphis Belle” was built toward the end of the war and never saw any combat. It is painted in the colors and nose art of the original historic “Memphis Belle” B-17 that flew countless missions with the 91st bomb group of the mighty 8th Airforce, and was the first B-17 to complete 25 missions.

The Curtiss P-40 Warhawk was an American single-engine, single-seat, all-metal fighter and ground attack aircraft that first flew in 1938. It was used by the air forces of 28 nations, including those of most Allied powers during World War II, and remained in front line service until the

end of the war. By November 1944, when production of the P-40 ceased, 13,738 had been built, all at Curtiss-Wright Corporation’s main production facility at Buffalo, New York.

P-40s first saw combat with the British Commonwealth squadrons of the Desert Air Force (DAF) in the Middle East and North African campaigns, during June 1941. The Royal Air Force’s No. 112 Squadron was among the first to operate Tomahawks, in North Africa, and the unit was the first to feature the “shark mouth” logo, copying similar markings on some Luftwaffe Messerschmitt BF 110 twin-engine fighters. Inspired by 112 Squadron’s usage of them in North Africa, and by the Luftwaffe’s even earlier use of it, both via Allied wartime newspaper and magazine article images, the “shark mouth” logo’s usage on the sides of

Precautions During Excessive Summer Heat



Erie County Health Commissioner Dr. Gale Burstein today urged residents to take extra precautions

during hot weather to avoid heat-related health emergencies such as heatstroke, heat exhaustion and heat cramps.

“It’s very important to plan ahead and be ready for hot weather, particularly for the very young and the very old,” said Burstein. “Try to drink plenty of non-alcoholic liquids, wear loose-fitting clothing, and try to be in an air-conditioned or shady area as much as possible. Also, try to avoid overwork during the hottest parts of the day, such as the afternoon.”

Residents are encouraged to be aware of the warning signs of heat cramps, heat exhaustion, and heat stroke.

Heat cramps are painful, involuntary muscle spasms that usually occur during heavy exercise in hot environments. Inadequate fluid intake often contributes to heat cramps. Muscles most often affected include those in the calves, arms, abdomen, and back. If you suspect heat cramps: Rest briefly and cool down; drink clear juice or an elec-



trolyte-containing sports drink; practice gentle, range-of-motion stretching and massage of the affected muscle group; if cramps don't go away within one hour, call your doctor.

Heat exhaustion can range in severity from mild heat cramps to heat exhaustion to potentially life-threatening heatstroke. Signs and symptoms of heat exhaustion often begin suddenly, sometimes after excessive exercise, heavy perspiration, and inadequate fluid intake. Symptoms may include: feeling faint, nausea, heavy sweating, ashen appearance, rapid, weak heartbeat, low blood pressure, cool and moist skin, and low-grade fever. If you suspect heat exhaustion: get the person into a shady or air-conditioned area;

lay the person down and elevate the legs and feet slightly; loosen or remove the person's clothing; have the person drink cool water (not iced) or a sports drink containing electrolytes; cool the person by sponging them with cool water and fanning; monitor the person carefully.

Heatstroke, which is similar to heat cramps and heat exhaustion, often results from heavy work in hot weather. Risk factors for this potentially life-threatening condition are age (older adults), obesity, dehydration, cardiovascular disease, alcohol use, and certain medications. Signs and symptoms may include: body temperature of more than 104 degrees; rapid heartbeat; rapid and shallow breathing; elevated or



low blood pressure; cessation of sweating; irritability, confusion or unconsciousness; fainting (which may be the first sign in older adults). If you suspect heatstroke: move the person out of the sun and into a shady or air-conditioned area; dial 911; cool the person by covering him with damp sheets or by spraying with cool water; direct air onto the person with a fan or newspaper.

the P-40's nose was most famously used on those used by the Flying Tigers in China.

The B-17 flight experience takes 45 minutes with approximately half hour in flight. B-17 Flights are \$410 for Liberty Foundation members and \$450 for non-members. 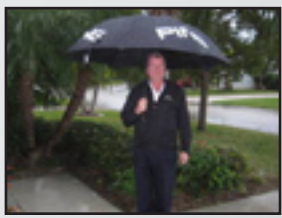
