Civil War will hold their annual ceremony at the Grand Army of the Republic Monument in Section 14 of Forest Lawn on Sunday, May 24th at 12:30 pm to honor those veterans from the Civil War buried in that section. The Grand Army of

the Republic was founded in 1866 as a fraternal and charitable organization for Union veterans of all service branches who served between 1861 and 1865. In 1868, Memorial Day was officially proclaimed by the

Rocket Man

'Love, Loss, and What I Wore'

Rocket Man possessed the only "Y" chromosome in the plus-size audience (their numbers, not their dimensions) for "Love, Loss and What I Wore" Sunday afternoon at O'Connell & Company.

He felt like a New England Patriot monitoring an opponents' locker room as they weighed such hefty options as "to bra or not to bra."

But enough about deflation. "Love, Loss etc." weaves a yarn about women and their clothes, the memories they leave on the closet floor, often on the order of "why did I buy this?" It's amusing, hilarious and a bit sad, sometimes simultaneously.

Impressario Mary Kate O'Connell joins Melissa Leventhal, Mary Moebius,

Sandra Gilliam and Darleen Pickering Hummert, a splendid and varied assortment who seem to be living every rueful word.

Only Hummert maintains a single role, basically the narrator, who remembers every dress she got married in, dating to age 20. "The youngest divorced woman in America," she claims. "Well, there IS Elizabeth Taylor."

She more or less represents author Ilene Beckerman, who actually set "Love, Loss..." in motion with a casual fashion memoir to which she then invited other women to contribute. Soon her sample case was busting its seams, as the sisterhood re-racked their memories. Sunday's gathering responded as if familiar with every pattern.

There's a running theme in which House Mother O'Connell will declare, say, "You'd be so pretty if you'd just..." followed by a fashionista fugue from the others: "Gain weight... lose weight... wear outfits," etc. From Leventhal: "Like anyone wears outfits!?"

O'Connell voices a series of nit-picking Moms from a whole United Nations of ethnicities. The sketches run from childhood memories to prison visits to serious illness, the dead-serious Moebius recalling a wrenching tale of critical surgery. O'Connell has a great bit with a purse (did you know that was considered clothing? Rocket Man didn't) which, as she says, "will never go out of style because it was never IN style."

Director Roger Paolini who crafts with considerable comfort. Gender notwithstanding, he gets it. However, the mandated readers-theater format, scripts on lecterns, creates awkward moments. If an actress goes "off script" she tends to use the page as a prop, and the slips show. In memorization theater, the performers charge right through, most audiences none the wiser.

Both its set and its actresses deliciously dressed by Tonawandas costume countess Pam Snyder, "Love, Loss..." puts on the dog (literally) up through June 7th in the comfy quarters of the Park School, 4625 Harlem Rd., showtime 7:30 Thursdays through Saturdays and 2:30 Sundays. Boyz allowed, honest.

As many as six baseball or softball games are ready to play ball but not until our National Anthem is played.

Two girls games feature Rebels versus Shamrocks and Blue Jays against Oakland A’s. Boys games ready to go are Cardinals versus the Reds, Brewers against the Marlins and Yankees versus the White Sox.

North Buffalo Baseball prides itself to be one of the premier youth leagues in the City of Buffalo. Begun in 1958, Shoshone Park has been the home for what has always been called North Park Baseball. For many years, teams were co-ed, meaning boys and girls played together on teams according to age and talent level. It wasn’t until the mid 1980’s that the amount of girls signed up to play warranted a new division separate from the boys. The results have been just as successful and in some cases, better than the boys when it came to winning regional tournaments against talent from across the State and in metropolitan areas.

scored three runs to lead the Rookie Pony Angels over the Lil Devils. Twin sisters Lia and Ava Seelbach both had two hits in the 7-2 victory.

In Minor Pony, Erin Tracy had the winning hit for the Blue Jays 1-0 win over the Yankees. Tatiana Boyd homered in the seventh inning to lead the Giants 2-1 over the same Yankee team and the Reds defeated the Orioles 5-1.

Angel Lynch knocked in teammate Julius Petti with the winning run in extra innings to lead the Red Sox to a 3-2 victory over the Royals in a Rookie Boys game. Billy LaPorta had the key hit for the Yankees in a 9-5 victory over the Blue Jays. The Indians defeated the Athletics 2-1 and the Rays topped the Orioles.

Michael Moriarty doubled to score three Cardinal runs and pitcher Brandon Lofrano pitched for the first time to help lead the team to a victory over the Reds. The Dodgers gave the Nationals their first loss of the season with a 6-4, come from behind win and the Mets defeated the Cubs, 9-3.

The League will take a day off for Memorial Day next week but be right back at it on Tuesday. Here’s hoping it’s a Big Hit !

national commander of the Grand Army of the Republic, and observed when flowers were placed on the graves of Union and Confederate soldiers at Arlington National Cemetery. New York was the first state to officially recognize Memorial Day; it did so in 1873.
On Monday, May 25th, Decoration of Graves, and Commencement of Services by the Erie County American Legion, which will host its annual ceremony at Forest Lawn to honor, recognize and salute veterans.

At 8:30 am, flags will be placed on the graves of veterans buried in the Field of Valor" and in the American Legion section of Forest Lawn.
At 9 am, the ceremony will begin in front of the American Legion Memorial Monument in the Veterans section, near the Main Street Gates.
At 10:30 am the Katherine Pratt Horton Buffalo Chapter of the National Society Daughters of the American Revolution will honor the 17 veterans of the American Revolution-ary War who are buried in Forest Lawn. A brief ceremony will be held in the area of Forest Lawn known as Franklin Square, where the remains of those originally interred at a cemetery located at Franklin Square in the city of Buffalo were re-interred in 1852. After the ceremony, a wreath and a U.S. flag will be placed at the grave of each Revolutionary War veteran.


