“Long Live Italy” is the theme for the 2016 Galbani Italian Heritage Festival on Hertel Avenue, which runs Thursday, July 14th through Sunday, July 17th.

Hundreds of thousands of visitors from around the world make the trip to North Buffalo’s Little Italy section of Hertel Avenue to celebrate of on Buffalo’s biggest ethnic festivals. This year’s Galbani Italian Heritage Festival will take place July 14th through 17th from 11 am to 10 pm on Hertel Avenue, between Delaware and Colvin.

Visitors to this year’s festival will enjoy a vast variety of Italian food from over 100 vendors featuring returning favorites such as Johnny’s Meat and their world famous Italian sausage sandwiches with peppers and onions on a fresh Luigi roll. Other Italian favorites such as canoli, gelato, Italian ice, pasta dishes, pizza stuffed artichokes,

bruschetta and the list goes on. Several American favorites will be available as well such as dipping dots, roast beef and fried dough. There will be



something sure to please every palate.

The festival will feature crowd favorites such as Grape Stomping, Bocce Ball tournament and exhibition play, for those who are serious enthusiasts, or anyone just wanting to learn.

Other returning favor-

ites include the Italians Got Talent competition, and the Italian Idol contest.

The festival is organized by three non-profit groups: The Hertel Business Association, The West Side Taxpayers’ Association and the North Buffalo Community Center, where all proceeds from the festival are distributed and used for community programs.

"It's a team game," said Max Schmarder. "I love being out there, doing what I can for the Dodgers, the Owls or any All-Star team. It puts a smile on my face and may lead me to attain All-WNY someday if we keep winning."
