

## Safer Intersections



Highly visible crosswalks were added to the crosswalk at Hertel and Colvin Avenues as well as crosswalks along Hertel Avenue.

Crosswalk enhancements have improved the visibility at the intersections of Hertel/Colvin Avenues, Hertel/Parkside Avenues, Hertel/Starin Avenues and Hertel and Parker Avenues. The Department of Public Works have made the intersections safer by adding



## The New Jack Eichel

Gone are the days of the lazy line changes, the lollygagging backchecking. The minus player with a cumulative -65 in his first four seasons. Jack Eichel is a +9 through 28 games, this number has risen over the past four games, perhaps the best four game stretch of his career.

In a November 27th OT loss to Calgary, he was a +1 with a single assist. On November 29th against Toronto he was the best player on the ice, with four points and was a +4. At Toronto on the 30th he dominated the first period before the Leafs tightened their defense to slow him down. He finished with one assists and a +1. Against New Jersey at Keybank center on December 2nd the Sabres demolished the Devils 7-1 with Eichel notching three points and finishing with a +3. That gives him three goals with five assists for eight points and a plus 9 over those four games. Not too shabby. With 17 goals and 38 points Eichel projects to over 50 goals and 111 points, which would establish him as one of the games truly elite players.

What is especially im-

pressive about Eichel's recent games is his improvement in the faceoff circle. His stats at the dot have been unimpressive at 45.5% percent as of last week. But he showed a tremendous improvement over the past four games. Against Calgary he won 50% of his draws, at home against the Leafs he was impressive winning 68.4%, at Toronto he was hot again at 54.5%. Against New Jersey he won 69.2% of his faceoffs. This is a substantial improvement which reflects his drive for improvement.

Most impressive is his plus minus stat. This measures goals for and against at even strength play. Eichel has been a minus player throughout his career. Under new

coach Ralph Krueger, the team has been tasked with defensive responsibilities. Defense is largely a matter of effort and Eichel's effort on the defensive side has been obvious. His speed is not just a weapon on offense but also on defense where his efforts have been very effective taking away time and space from the opposition.

It's a matter of maturity. Eichel is no loner a teenager feeling his way around the league. He is now a 23 year old whomis more mature physically and mentally. He plays a 200 foot game. A spectacular diving backcheck play against Toronto at Keybank Center was a highlite reel play as outstanding as any goal he will ever score. On another play he dropped to the ice to deny John Tavares a shot or path to the net leading to a turnover. These are the type of plays that help to win games that are showing that Jack Eichel is showing his desire to fulfill his considerable potential by becoming a complete player.

## The Irishman

Took out the three and a half hours of my life to watch the new movie on Netflix, "The Irishman". For example, before Hoffa, on a delivery if the customer wanted you to bring it inside, to the basement or the third floor, we had to do it. After Hoffa, it was tailgate delivery, you brought it to them, and it was up to them to unload it. Usually we worked with the customer, but no third-floor delivery. Just a small example of why teamsters loved Jimmy Hoffa.

The movie, despite the poor portrayal by Pacino as Hoffa and DeNiro, who usually plays an Italian mobster, playing an Irishman, was pretty good. If you can stay awake. It is long! Can't imagine seeing it in a theatre. Can't go back and see what you missed while sleeping. Maybe the thought is you

must see it twice to get the total story.

The casting crew wanted name actors with no thought of making it look authentic. You would think that this being a true story, the characters should at least be close. I think the thought here is what happened was so long ago most people do not remember the true facts. Few remember Jimmy Hoffa. ## Seniority

### Ask Rusty - About Survivor Benefits, My Own Benefits and Taxes

**Dear Rusty:** I am 67 and still working full time but plan to retire after June of next year. Because of my income I have not been drawing my Social Security benefits; however, my income will not be a tax issue in 2020 with my planned retirement. If I begin drawing my SS when I'm 68 next June, can I draw it retroactively to the first of the year at that rate? Or, beginning January 1, 2020, can I draw on my deceased wife's SS and then switch to my higher rate upon my birthdate in June? Signed: Exploring My Options

**Dear Exploring:** Since you are eligible for both a survivor benefit from your wife and your own SS retirement benefit you have a choice of which one to choose and when to claim. You can choose the survivor benefit first and continue to delay your own SS benefit, thus allowing your own benefit to continue to earn delayed retirement credits. You can delay until you are

70 years old or, depending upon your financial needs, you can claim your own benefit at any time, including June of next year.

Your survivor benefit from your wife will be 100% of the benefit your wife was receiving (or entitled to receive) at her death. You could have started that benefit when your wife passed, but it would have been reduced if that was before you reached your full retirement age (66). Survivor benefits reach maximum at your full retirement age (FRA), and at FRA you get 100% of your deceased wife's SS benefit. You can restrict your application to your survivor benefit if you choose to do so, and you can request up to 6 months in retroactive survivor benefits if you wish. By doing that, you are delaying the claim for your own benefit so it continues to grow in value.

Since you have not yet claimed your own SS retirement benefit, you have already been earning Delayed Retirement Credits

(DRCs) at a rate of 2/3rds of 1% per month past your FRA of 66. DRCs accumulate until you are 70 years old, when your monthly benefit would be 32% more than it would have been at your FRA and 16% more than it will be when you turn 68 in June 2020. If, instead of continuing to delay, you decide to claim your own SS benefit in June of next year, you can claim up to 6 months retroactive benefits, but doing so will move your effective claim date back 6 months and your monthly benefit amount will be permanently reduced by about 3.3%.

So, to answer your two specific questions: yes, you can claim your SS retirement benefit in June 2020 and get 6 months retroactive benefits but your benefit will be reduced as explained above. And yes, you can claim your survivor benefit from your deceased wife in January 2020 and then switch to your own SS retirement benefit in June. From a

purely financial standpoint, the latter method would give you some extra money starting in January without reducing your own SS retirement benefit. And it would also give you the option of delaying your claim for your own benefits beyond June 2020 and continuing to earn DRCs until a later time, up to age 70 if you wish. Doing so would give you a substantially higher SS retirement benefit for the rest of your life.

But in either case, the SS benefits you collect will only become part of your taxable income if your "combined income"

exceeds \$25,000 (assuming you file your income tax as "single"). Your "combined income" is your normal Adjusted Gross Income (AGI) for income tax purposes, plus 50% of the SS benefits you received for the tax year, plus any non-taxable interest you may have. If your combined income exceeds \$25,000 then up to 50% of the SS benefits you received in the tax year becomes part of your overall taxable income; if your combined income exceeds \$34,000 then up to 85% of your SS benefits becomes part of your taxable income.
