

City of Buffalo **Income Based Programs**

If your property falls inside the boundary line, you may be eligible for the following income-based programs and services listed

Emergency Assistance For low and moderate income owner-occupants, interest-free loan and conditional grant combinations are available to help you make emergency repairs. Requests for assistance should be limited to a single emergency item only. Upon inspection, two or more emergency needs may result in disqualification.

To be eligible: Property must be in generally good condition (free from structural issues and sig-



nificant health and safety hazards). You must meet income guidelines (household income at or below 80% of the HUD median income, adjusted for family size; the income limit for all city repair programs). You must have owned and occupied the home for at least 1 year prior to application. Real estate taxes, water and User Fee bills must be current.

Qualifying repairs include: Leaking roof, hazardous chimney, break in sanitary system or water service, electrical hazards at the main panel, defective heating system, defective hot water storage heater or water meter in-Continued on page four.

Ed Staniowski

Happy birthday to Ed Staniowski, born July 7th 1955 in Moose Jaw, Saskatchewan. If you're a long time Buffalo Sabres fan you might remember Ed. He was the goalie for the St. Louis Blues who nearly single handedly eliminated the Sabres from the playoffs in 1976.

Ed, was named the Canadian Major Junior player of the year as a junior. The Buffalo Sabres thought about selecting Staniowski in the first round with the 17th overall pick in the 1975 NHL draft, but GM Punch Imlach instead drafted another goalie, Bob Sauvé. St. Louis then snatched Staniowski with the 27th pick in the second round. He was the third goalie taken.

The highlight of Ed's pro career came in his first pro season, in a three game preliminary playoff series against the Buffalo Sabres in 1976. Glenn Hall called Ed's performance over the series the best he ever saw.

The 29-37-14 Blues were a heavy underdog against the 46-21-13 Sabres, who had lost in the Stanley Cup Finals the year before. Staniowski was relatively unknown having played just 11 games in his rookie season with a 5-3-2 record, a 3.20 GAA and .902 save percentage. The Blues were inspired by his strong performance to name him the playoff starter in goal for the Blues. The Sabres were led by 50 goal scorer Danny Gare and the French Connection line of Gilbert Perreault, 44 goals and 113 points, Rick Martin with 49 goals and Rene Robert with 35 goals. A two game of the Blues was expected

Game one would have ordinarily been held in Buffalo but the NBA Buffalo Braves had a game previously scheduled that night so the Sabres were forced to open the series on the road in St. Louis. Staniowski was spectacular in a 5-2 win blocking 37 shots including two amazing saves against Gare and Jerry Korab.

The next two games were held in Buffalo with the Sabres facing elimination in the best of three


series if they lost once. Buffalo turned up the pressure on the visiting Blues firing more than 50 shots at Staniowski in each of the next two games. St. Louis lost the next game 3-2 in overtime. The Sabres won the third and deciding game 2-1 in overtime when

Don Luce scored the series winner on a three on two break in the 15th minute of OT.

Staniowski was bothered by some physical issues throughout his career, particularly an injury to his catching hand, and he decided to retire from hockey in 1985. He had played pro hockey for 10 years, spending most of his time in the NHL with the St. Louis organization. He also played with Winnipeg and Hartford, appearing in 219 games in his NHL career with a 67-104-21 record and a 4.06 goals against average.



Guns, guns, guns.

When I was a little boy way back when, the only guns you ever saw were toy guns. Mostly cap guns and made of metal as plastic was new. Looked like the ones that cowboys used to carry, Silver with white handles. Almost never did you see a real hand gun that shot bullets. Sometimes you would get a glimpse of one in the holster of a Policeman. Just the butt end of a 38 sticking out the top and secured closed. Even with that you were in awe. Almost no one back then owned a gun. I did not see a real hand gun out of a holster till I was in the Army National Guard. We were taught with three firearms, a M1 rifle, carbine

and a 45 pistol. That was it. Like I said the only ones who had guns were the Police and not even all of them. The beat cops if I recall right did not carry guns. The only other people who had them were criminals and gangsters, and even then it was machine guns. Their gun of choice. Not the preferred weapon

of either the police or the military at the time for some reason. Would need an expert to tell why a rapid fire weapon was not used in WWI or II. I think the argument was that it was not accurate. If it is capable of shooting fifty rounds off, how accurate does it have to be? Just the noise alone is enough to scare the pants off of you. The mob used it effectively.

Then there were the people who love guns. I knew a fellow in Kiwanis who had dozens and dozens of guns. His home had a sign on it saying "If you plan on burglarizing, you picked the wrong house". It was a two story house and had an attic filled with almost every gun you could imagine. One room alone was filled with Thomson Machine guns. Lots of them were collectable and probably did not shoot but there were all kinds. I was impressed. Needless to say not too many people are invited into this self made muse-

Still most citizens did not have guns. My Dad never had one, neither did any of my brothers except when they were in the service. Born and raised on the West Side of Buffalo, there was no need to have home protection. All arguments were solved in fisticuffs. Not even knives were used. There were no shootings and burglaries were held when no one was home. Few if any armed robberies. Just living on the West Side was protection.

I remember meeting an Irish girl from South Buffalo at Skate Land Downtown. I used to go visit her in South Buffalo. One night she was babysitting and her parents, knowing I was a good Catholic boy, allowed me to sit with her. As we were sitting having a nice conversation, the door bell rang. She peeked out and saw four of her South Buffalo friends, looking for something to drink, alcoholic. She told me to go and hide as these are rough characters. Me hide? No way, Josè and I told her no. She answered the door with me looking over her shoulder, they asked who I was and she answered with my name and that I was from the West Side. Much to my surprise, they just took off and not fast enough. I asked her why the sudden turn around and her answer was, "the West Side

did it". The only protection I needed was where I lived. No gun, no knife, nothing except the reputation of my

Unfortunately it is not that way now. I still do not have a gun but I guess that is not wise in today's atmosphere. Gun sales are skyrocketing. More and more people seem to feel they need to protect themselves. Each new story that seems to threaten law abiding citizens, spike the number

of guns and ammunition

Personally I wonder why a person needs an AR-15 machine gun to protect their home. That question had inspired much anger with gun advocates as I made the mistakes of asking it on Social media. I thought it was a fair question. Not so, and I was called some pretty foul names. I learned my lesson. Do not anger someone with a gun.

Ask Rusty - Why Won't Social Security Give Me My Widow's Benefit?

Dear Rusty: I have been a widow since November 2019. I retired under the Federal Civil Service Retirement System. Before my husband died, I made an appointment with Social Security to see if I could receive his Social Security if he passed on. I was told I could. Since he passed, Social Security has adamantly refused to let me have my husband's Social Security. I have had many problems with them. Who is correct here? I have lost \$1400 per month. My social security check is about \$126 per month. Signed: Frustrated Widow

Dear Frustrated Widow: First, please accept my condolences on the loss of your husband. Unfortunately, I don't have good news for you.

Because of your Federal Civil Service Retirement System (CSRS) pension, you are subject to the "Government Pension Offset" (GPO) provision of Social Security. The GPO reduces the survivor benefit for anyone who also has a pension from an employer which did not participate in Social Security (neither the employer or the employee paid into Social Security), and your Federal CSRS pension falls into this category. GPO reduces any survivor benefit you might otherwise be entitled to by 2/3rds of the amount of your CSRS pension, which often eliminates the survivor benefit. For clarity, GPO also applies to a Social Secu-

As you probably already know, your CSRS pension caused your own Social Security benefit, earned from other work outside of your Federal employment, to be reduced by the Windfall Elimination Provision

rity benefit from a living

spouse.

(WEP). Unfortunately, whoever you previously spoke with at the Social Security Administration prior to your husband's death gave you some incorrect information, because you are also subject to the GPO. And that is why Social Security will not now pay you a survivor benefit from your husband.

I'm afraid you have no recourse on this, as both the GPO and WEP have been the law for decades. The Federal Government has now changed to a "Federal Employee Retirement System" (FERS) which fully participates in Social Security (both employees and the employer contribute to Social Security), so more recent Federal retirees are not subject to the WEP and GPO rules. But there are still many U.S. State and local government employers which, to varying degrees, do not participate in Social Security and whose employees are still impacted by both GPO and WEP.

As CCI moves towards the future of expanded services and resources, they remain steadfast knowing that their beloved cultural center has an enormous opportunity to contribute to the ongoing renaissance within North Buffalo and the greater Western New York Community.

CCI was formed as a 501(c)3 non-profit organization (currently undergoing retroactive reinstatement) whose mission is to promote value to our society by way of the Italian culture, heritage and particularly its language. Founded in 2010 by Dr. Giacobbe and his late wife, Renata Scognamiglio Giacobbe, this dynamic couple envisioned a welcoming and inclusive environment with access for all.

Today, CCI provides a space where Italians, Italian-Americans, and all other individuals with an interest in Italian heritage and/or education, meet, interact, learn from one another and celebrate the richness of Italian culture. CCI has grown from humble beginnings to a strong organization of over 250 members, comprised of persons of all ages.

Notable cultural and educational accomplishments over the past year include: Vibrant educational programs; Cooking classes; Monthly 'story hour' for children; Italian language instruction at various levels; Classical Italian movies with English subtitles; Monthly lectures on Italian culture; Sponsored Concerts and an inspiring tenday excursion to Italy attended by 40+ members of CCI and the greater community. Additionally, CCI is a resource for exchange students to and from Italy and for individuals who travel to Italy for business or pleasure.

Additionally, CCI engaged SUNY Buffalo State Professor of Museum Studies, Cynthia Conides, Ph. D, to design an Adaptive Reuse Plan for the North Park Library Building, along with Museum Studies Graduate Student, Michaela Worosz. This comprehensive research model incorporates the business plan along with Architect Tommaso Briatico's vision.

In order to become the distinctive foundation of Italian culture and education, CCI is launching a capital campaign of $\$\bar{2}$ million. Projected costs will support the restoration, exhibits and adaptive reuse to transform the North Park Library into an exciting new Italian Cultural Center. It is equally important for CCI to have the capacity to provide professional level resources, education, facilities and wrap-around amenities at the new Center (e.g. kitchen, auditorium for lectures/ speakers, classrooms, space for artifacts/historical items etc.). To that end, the Board of Directors is committed to also fund a \$500,000 endowment to ensure CCI's sustainability and continued growth.

Leading this initiative for CCI, in addition to Dr. Giacobbe, is the Honorable Anthony M. Masiello and local developer, Rocco Ter-

mini.

CCI endeavors to seek the commitment of government, corporations, community supporters, and private foundations to ensure the transformative development of the North Park Library into a regional asset that promotes and fosters the integration of interactive language instruction with cultural enrichment. We will continue to serve our clients while we renovate the building.

CCIs Campaign Leadership invites the WNY community to play an integral and critical role in ensuring the Centro Culturale Italiano di Buffalo meets and/or exceeds its goal to become a destination for Italian-Americans and all other "citizens of the world" with an interest in Italian heritage and/or education. 


