Getting Ready For Baseball!

A year without baseball or softball in Shoshone Park hasn't hurt the Hertel North Park Youth League in Shoshone Park. In fact, it's actually helped.

With just 23 days left until Opening Day May 8th, the 64 year old league has come back strong after having cancelled their 2021 season due to the Covid-19 Pandemic. When the league yells "play ball!" next month, a record number of boys and girls will be ready to play. As this column goes to press, a record 930 children will put 2020 behind them as a bad memory and face their school friends again in North Buffalo.

"We're overwhelmed by our new number of registered players this season," said League board members after a Saturday morning zoom meeting. "We're glad that the League is growing, despite the Pandemic and having cancelled our season last year. It's indicative of North Buffalo parents wanting value in their child's life from an early age. It's nice to know we offer this for the Community."

A team of League board members, numbering close to 20, have been working hard over several months, beginning late last year to ensure a new season can start before Mother's Day this year. Saturday, they viewed the numbers of signed up players and determined how many teams would be in each division and how many players would make up a team. No decisions were made as to which team a Joe or a Mary would be on yet but the team would have the same amount of players.

Everyone in Hertel North Park is a volunteer. Board members spend countless hours in the Park, located on Hertel Avenue near Main Street to prepare a new season. Much work needs to be done and several do many tasks while working full-time, raising a family or going to School. Soon the League will hold a Park clean-up where more volunteers will beautify Shoshone of excess weeds and debris. Hertel North Park has always been a reason why many families have chosen to live in North Buffalo.

This year, six new teams have been added to nearly half of the competitive divisions that make up little league baseball in Shoshone Park. These teams are instructional for boys and girls and are all played at night during the week and on Saturdays. There's a new Cardinals team for

girls, 12 and under. The Tigers will join nine other teams in a boys 10 and under division. The Angels and Twins will join 10 other teams in Rookie Boys and the Comets and Stars will be added to the Rookie Girls division.

Now, with the new teams ready to go, parents are being asked to serve as volunteer coaches for the league, a year that runs from May until August. Each team will make the Playoffs but a volunteer parent can help make a child's Summer that much happier. If you wish to help coach a youth team this summer, the Park phone number is 862-0243 and someone will return your call.

Each year, generous financial support of local businesses helps the league continue. This year is no exception. If you know of a business who might like to sponsor a team in Hertel North Park, the cost is \$175 and would put your name and business logo on the back of a players jersey for one year. Ask Rusty- When Can I Get Benefits from My Ex-spouse?

Dear Rusty: I know that I am able to get Social Security benefits from my ex-husband. We were married for 16 years and I have not remarried. I will be 60 soon and he is 63. I do not know if he is retired yet, as we do not speak. Please advise when I can collect and how to go about the process. **Signed: Divorced Lady**

Dear Divorced Lady: Since you were married to your ex for more than 10 years and haven't remarried, you may be able to collect a spousal benefit from your ex-husband when you are 62 years old. Your eligibility will depend upon the amount of your own personal Social Security (SS) benefit compared to your ex's benefit amount, but you cannot collect an ex-spouse benefit before age 62. To be eligible for a benefit from your ex-spouse, you must also claim your personal SS (from your own lifetime work record), and when you claim your own benefit an ex-spouse benefit will be given, if you are entitled to one.

To be eligible for a benefit from your ex-spouse, your personal Social Security retirement benefit at your own full retirement age (FRA) must be less than 50% of the benefit your ex-husband would get at his FRA (note that FRA amounts are used for this determination, regardless of the age at which either of you claim SS). If your FRA benefit amount is less than half of his FRA benefit amount, then you will be entitled to a "spousal boost" to bring your total payment up to your spousal entitlement. But taken at age 62, both of those amounts will be reduced.

Your full retirement age is 67, and if you claim any SS benefit before that it will be reduced. At 62, your personal SS retirement benefit will be cut by 30% and your spousal boost will also be reduced. So, at age 62, the total amount of benefit you could get (your own benefit plus your spousal boost) would be about 32.5% of your ex-husband's FRA benefit amount. Nonetheless, if

you are comfortable with these benefit reductions, you can claim at age 62 (or any age thereafter) by contacting Social Security or, when the time comes, apply online at www.ssa.gov/applyforbenefits. You will need to provide SS with a copy of your marriage certificate and your final divorce decree, and you will need to know your ex-husband's Social Security number (SSN). If

you do not know his SSN, you'll need to provide his parents' names and his date and place of birth.

If you wish to find out in advance whether you're entitled to an ex-spouse benefit and how much it is estimated to be, you can contact Social Security at 1.800-772-1213, or call your local SS office (find the local office number at www.ssa.gov/locator). Please note that all Social Security offices are temporarily closed to public access due to the pandemic, so calling them is your best current option to get an estimate of your spousal benefit.

One final caution: if you claim SS before your full retirement age and you are working, you'll be subject to Social Security's "earnings test" which limits how much you can earn before they take back some of your benefits.

Northwest Buffalo Beat

When I Was A Kid Part Six

I mentioned World War II in my last column. It started when I was six years old and ended when I was ten. That means in all my formulating years, we were at war. I knew nothing else except that daily life centered on the war effort. I thought that was the way it was and would always be, as I knew no other way.

My world at that time was using ration stamps to buy food and gas was routine. Seeing all the young men leave home to go off to some foreign country and perhaps never returning, this happened too often. Seeing small flags with stars on them in the windows of homes where their young men were in the service. Blue star for each member and some had two, three and more. The star would change to gold if a person in the service would no longer return home. I just recall walking down Fargo Avenue, a typical neigh-

borhood street and see all these flags in the windows. Far too many of them were gold.

They stopped making automobiles during the war years so I thought there would never be new cars again. We had to keep our '35 Ford running as you could not replace it. Used cars, or anything that ran was scarce. Even if you had a car, you had to use it to get you back and forth to work as gas was rationed. No long trips or rides in the country, it was the way it was. In those days everyone was thin, as food was also limited. Meat was rationed so you were only allowed so much per week depending on the size of the family. There was food in the super markets but it was generic with not much to choose from.

Everyone contributed to the war effort. We had a flag in our house with two stars as two of my older brothers served. My older brother was in the Air Force and somewhere in Europe fighting the Germans. My other brother was in the Navy and on a ship. My mom was always in fear of someday getting a telegram or visit notifying us that one of them would not be returning home. It got to the point where the doorbell ringing sent an immediate chill through your spine. We had to live with that but I knew of it being no other way. It was just the way it was. We were at war and no one knew when it would end and who would win.

My dad worked every day but we had limited finances. Still he contrib-

uted part of his pay to buying war stamps which eventually became War Bond. If we won the war, you would get your money back with interest. Of course if we did not win, they were worthless. It was the patriotic duty of all red blooded Americans to buy what they could to support our troops overseas. My dad did that the entire war. In fact they sold the stamps at my school and I used to purchase them for him. Each week whatever he could afford he would have me purchase and bring home these war stamps. Again this became a way of life as I knew no other way.

There was tremendous joy when it was announced that we had defeated Germany in Europe. It was a happy day, but it still was not over. It was called "VE" day. Victory in Europe and it was such a relief. Things were going our way, but we still had the Japanese to contend with. Our boys would not be coming home for good as those who were in Europe, would continue on in the Pacific. It was a happy moment but still not the sigh of relief everyone was looking for.

Finally, in August of 1945 the Japanese surrendered. It is hard to describe the Euphoria of that day, "VJ" day. Victory in Japan, we had won the war. It was over! The tremendous celebration continued for many days and weeks. Like everyone else I was overjoyed and took part, but still did not realize the full meaning of what it meant. I had grown as a toddler into a young boy not knowing any other way. It was not till years later when things returned to normal did I become aware of how it was supposed to be. All those days, all those weeks, all those months and years of being at war and fighting the battle on the home front. I sure hope that never happens again. It will not, at least in the way it did.
