A local therapeutic dance program for people with Parkinson's disease has been awarded a significant Community Grant from the Parkin-

son's Foundation. Art Moves Me, facilitated by professional dancer and artist Cynthia Pegado, is a choreographed and Move-Mindful ment Program for people affected by Parkinson's Dis-

ease or Parkinsonisms, including patients, care partners, family members and friends. The \$23,100.00 grant was recently forwarded and will support these incredibly affective and highly popular classes in Buffalo over the next year. Pegado collaborates with the Burchfield Penney Art Center to incorporate art and music in leading her group through prescribed movements that are proven to benefit those with neurologically-based movement disorders.

Art Moves Me is one of numerous program recipients of the Community Grants supported by the Parkinšon's Foundation that furthers the health, wellness and education of people with Parkinson's disease (PD) across the nation. ## Hail To Our Quarterback!

"Fasten your seatbelts ladies and gentlemen," the legendary Buffalo Bills broadcaster Van Miller used to say before each game. This could be the year the team gets back to the Super Bowl and wins it this time.

With the victory over Kansas City Sunday night in Arrowhead Stadium behind them, the Bills can again take one game at a time and prepare for the rest of what's looking to be a magical season led by number 17, the Quarter-back, Josh Allen. With his leap over a Chief defender in the fourth quarter to gain a first down, it proved again to all here in Western New York that the "winner" from Wyoming would stop at nothing to lead this team to a Super Bowl berth again beyond an AFC Championship.

Next up is Tennessee, a team that was never in existence when the Bills went to four straight Super Bowls 1990-1993. The going may seem easy again with winnable games through mid November but head coach Sean McDermott will still remind us to "trust the process." Brandon Beane has built a roster through the

NFL Draft, beginning with a franchise QB in Josh Allen three short years ago in 2018 and the Bills' ride to the top has been the most enjoyable so far.

But our quarterback isn't the only one to have worn number 17 on his red, white and blue jersey for the Buffalo Bills. No. In the mid 1970's the team drafted Gary Marangi in 1974 out of Boston College to become the next quarterback and gave him #17 to back up Joe Ferguson. Marangi did get to play during his three years here and made an impression so much so that a large segment of fans wanted him to become the starter, in place of Fergy.

I was a junior at Bennett High School at the time and coach Lou Saban had left the in 1976, leaving the Bills in the hands of offensive line coach Jim Ringo. One morning in early September of 1977, I was selected by a school newspaper advisor to attend a program

held at then Rich Stadium to have a huge press conference with Ringo and some Buffalo Bills players. Many schools were also on hand to be able to sit in the press box of a stadium just five years after it opened in 1972. Bills owner Ralph C. Wilson was in attendance that day and after pastries and coffee, fruit and juice, he welcomed us student journalists to the NFL along with L. Budd Thalman, the Bills public relations director.

I was hooked on this profession and consider it one of the best days of my early life. The Bills only won two games in 1976, under Saban and Ringo but I didn't care. O.J. Simpson was "the juice" and whoever was going to hand the ball off, whether Fergy or Marangi, would lead us back into the playoffs. It was a fun time to be growing up a Bills fan. We ran a story in the Bennett Times newspaper and then concentrated on Harvard Cup football with Gerry Berkman and Larry Veronica. The Stadium was behind the School, where all the teams played on Saturday.

Memories still so fresh and easily attainable thanks to the Buffalo Public School System and the Buffalo Bills. "Let's Go Buffalo'





# The Blotter Felonies

#### North Buffalo October 11, 2021

Delaware Avenue – While on patrol officer did locate a stolen vehicle in the parking lot of 2232 Delaware Avenue. Upon approaching the vehicle, the defendant was found sleeping in the back seat.

#### **October 8, 2021**

Delaware Avenue - Officers did observe a suspicious vehicle parked in the parking lot of 2318 Delaware Avenue. Vehicle has been sitting in the parking lot for approximately 1.5 hours. Upon officers walking up to the vehicle a cigarette pack was in plain view in between the defendant's legs with two crack pipes sticking out. Officer then asked the defendant to hand him the pack and then discovered white powdery substance and a rocky tan substance individually wrapped in plastic baggies. Approximately 7 grams powder and approximately 0.5 grams of rock.

#### **October 8, 2021**

St. Lawrence Avenue-Lackawanna Police Deobtained partment search warrant for 254 St. Lawrence. Search warrant was obtained by Captain from City Court Judge. **Buffalo Police Department** SWAT did execute said warrant along with Lackawanna Police Department, Buffalo Police Department INTEL and SSTF. Upon further investigation (1) black Glock model 21, .45 cal. Loaded with (1) cartridge in chamber and (10) cartridges in the magazine were recovered from under the living room sofa by officers. (1) black/silver Ruger model GP100, .357 caliber loaded with (6) cartridges in the cylinder were recovered from the bedroom closet inside red coat pocket by officer. Officer did recover Al Fakner tobacco box from the kitchen cabinet which contained (1) large bag of gray powder and (1) small bag of gray powder of suspected Fentanyl recovered in residence. Officer also recovered (1) large clear bag of white rock like substance (suspected crack) (1) small bag of white rock like substance (suspected crack cocaine) and (1) small bag of white powder and white rock like substance (suspected crack cocaine.) Cocaine and crack cocaine

found in kitchen cabinet. Cocaine and crack cocaine weighed approximately three ounces. Officers also recovered from kitchen cabinet Vita Blend cutting agent. Officers recovered from kitchen counter (1) black scale with residue from the living room mantle. All submitted.

#### Riverside October 9, 2021

Riverside Park - Victim 1 states that on 10/8/2021 she did text the defendant that she was not allowed on the football field for Riverside Little League games and practices at Riverside Park. Victim is Vice President of the League. Defendant did text back saying, 'I'm coming after the whole team!' along with other texts making victim 1 feel threatened for her safety. On 10/9/2021 defendant did come to Riverside Park and while there did attempt to hit one of the witnesses (assistant coach) on the football field sidelines by the cheerleaders. Victim 1 did interfere and while doing so did get punched with a closed fist several times to her right cheek and left shoulder by the defendant. Victim 1 and multiple witnesses state the defendant was swinging punches at everything in her path. Victim 2 states while trying to break up the fight the defendant did grab a football helmet and hit him with it to the back of his head. Victim 2 declined medical attention at the time. The incident happened at Riverside Park on the football field sidelines during a game with many children present. Both victims requested an order of protection against the defendant.

#### October 10, 2021

Amherst Street – Defendant did take \$36.07 worth of merchandise and passed all points of purchase without attempting to pay.

#### **October 8, 2021**

Grote and Military Road – Defendant was found passed out in the driver's seat of the vehicle, keys in the ignition, in the lane of travel at the corner of Grote and Military. In plain view on the front center armrest was a white powdery substance believed to be heroin. The defendant did have a revoked NYS driver's license. Also

in plain view was a growler of alcohol and defendant did have seatbelt fastened. Vehicle impounded to 166 Dart Street.

#### October 7, 2021

Amherst and Germaine Streets - Officers were stopped by passerby witness who stated defendant and co-defendant were arguing in vehicle and did strike another vehicle before fleeing scene. Defendant was apprehended at Amherst Street and Grant Street. Upon DMV check of defendant, he did have revoked driver's license. During inventory of vehicle patrol officer recovered white rock-like substance in clear plastic bag in co-defendant's purse near passenger seat. Patrol officer recovered Xanax pills from glove box of same vehicle. Defendant was in violation of order of protection. During argument defendant made threats to harm co-defendant.

# About the Basics of Applying for Social Security – Ask Rusty

Dear Rusty: I am planning to apply for Social Security in May of 2022 and would like to understand how to file. I will be taking it when I am 62. Signed: Ready to Retire

Dear Ready to Retire: Congratulations on your upcoming retirement! You should apply for your Social Security benefits about 3 months before you wish benefits to begin (you will tell them the month you want benefits to start when you apply). Since you plan to apply at age 62, be aware that you must be 62 for an entire month to be eligible for benefits - you cannot get benefits for the month you turn 62 (unless you were born on the 1st or 2nd of the month). Rather you become eligible the following month.

Your benefit payment date will be either the 2nd, 3rd, or 4th Wednesday of the month, depending on the day of the month you were born. Born between the 1st and 10th of the month, your payment will be received on the 2nd Wednesday; born between the 11th and 20th of the month, payment will

be made on the 3rd Wednesday; born after the 20th of the month, your payment will be received on the 4th Wednesday.

You can apply for benefits over the phone by calling Social Security at 1(800) 772-1213 (or by calling your local office) and requesting an appointment to apply. However, by far, the most efficient way to apply is online at www.ssa.gov/ applyforbenefits. Here's a link to a short video about applying online: https:// www.ssa.gov/hlp/video/ iclaim r01.htm. To do the online application, you will first need to create your personal "my Social Security" online account, which is easy to do at www.ssa.gov/ myaccount. When you have that online account set up, you will see your estimated benefit amounts at several ages. You'll see that if you claim at age 62, your benefit will be 30% less than it would be at your full retirement age (FRA) of 67 (a permanent reduction), and you'll also see that your benefit at age 70 would be about 75% more than your benefit at age 62.

Please also be aware that if you claim before your full retirement age and you continue to work, Social Security has a limit for how much you can earn before they take away some of your benefits. The 2022 earnings limit is not yet known, but it will be something a bit more than the 2021 limit of \$18,960. If you exceed the annual limit, Social Security will take back benefits equal to \$1 for every \$2 you are over the limit (half of what you exceed the limit by). The earnings limit goes up by over 2.5 times in the year you reach your full retirement age and goes away entirely once FRA is attained.

Finally, your Social Security benefits may be subject to income tax if your combined income from all sources is high enough. The thresholds depend on your IRS filing status - if you file as "married/jointly" and your combined income (yours and your husband's) is more than \$32,000, then 50% of your SS benefits for the tax year becomes part of your taxable income. If your combined income as a married couple is more than \$44,000, then up to 85% of your SS benefits will be taxable. The thresholds are less if you file your taxes as a single – in that case, income over \$25,000 means 50% of your SS benefits are taxable, and income over \$34,000 means up to 85% of your benefits will be taxed at whatever your normal IRS tax rate is.

# Centro Cultural Italiano (Italian Culture Center)

Attended the ribbon cutting of the CCI (Centro Cultural Italiano) on Sat-urday. What an amazing event! Right here in North Buffalo on the corner of Delaware and Hertel. That decides it, we are now officially considered the Little Italy of Buffalo. It is now the Italian American community and should be recognized as such.

My belief is that it all

started when the Italian Festival moved from Connecticut street on the West Side to Hertel Avenue in North Buffalo. I happen to be a witness to the negotiations back in 1988 when the leaders of the event were discussing the move. The deciding factors were the carnival and food truck owners. Hertel offered a wider street with more sidewalks. It was also

evident that the neighborhoods were changing, and thousands of Italian Americans were now residents of North Buffalo. There were other reasons, but we know the move happened. In the beginning the festival was greeted with open arms by most merchants and residents.

As the years passed the event became one of the largest Italian Festivals in the country. With it came the problems. Each year the Italian Festival committee would try to address the problems of the previous year. A momentous task to say the least as the festival became bigger and bigger. The committee tried to keep it with an ethnic theme. Italian food and culture! Eventually the carnival people were downsized, and it became more of an ITALIAN festival. The food, the displays, the ethnic booths and even dress. It still had its problems as it was in a residential neighborhood. The homeowners' won out and the festival moved to downtown. It did leave a lingering effect, however. North Buffalo was now the Italian American community of Buffalo. Herel Avenue was declared "Little Italy."

The festival is gone from here but not the memories of how great it was. It is gone from the neighborhood, but it has left its mark. The festival was a place for all the old west siders to meet and reminisce about the good old times. Fortunately, there were people who did not want to let that go. They wanted the Italian American heritage to live on here and decided to do something about it. Negotiations began for the initiation of an Italian Culture Center. A place for goombahs and piezon's to meet and talk about their heritage. The Italian festival in a build-


The old North Park library on the corner of Delaware and Hertel was no longer in use and empty. The original motivating force, and there are dozens that contributed, was Dr. Francesco Giacobbe. He produced a plan to renovate the old Library into an Italian heritage center. He solicited all Italian American politicians and businesspeople to not only get the project underway, but make it happen. And happen it did. We now have an İtalian American culture center right here in North Buffalo. The ribbon cutting was attended by the who's who of Italian descent in Buffalo. This structure is a tribute to the hard work

and dedication of the many

volunteers who contributed. The building is beautiful and well done. There are still projects in the works.

The walkway leading into the front has cobblestone or brick paths. These bricks can be purchased by anyone, with a name chosen by the buyer engraved on it. This is a fundraiser to help defray the cost of maintenance. The facility also has a new restaurant and coffee shop. Why not stop by and visit, it is right in the neighborhood.


