Flag Raised At City Hall



The St. Patrick's Day flag raising took place at Buffalo City Hall on Tuesday, March 14th.

Mayor Byron W. Brown and South District Council Member Christopher P. Scanlon, joined by the United Irish American Association (UIAA), kicked off St. Patrick's Day week by hosting an Irish flag-raising ceremony in Niagara Square on Tuesday, March 14th. The event celebrated the upcoming return of the UIAA's St. Patrick's Day Parade on Delaware Avenue and the Valley Community Association's Old Neighborhood Parade in the Old First Ward. Both parades were cancelled

in 2020 and 2021 due to the COVID-19 pandemic. This year in Buffalo, both the Ukrainian flag and the Irish Flag will wave on the same pole in Niagara Square.

"After two very long, difficult years, we're thrilled to see the return of the St. Patrick's Day Parades in Buffalo," said South District Councilmember Christo-pher P. Scanlon. "While we spend this week celebrating and honoring the history of Ireland and its people, our hearts are with the people of the Ukraine who are fighting to keep their history and culture alive."

"It is an honor to be part of today's Irish flag raising ceremony, as both of my parents were born in Ireland," said Patrick McGuinness, the Grand Marshal of the St. Patrick's Day Parade. and Western New York!"

The ceremony is onSaturday, March 19th at noon, beginning on South Park Avenue and ending on Louisiana Street and the St. Patrick's Day Parade is Sunday, March 20th at 2:00pm on Delaware Avenue.

City Of Buffalo Spring 2022 Bulk Trash Collection To Begin April 10th

Mayor Byron W. Brown today announced that the City's Department of Public Works, Parks & Streets will kick-off the Spring 2022 Bulk Trash schedule the week of April 10, in the Ellicott District.

"In 2022, we will once gain offer Spring and Fall bulk trash collection. I ask residents to follow the guidelines on the amount and type of items that can be put out for collection" Mayor Brown said. "I'm also asking residents get their bulk trash to the curb on the Sunday of their designated collection week as pick-ups will take place Monday through Saturday, not just on their regular garbage day."

Residents are also asked to follow the posted parking regulations in their neignborhood to make sure trash collection equipment has access to the curbside piles.



A Personal Appearance!

Former Major League Baseball Player and Manager Bobby Valentine paid a visit to Western New York last month in West Seneca, promoting his 2021 memoir and signing autographs for local fans during the dreaded Baseball lock-out. The 71 year old Shortstop and Outfielder for five MLB teams from 1971-1979, played most of his career on the West Coast with the Los Angeles Dodgers, California Angels and San Diego Padres.

In 1977, the Padres traded him to the New York Mets for Outfielder Dave Kingman, where he spent two years before finishing his career with the expansion Seattle Mariners in 1979. He later managed

the Mets for seven seasons, from 1996-2002, compiling a 536-467 record and a National League Pennant in 2000, when the team faced the New York Yankees.

The personable Base-ball legend took time out of a busy schedule to visit WNY February 19 at Bases Loaded Sports Cards, on Union Road to sign copies of his 2021 book, "Valentine's Way" and answer questions from collector's and fans of the game.

"I started collecting Baseball cards when you were a rookie with the Dodgers," said one fan who said he once owned Valentine's rookie card in 1971. The fifth pick of the 1968 amateur draft by the Dodgers, led by Hall of Fame

Manager Walter Alston, Valentine spent three seasons playing with the likes of Maury Willis, Steve Garvey and Billy Buckner. He batted .263 and drove in 57 runs against players like Willie Mays, Pete Rose and Hank Aaron in the tough National League Western Division.

While he chose not to comment on the ongoing strike that ended last Thursday evening between the Players Association and team owners, Valentine was very attentive to area fans, answering questions and listening to stories about Major League games held here for the Toronto Blue Jays last season.

"This is a great City and it's a pleasure to visit a place that loves the game even though there's no Major League team," said Valentine. "That tells me a lot about you."

Just as soon as a deal was struck last week, Baseball fans here in WNY drew a collective sigh of relief and watched as teams like the Blue Jays and Yankees, Mets and Dodgers, and all other teams, started reporting to their Spring Training sites in Arizona or Florida. With actual Spring Training games scheduled to begin Thursday, March 17, the 2022 season will begin on Thursday April 7.

Late Sunday night, the Yankees and Minnesota Twins completed a block-buster trade, sending catcher Gary Sanchez and third baseman Gio Urshela to the Twins for newly acquired Shortstop Isiah Kiner-Falefa, third baseman Josh Donaldson and catcher Ben Rortvedt. The young catcher of the Twins might be the steal in the trade if he can help Bronx fans forget about Chris Sanchez.

Ask Rusty – My Husband Still Works; Must He Enroll in Medicare at age 65?

Dear Rusty: There is confusion between my husband and me on when he should file for Medicare. My husband will be 64 in July. While he does plan on continuing to work to age 67 and continuing with his employer's insurance plan, I believe there's a requirement that he file for a cer-

tain part of the Medicare retirement plan at age 65, otherwise there's some penalty at some point in the future after retirement. There's lots of confusion with this, and I'm hoping you can explain exactly what the process is in filing for Medicare at age 65 and after reaching full retirement age.

Dear Confused: From what you've shared, it doesn't appear that your wife will be entitled to a spousal benefit because her own benefit at her full retirement age (FRA) is more than

half of your FRA benefit amount. If your age 69 benefit is about \$3300, then your FRA (age 66) benefit amount was about \$2660). Half of your FRA amount (\$1330) is less than your wife's FRA amount (\$1900), so no spousal benefit will be available to your wife.

In your specific circumstance, both you and your wife should consider your individual objec-

tives in deciding when to claim Social Security. If you plan to claim next month at age 69, you will get a benefit that has increased by about 26% due to the Delayed Retirement Credits (DRCs) you've earned since you reached your FRA of 66. Claiming at her FRA, your wife will get the full SS retirement benefit she has earned from a lifetime of working.
