

#### Don Morris Fields At Shoshone Park



Earth Day was celebrated a little early this year for the Hertel North Park Youth Baseball League this past Saturday as Abi Reinhardt, left, returned to Shoshone Park with her son Kevin and daughter, George-Ann to help clean the diamonds. They're standing beneath the Kevin C. Reinhardt scoreboard, erected in his honor for the countless hours he devoted to the League as a board member and Coach until his untimely passing in late October 2020.

They were talking about all the boys and girls, last week, that have signed up to play baseball and softball in Shoshone Park this season. They were Downtown, in Buffalo's City Hall, where a group of men and women meet regularly, to discuss important issues.

In North Buffalo, the important issues are the over 1,000 children that are getting ready to open their 67th season, playing in Shoshone Park this summer, starting on Saturday, May 4th, hopefully under bright sunshine.

But on this Tuesday afternoon, two Councilmembers in neighboring districts, Rasheed N.C. Wyatt and Joel Feroleto of the University and Delaware portions of the City, led the legislative body to unanimously approve the renaming of the baseball diamonds to "Don Morris Fields at Shoshone Park" The Resolution read as follows...

The Buffalo Common Council unanimously approves renaming Shoshone Park's baseball diamonds to "Don Morris Fields at Shoshone Park" to honor Don Morris for his extensive contributions to Buffalo and the Hertel North Park Youth Baseball League, The resolution includes renaming the fields, updating Park signage and

distributing copies of this resolution. Additionally, construction has begun on the 11.5 million, 34,539 square foot indoor multi use fieldhouse.

The multi-Purpose facility, named after Thomas M. Smith, a long-time advisor to Buffalo Mayor Byron W. Brown, in the Buffalo Parks Department, passed away suddenly in 2022 at the age of 51. At the official ground-breaking for the new build back in October of last year, hundreds came out to watch the Smith Family, Jessica and her two sons, pick up a shovelful of the earth. Both boys have played for Hertel North Park League baseball.

Morris signed his son Marc up to play t-ball in 1988 in Shoshone Park and watched him learn the game he so loved ever since the Dodgers were still in Brooklyn. It didn't take long for him to join the other coaches in the Park to sit in on meetings for the League. By 1992, he was elected president of the Hertel North Park Youth Baseball League, succeeding Charles Bartolotta and began a 30 year term as the leader of baseball and softball in this tiny Park on Hertel near Main Street that wanted any child to be able to play the game.

"I want to thank the family for lending Don to us," said

University District member Wyatt in a news conference afterward. "for those many years in partaking and assisting in developing young talent and giving them the wherewithal to really have confidence in playing baseball."

In a District that falls just

In a District that falls just a few City Blocks away from Shoshone Park, Delaware District member Feroleto stated "his whole heart went into Shoshone. He was just all in. There's over !,000 boys and girls that play...so we're just grateful for all of his contributions and happy to be a part of naming these fields after him."

In roughly 10 days, Hertel North Park families will hopefully begin to gather near the corner of Hertel and Saranac Avenue, behind the Cornelius Building, players dressed in new team uniforms will begin marching up Hertel towards Shoshone Park under a Buffalo Police escort just before 12:00 noon and welcome in a new season in front of the Businesses along Hertel Avenue. Hundreds of people gather along both sides of the busy thoroughfare to wave at all the smiling faces going by. A Buffalo Fire Truck is also on hand as well as some Antique cars. It's a day of fun for sports in North Buffalo and the best Day of the year, according to Mr. Morris, who kept the dream going for thousands of area children.

This past Saturday, Shoshone Park celebrated Earth Day early, as hundreds of people arrived early to help clean the Park of leaves and debris that had accumulated on the grounds since last year. Volunteers from St. Mark's Church, Buffalo Riverkeepers and various other organizations were on hand to help get the Diamonds and dugouts ready for the season.

Michael Burke was there too. Playing for the Champion Athletics last year, he begins his last season now while his Mom, Susan, helps Hertel North Park with chances for all players to help donate or exchange equipment that they may not have a use for so they may donate to others. There are gloves, bats, shoes and sneakers, helmets and pads available for others who might need them. You can reach her at www.susanburke2021@gmail.com.

Practices are being held everyday in the Park in spite of the weather. Saturday, Rookie Boys Angels and Twins were swinging the bats and tossing the ball around. Rookie Girls Diamonds and Wolfpack players were learning about first, second and third base. The Double AA Cardinals were each getting a chance to hit and the Major Boys Padres team was gathered around their coach, Jacob Lea-Kelly for a team meeting.



#### Ask Rusty - Minister Wants To **Maximize Social Security Benefit**

Dear Rusty: I want to apply for Social Security, but I want to make sure I get all the benefits I have earned. I am a veteran with a 10% disability rating (not sure if that matters). I am 68 years old. I am a minister and have been exempt from Social Security taxes for most of my income since I was about 30, but I still have the 40 quarters needed. I have also worked off and on in the secular workplace and continued paying Social Security taxes.

Thank you in advance for your service as a Social Šecurity Advisor. Signed: Seeking Answers Dear Seeking:

Don't worry about fees here at the AMAC Foundation – there is never a fee for the services we provide (we are non-profit). And I want to thank you for your military service - you may find the "For Veterans" section at our AMAC Foundation website interesting – www. amacfoundation.org.

To your question: Your VA disability rating does not affect your Social Security benefit. At 68 years old, your Social Security benefit payment has been earning Delayed Retirement Credits (DRCs) since you reached your full retirement age (FRA) of 66 years and 4 months in July 2022. That means that your benefit, if you claim now, will be about 13% more than it would have been had you claimed at your FRA. FYI, if you continue to delay, your SS benefit will continue to grow (by 8% per additional year you delay), up to the month you turn 70. At that time, your SS benefit will be 29% higher than it would have been at your FRA. Nevertheless, if you wish to claim a smaller amount now, you can do so in a couple of ways:

You can call Social Security (at 1.800.772.1213, or your local SS office) to request an appointment to apply. They will most likely set a date/time to call you to take your application over the phone (they discourage office visits these days). Once you have applied, it typically takes a month or two to process your application, but they will pay your benefits effective with the month you say you want them to begin. Note, they will likely also offer you six months of retroactive benefits but be aware that if you accept that offer your monthly payment will be permanently reduced by

You can apply for your SS retirement benefit online at www.ssa.gov/apply. Applying online is, by far, the most efficient method, as shown in this short video: www.ssa.gov/hlp/video/ iclaim\_r01.htm. However, to apply online you will need to first create your personal "my Social Security" online account at www.ssa. gov/myaccount. Once you have your personal online account set up, you will be able to see what your SS retirement benefit will be now, and at future ages should you plan to wait longer to claim. Your SS retirement benefit will be based on your lifetime record of earnings from which Social Security FICA taxes were withheld (or self-employment earnings on which SS payroll taxes were levied). In any

Although your situation is somewhat uncommon, it is not exceptionally unique. Your VA disability rating does not affect your Social Security benefit and, because you are a member of the clergy, you are not subject to Social Security's Windfall Elimination Provision (WEP) – a rule which reduces SS benefits for those with a pension earned while not contributing to Social Security. In other words, your SS benefit will be based entirely on your lifetime record of earnings from which Social Security payroll taxes were withheld, and your age when your benefit starts.
