Ask Rusty - I'm Working After Age 65; Why **Aren't I Exempt From Medicare Part B?**

Dear Rusty: Why, as I continue to work after age 65 and have FICA taxes taken from my check, am I – or anyone - also compelled under the threat of penalties, rate increases, etc. to immediately take Medicare Part B? Am I not then effectively paying into the system twice? As more and more people over 65 continue to work, isn't that a consideration that should be evaluated by Congress - if one is working past 65, above a specific level of income and paying FICA taxes, the Medicare Part B premium is waived?

Thank you in advance for your service as a Social Security Advisor.

Dear Working Senior: FYI, 6.2% of the FICA payroll taxes you pay while working goes to Social Security, and another 1.45% goes to fund Medicare Part A (hospitalization coverage, which is free to you). None of the FICA payroll tax you pay from your work earnings goes to fund Medicare Part B (coverage for outpatient services), which is the part of Medicare for which you must pay a premium.

Said another way, your FICA payroll taxes do fund Medicare Part A, which is free to you, but do not provide any funding for Medicare Part B. Part B is funded from two primary sources the premiums paid by beneficiaries, and the federal government from the general Treasury. Premiums from enrollees pay for about 25%

are paid from the general U.S. Treasury (not from Social Security money).

So, it's necessary to separate Part B from your thinking about the payroll taxes you pay while working - you're not paying anything to fund Part B through your FICA taxes. You aren't compelled to enroll in Part B (it's optional), but if you don't enroll during your initial enrollment period (3 months on either side of the month you turn 65) and don't have other equivalent "creditable" coverage from an employer, and you enroll in Part B later, a late enrollment penalty will apply (10% additional premium for each full year after age 65 you go without creditable healthcare cover-

So, your premise in suggesting that Part B be free (the premium waived) if you're working over a certain age or after an amount of time contributing to the program isn't valid, because no one contributes to Medicare Part B through FICA payroll taxes - Part B beneficiary contributions are only made through premiums paid by those enrolled in it. And you don't need to enroll in Part B if you have "creditable" healthcare coverage from an employer. The Part B non-enrollment penalty only applies if you enroll after your initial enrollment period has expired and didn't have "creditable" healthcare coverage after you turned 65. "Creditable" is a group plan with more than 20 participants.

Blue Stars And Gold Stars.

There are fewer and fewer of us that have lived through the second world war. Like 1%. It is not unusual to be asked questions about what it was like during those terrible three and a half years the United States was involved. Truthfully, it is getting harder and harder to recall life back in those dark days. However, I still can answer some of the inquiries. As much as I can remember.

The other day my eldest daughter, who is a history buff, did ask something that really made me think. I had two brothers who served in the military during the war. She asked what it was like when my siblings left to serve their country. Was there a tremendous amount of grief, knowing that there was a likelihood that they may never return? Had to dig deep to remember what happened but I did produce an answer.

We know that the Japanese bombed Pearl Harbor on December 7th, 1941. The war in Europe had been going on for a couple of years at that time but we were not involved. Suddenly the United States was in it, like it or not. Who knew what was going to happen. Many of the young men decided to enlist to fight for what they thought was right for the country.

I know they had to implement a draft or subscription. The draft board would decide your status and when your name came up you had no choice, you had to go. I do recall you were either 1A or 4F. 1A being eligible or 4F being physically unable to perform. My two brothers were 1A and both qualified for the draft. Those who were drafted automatically went into the Army. You were able to pick the branch of the military of your choice, if you enlisted. My oldest brother joined the Air Force at the start of the war. Yes, in the beginning it was "gung-ho" to go and teach those Japs a lesson. Like most wars there is no telling how long they will last. I do not believe anyone expected it to last so long.

So, when my first brother left to serve, there was no overwhelming grief or dismay. We were all proud of him as he was going to defend what we deemed important. Just like most families at the time, which was at the start of hostilities. No one had died yet. That changed as the months and years went by. When friends and neighbors started to get news that their young men had been killed in action, reality set in. Some of these boys, who we knew, were never going to return home. When my second brother became old enough for the draft he joined the Navy. Strange choice as he did not even know how to

As the time went by, it looked bleak. Furloughs for the men, (time off from the battle front) became less and less likely as the war drew on. My oldest brother was gone for almost three years. Still proud of him but we did not know where he was, and if he was ok. So many near us were getting the worst news possible. It was a sad time.

If you had someone serving in the armed forces, you proudly hung a banner in your window with a blue star on it. If you had more than one you added stars. Some banners had three and even four stars. If a member was killed in action, the star changed to gold. I recall walking in our neighborhood and seeing all these blue stars in so many windows. There were too many gold stars. It was only natural to wonder if your loved one would come home someday. Yes, as time went by and the war lingered, we worried about our men.

Fortunately, eventually, the war ended, and both my brothers survived. Can you just imagine the joy there was to that? Who knew it would last that long and maybe even longer. The older one did see lots of action in Europe and was lucky to be one that returned home. Many of his friends did not. The other one was safe on a ship in the Atlantic. We were so happy to see them return.

So, my answer was that when they went in, I do not recall unhappiness at their leaving. As the years dragged on the worry mounted. But that ended on VJ day, Victory in Japan, the war was over. All was well that ended well and the end was most welcome.
