Allentown Art Festival 2024



Buffalo's annual Allentown Art Festival, 2023.

The Allentown Art Festival, produced by the Allentown Association, Inc., and Allen West Festival will be held Saturday and Sunday, June 8 and 9.

In 2023, due to ongoing construction related to the Allen Street Improvement Project, Allen West shifted partially to the east of Elmwood. With the community-designed re-construction of Allen Street now complete, Festival artists will return to the traditional footprint between Elmwood

and Wadsworth Street while the Allentown Art Festival will be held along Delaware Avenue and on Allen Street, East of Irving Place.

For 25 years, Allentown has provided a showcase for local artists. Festival participation is limited to artists and craft artisans who live and work in Western New York.

In 2024, over 125 local artists and craftspeople will display their work along Allen Street on Saturday from 10:00 AM to 6:00 PM

and Sunday from 10:00 AM to 5:00 PM. The artwork for sale runs the gamut from fine art painting to photography to jewelry, wood carving, metal craft, hand printed t-shirts and handmade clothing and even locally crafted spice blends. There is definitely something that will appeal to everyone.


From 3-6 p.m. we will feature the local band The

Wildcat Weekend



North Buffalo Wildcats win 14U Championship in their own Tournament held this past weekend in Shoshone Park.

It may have been Memorial Day weekend on the calendar, but the girls on the North Buffalo Wildcats teams call it 'Wildcat Weekend.'

Two North Buffalo Wildcats teams won Tournament Championships in their own annual Tournament held this past weekend in Shoshone Park. Hundreds of area girls, playing on as many as 36 teams, traveled to Shoshone Park

Friday, May 24th and battled against each other and against Mother Nature as well, to make the 21st Annual North Buffalo Wildcats Tournament a complete success again in North Buffalo.

Nora Jordan, Tilly Scanlon and Anna Senulis each had three RBI's and four other girls had three hits each to lead the 10U Wildcats to a 15-12 victory over the Grand Island Vikings early Sunday afternoon in front of a cheering crowd of onlookers on Diamond #7. Brailyn Gaiter, Carly Patcholek, Zahara Ky-ser and Autumn Schoos came up with big hits at the plate to lead the Wildcat way to victory. Scanlon and Schoos were masterful on the mound against a powerful Viking offense, throwing strikes and hanging on to win. The team got excellent play from everyone throughout their Tournament against seven other teams, including the Vikings.

These girls were just amazing this weekend," said head coach Bob Schoos afterward. "They never gave up and it

seemed like a different girl would help lead us to victory in all three games. Truly a credit to our program here."

Besides Grand Island, other teams in the 10U Bracket included Amherst and Clarence, two tough competitors in such a young age. Other North Buffalo Wildcat players include Tess Capolupo, Mary Ganci, Addie Ryan and Jaiana Thigpen. All girls received individual trophies from their Coach, after the game and raced around the diamond in victory celebration.

Nine North Buffalo teams competed against teams from as far away as Fredonia and Syracuse. Other teams came in from Lockport, West Seneca and Wheatfield. Elma, Marilla and Wales were represented as well as Orchard Park and Hamburg. This years Tourney of 36 teams is the most teams that Hertel North Park has hosted since the Tournament was set up 20 years ago by Joe Bellanti.

Later Sunday night, the Wildcats won their second Tournament Championship in the 14U Division with a 3-1 victory over the West Seneca Magic in an exciting game led by the of-fense of Skyler Ball and Allie Foglia. Both girls were blasting homeruns all weekend long, each with three run homers against Central New York and Fredonia. Ball's solo homerun in the second inning against Fredonia Friday night put North Buffalo on the board early in a 6-5 win. Clohe Claeys, Shea Hornung and Molly Savage all hit impressive triples to lead an offense, ready to defend its Park. Izzy Kilonsky was pure magic on the mound for the Wildcats. She blasted a solo homerun and threw a no-hitter for North Buffalo. The team played excellent defense around the horn and kept West Seneca on edge through-out the whole game.
Other Wildcats girls

include Peyton Gallivan, Clara Rickus, Mackenzie Gunnerson, Darcy Bar-tels and Lidia Foglia. All eleven have been playing together in the Park for years, growing up together and building a feeling of Shoshone Pride.

"I'd like to thank everyone who helped make this our best Tournament ever since we began this, 20 years ago." said Scott Gallivan, the Wildcat Director and vice-president of Hertel North Park Baseball and Softball. "We had some issues with the rain on Saturday but we were able to give everyone a fair competition. I wish to thank our grounds crew and everyone who helped get diamonds ready to play. But most important, I wish to thank all the girls for giving us a reason to cheer."

The regular season House games resumed Tuesday evening after the Memorial Day weekend. Girls 13-16 years of age began their Senior Division season last Monday, May 20th with a Tigers 11-10 victory over the Bulls. Other teams in the Division are the Longhorns, Sooners and Wolverines.

The Senior Boys Division began their season this past Wednesday night, May 29th and consists of eight teams. They are the Athletics, DBacks, Dodgers, Mariners, Mets, Phillies, Pirates and Tigers. That's a total of 78 teams all playing on the Don Morris Fields in Shoshone Park.





Ask Rusty - About Social Security's Earnings Test And Cost Of Living Adjustments

Dear Rusty: Is there a limit on earnings when you're fully retired? Also, should all retirees receive COLA or is there an exception?

Thank you in advance for your service as a Social Security Advisor.

Signed: Retired But Wondering

Dear Retired: Your questions are fairly simple but, nevertheless, often perplexing to those wishing to apply for Social Security, because the SS rules are many (over 2,700 of them) and those about to apply for their benefits may be simply unsure and want to avoid a costly mistake. I'm happy to answer your questions and, hopefully, clarify any uncertainties you have on these

Social Security imposes an earnings limit on anyone who collects Social Security before reaching their full retirement age (FRA). If you haven't yet reached your FRA (somewhere between 66 and 67, depending on the year you were born), and you continue to work, there is a limit to how much you can earn before they take away some of your benefits. So, the answer to your first question is, yes, there is an earnings limit (\$22,320 for 2024) if you haven't yet reached your full retirement age. If the annual earnings limit is exceeded, Social Security will take away some of your benefits (\$1 for every \$2 you are over the limit, up to the year you attain

you have already reached your full retirement age the earnings limit no longer applies, and you can earn as much as you like without consequence. And here's a nuance to be aware of: if you work and exceed the earnings limit, and have some benefits withheld as a result, when you reach your FRA, you will get time credit for any months you didn't get benefits, which will result in your monthly amount being a bit higher after your

Regarding COLA (Cost of Living Adjustment), everyone, without exception, who has earned a Social Security benefit and reached eligibility age (62) receives the annual COLA increase whether they are already collecting their benefits or not. If you're not yet collecting, the COLA is added to your "primary insurance amount" or "PIA," on which your benefit will be based when you claim. If you are already collecting SS, COLA will be added to your gross monthly SS benefit amount. However, since there was a \$9.80 increase in the 2024 Medicare Part B premium, and since the Part B premium is taken from everyone's SS benefit payment, Social Security recipients enrolled in Medicare Part B will not see the full 3.2% COLA in their net monthly Social Security payment. Everyone will receive the COLA increase, but no one enrolled in Medicare Part B will get the full COLA

increase in their net SS FRA when the assessment is less). However, if payment because some of OF THE 70'S & 80'S! ONDAYS

the COLA increase is used to pay their increased Medicare premium.



No Italians?



Buffalo's West Side Rowing Club.

Watched a just released movie on Prime last night that triggered some memories. Those who are old enough may also travel along the memory path with me. The movie was, "Boys in a Boat," and it turned out to be a good flick. It is about shell rowing and the competition that goes along with it. Do not want to get into too much of the movie except to tell you I really enjoyed it. One of those that take you into it and you pull for the team like it was your own.

Brought back the days when the West Side Rowing Club was located at the foot of Ferry. It is still in operation but has moved to a different location further up the channel. The former spot was where Broderick Park is now. The former building was located right where the break wall started on the canal side. Such a joy in the early Spring to see the Black Rock Channel filled with these magnificent rowers. Single shells, two-man and the impressive eight-man crews filled the calm waters of the Erie Barge Canal. The mighty Niagara River flowing on the other side of the man-made break wall. Back and forth under the Peace Bridge. Sometimes you could watch races of the eight-man shells competing amongst their own crews, from the top of the hill, which used to be

Being as I used to hang out all summer at the foot of Ferry Street, I became familiar with the West Side Rowing Club as I used to pass it whenever I went out on the break wall, (now known as the Bird Island Pier) to fish or swim. Could not wait to grow old enough to join and become one of those rowers on the eight-man shells. Used to go into the facility and just look around till they would always kick me out.

Eventually, I did become old enough to join. Not that I could afford it, but I wanted it so bad. When I did, it showed me a new side of how things were that I never thought about. Prejudice! This was back in the early fifties and things were a lot different then than they are now. Schools and neighborhoods were segregated. There was no bussing, so you went to the school within walking distance of your home. The East Side of Buffalo was where the African American homes were located. The West Side was mostly Italian. In my Grammar school, School 18, there were two African American people that I remember. In High School, Grover Cleveland, there were also two. There was racial bias still in sports, but it was changing. As a young boy I just do not recall anything racial. World

War II had just ended, and we were all just Americans.

One of my first jobs was reading Gas Meters and there were days I spent the entire day reading meters in the Fruit belt. What was known as the Ghetto. Arms, legs, and backs. Tougher than you would think. The movie shows that. Still wanted to do it and be a part of this great institution. Then it happened. I met the






