

For ten year old Colin Stimpson of North Buffalo, last Friday night will forever be etched in his young mind after what happened to him Downtown, in Sahlen Field.

That's the night the fa-mous Savannah Bananas Team came to town to play Baseball in the first of three games scheduled just after the July 4th holiday. Stimpson and a bunch of his teammates on the 10U Yellow North Buffalo Blaze Travel team like Noah Lundquist, Max Capaccio, Connor Roehl, Zeke Ganci, Ted McGowan and Jermin Collazo all grabbed seats behind the third base dugout in Section 111and got ready to watch a team dressed in yellow uniforms play the game like they've never seen before.

All the 10U Blaze team players, led by Coaches Sal Capaccio, Matt Burke and Dustin Stimpson wore their green and gold team uniforms amongst the sellout crowd that filled Sahlen Field this night from the first row right to the top. For the Stimpson family, they found seats in Section 119, but there wasn't a bad seat in the house of Bison Baseball.

We brought our gloves with us," said the young Stimpson, after the game. "We wanted to get autographs and meet some of the players. We wanted to have fun.'

Playing against a team Firefighters, of Andy Archer of the Bananas grabbed a microphone and welcomed everyone to the game. The crowd roared in appreciation and listened as Archer explained the rules to everyone on hand before the game started. Stimpson and his family, settled in and that's when the fun began. "It was a very cool mo-ment," said Dustin, after-ward. "Then, people began yelling at us to go down to-wards the field. My son had the ball in his glove and followed an usher down the aisle. I saw someone pick my son up and pushed him through an opening in the netting and just like that, he was on the field."

Colin picks up the rest of the story. "One of the Savanna

Banana players tells me to follow him and we walk towards home plate. The game is going on but I'm just trying to keep up with this guy. We get to the first base side and I meet Andy."


"What is your name, he asked me? I told him, Colin. Where do you live? How old are you? 10 I said then he wanted to know where I lived and I said Buffalo."

## Knifing And Drug Bust On Humboldt Parkway





### Ask Rusty – We Want To Claim SS At 62. When Should We Apply?

Dear Rusty: My wife and I are going to be taking Social Security at 62. She will be 62 on April 15, 2025. I will be 62 August 7, 2025. When should we apply for Social Security?

Thank you in advance for your service as a Social Security Advisor. Signed: Ready to file

Dear Ready: Social Security recommends you apply for benefits about 2 – 3 months prior to when you want your benefits to start (to get them time to process your application). You will specify on your application when you wish your benefit to start, so applying early isn't a problem. Just a few things to keep in mind:

Your first month of eligibility will be the first month you are 62 for the entire month. In your wife's case, her first month of eligibility will be May 2025, and in your case your first month of eligibility will be September 2025. Your wife's benefits will be paid on the 3rd Wednesday of every month, and your benefits will be received on the 2nd Wednesday of every month (payment dates depend on when your birthday falls).

Social Security has an earnings test for those collecting early benefits (before your full retirement age). If you are working and exceed the earnings limit, SS will take away some of your benefits. The earning limit for 2024 is \$22,320 and, if that is exceeded, SS will take away \$1 in benefit for every \$2 you are over the limit (the limit changes annually, so the 2025 limit will be more). Thus, if you plan to work after collecting, you must stay aware of the earning test. If you earn substantially more than the earnings limit, you even may be temporarily ineligible to collect benefits (until you either earn less or reach your full retirement age (FRA) when the earning test no longer applies).

By claiming at 62, you will incur a cut in benefits of about 30% from the amount you would get by waiting until your FRA to claim. And, except for annual cost of living adjustments, that is a permanent reduction. FYI, your benefit will continue to grow if you wait longer to claim. Deciding when to

claim Social Security should take into account your financial

needs, your life expectancy, and your goals as a couple. Claiming at 62 is the right choice for many, but waiting lon-ger, if feasible, will result in a higher monthly amount, which could be beneficial if your life expectancy is long. Of course, we are here for you if you have any additional questions, so please don't hesitate to contact us again if needed.
