### A NEW DAY DAWNING!



The sun shines over Shoshone Park last Saturday morning and the new Mural that has been painted on the north side of the Thomas M. Smith Athletic Center opening this fall.

There's a new day dawning in Shoshone Park for 2026.

Next year, in early May, the Sun will rise over the top of the new Thomas M. Smith Athletic Center and boys and girls playing in the Hertel North Park Youth Baseball League will have another place to

go to play the game.

Ever since the end of the HNPYBL season in late July, Shoshone Park has still been the place to go in North Buffalo for Travel team tryouts for next year, tournaments, Fall Ball and Catholic School Junior Varsity games played now on the weekends. "Trying to find a diamond to play Monsignor Martin baseball in Shoshone Park has been crazy," said a Commissioner of the High School Catholic Leagues recently. "Games always take precedence over practices as far as I know, but Shoshone Park is

our first choice." September 27 was a great day for Shoshone Park. City officials, including Buffalo Mayor Christopher P. Scanlon were on hand to help unveil a new mural that was painted on the northside of the Athletic Center that faces the playing diamonds of the Park. The colorful display shows the happy faces of three children in various uniforms that might reflect the children of today while using the building. Also in attendance was University District Councilmember Řasheed N.C. Wyatt, Delaware District Councilmem-

ber Joel Feroleto and Father David Richards of St. Mark's Church who offered a religious blessing on the new structure.

It's hard to believe that just two years ago, then Buffalo Mayor Byron W. Brown presided under a huge tent erected over a pouring rain to help Jessica Smith and her two boys put a shovel in the ground and begin the building in honor of her husband's service to the City of Buffalo. Without the help of a mild winter in 2024 and a successful Summer last year in Shoshone Park, the Thomas Smith facility rose up from the ground one day at a time and now sits just off the parking lot of a Park that has become a jewel in North Buffalo.

Over 1,300 boys and girls played in the League this year, encompassing over 100 teams in house, travel and t-ball. With the seasons changing to the winter months, the board of directors is up for the challenge to keep making Shoshone Park even better for next

This year, with an improved Diamond #5, the Senior Boys Pirates defeated the Dodgers for the Championship while playing on a surface that was long overdue for change.

But Diamond 5 wasn't the only place where good Baseball and Softball was played. In Senior Girls, the Tigers defeated the Wolverines to win the Championship in July. Under first year coach Carlie Rickus, the Tigers were tremendously successful mixing the talented team with travel players and first year girls who played their hearts out. The team suffered just one loss all season, to the Bulls and defeated the Longhorns and Sooners in a five team division.

In Major Girls, the Huskies defeated the Bruins to win the Championship in some very fine play under the watchful eyes of coach Bob Schoos. As the number 1 cede in the Division, they awaited the winner of a Ducks/Griffs matchup and then won two of three games against the Bruins, 9-6. Other teams in the Division included the Buckeyes, Ducks, Griffs and Hokies. Bob and Janine Schoos have helped hundreds of girls become successful on the diamonds in many years at Shoshone.

After finishing the regular season undefeated with a 12-0 record, the Giants awaited the playoffs against seven other teams to put a final touch on the 2025 Summer. However, a very good Braves team was waiting for the challenge. After the Giants defeated the Reds and the Cardinals in the first two rounds the Braves defeated the Giants in two straight games, 5-4 and 6-5. Coach Noah Huard, a former player in the League himself growing up, has been a long-time coach in Hertel North Park for many years. They finished the season in second place with an 8-4 mark and won four more to win the Championship.

## **Defendant Pushes Victim Into A Recycling Bin**

#### **North Buffalo October 7, 2025**

Sanders Road - Defendant did go to his ex-girlfriend's house, where he was not supposed to be, and was confronted by the victim. The defendant did then go to his car and retrieve a metal rod and swung it at victim but did strike him.

#### October 6, 2025

Delaware Avenue - While at 2731 Delaware Avenue, victim did leave his wallet on top of the ATM. The store manager and the victim's daughter both did observe the defendant reach up on top of the ATM and grab the wallet and put it in their purse. Contained in the purse were victims license, credit card, bus pass, medical cards and a small amount of cash. This was witnessed by the store manager and the defendant did admit to detective on the phone that she took the wallet.

#### **October 3, 2025**

Delaware Ávenue - Defendant did select \$108.98 worth of merchandise from 2626 Delaware Avenue (Target) and did walk past all points of purchase without paying. Video available from detective.

#### October 1, 2025

Hertel Avenue - Defendant did pass all points of purchase without paying with \$147.22 worth of merchandise.

#### October 1, 2025

Hertel Avenue - Defendant did enter the apartment building at 438 Hertel Avenue. While inside the apartment building police arrived for a 911 call. The victim appeared at her apartment door to talk with police and explained why she called. The defendant barged into victim's apartment and began to tussle with the victim. Victim had a knife to defend herself. Officer deployed taser at victim causing minor injuries to victim. Victim sustained minor injuries from defendant and taser (bruising to right breast, soreness to left rib, knee, and soreness to left side of face). Officer did witness the incident.

**October 1, 2025** Hertel Avenue - Victim states suspect and victim got into an argument over turning the heat on and the suspect pushed them into a recycling bin. Minor injuries sustained.

# Should I Take Social Security Now, Or At Age 70? - Ask Rusty

Dear Rusty: I was born in April 1958, and my plan has been to take my Social Security at age 70. However, my sister-in-law says that it is smarter to take it now while I am still working. I will be 70 in 2.5 years. Her husband collects his SS and has kept working. She believes their strategy will net more money than mine due to the fact he has continued to pay into the system, and she believes it has super boosted his monthly benefit. What say you? BTW, Lord willing and the creek don't rise I plan on living at least till 87.

Signed: Questioning My Plan

**Dear Questioning:** You have already reached your SS full retirement age (FRA), so you can earn as much as

possible without your SS benefit being negatively affected by Social Security's Annual Earnings Test. In fact, if your current earnings are among the highest over your lifetime, your SS benefit amount will continue to increase because of your higher current earnings. You are now also earning Delayed Retirement Credits (DRCs), which will improve your monthly amount by .67% for each month (8% for each full year) you delay. That means that if you wait and claim at 70 you will get about 127% of what you would have gotten had you claimed at your FRA of 66 years and 8 months (plus you'll also get all COLA increases which occur between now and then). So your life expectancy is key.

It usually takes about 12

years to breakeven moneywise by claiming at age 70 vs. at FRA. In other words, if you claim at 70 instead of FRA, you'll have received the same amount of SS money after you are 82. Thus, if your life expectancy is greater than age 82, you'll get more in cumulative lifetime benefits by waiting until 70 to claim. Of course, no one really knows how long they will live, so it is a judgement you need to make. "Average" life expectancy for a man your current age is about age 84, but if you'd like to get a more personalized longevity estimate you can use this tool we use here at the AMAC Foundation: https:// socialsecurityreport.org/ tools/life-expectancy-calculator/

Another thing to keep in mind is whether your wife will get a widow's benefit if you die first. A widow will get the higher of either her own SS retirement benefit, or the husband's benefit amount when he died. So, if you claim at age 70, your surviving spouse will benefit (if her own SS is smaller) because you waited until 70 for your higher SS amount. Just something else to keep in mind.

Yet another is whether your wife will be entitled to a higher benefit as your spouse while you are both living. (FYI, a spouse will get a "spousal boost" if her own SS retirement benefit at

FRA is less than 50% of her spouse's FRA entitlement). If so, your wife cannot claim her spousal benefit until you take your own SS retirement benefit. If your wife will be entitled to more as your spouse while you are both

living, then delaying until age 70 means your wife cannot collect her higher spousal amount until you claim. Depending on your financial needs as a couple, that may affect your decision as well.
